Other Inspection Regulations:

1. The commodities in the list have carried out imported inspection since 12 Dec, 2016.
2. Inspection method:
 - (1) Heavy metal inspection method, Taiwan Herbal Pharmacopeia (announced on Jan, 2013).
 - (2) Heavy metal determination method (Cadmium ,lead, copper, Mercury and arsenic), Taiwan Herbal Pharmacopeia (announced on Jan, 2013).
 - (3) Pesticide residues determination method, Taiwan Herbal Pharmacopeia (announced on Jan, 2013).
 - (4) Aflatoxin determination method, Taiwan Herbal Pharmacopeia (announced on Jan, 2013).
 - (5) Sulfur Dioxide determination method, Taiwan Herbal Pharmacopeia (announced on Jan, 2013).
 - (6) Method of Test for Pesticide Residues in Foods-Multiresidue Analysis (5).
5. Inspection items and standards according to the Pharmaceutical Affairs Act concerning the regulatory limit of harmful substances in traditional Chinese medicine raw materials.
6. Any correction of C C C Code change will be effective only upon publication by the competent government office.
