MEMORANDUM ORDER

SUBJECT:

TEMPORARY BAN ON THE IMPORTATION OF DOMESTIC AND WILD BIRDS AND THEIR PRODUCTS INCLUDING POULTRY MEAT, DAY OLD CHICKS, EGGS AND

SEMEN ORIGINATING FROM Germany

WHEREAS, Section 1770 of Act No. 2711 (Revised Administrative Code of 1917) which was adopted by incorporation together with Sections 1761-1769, in Section 5 of Act 3639 (Charter of BAI) empowers the Department Head to issue a general order preventing the entry of animals, animal effects, parts or products from any country with dangerous communicable animal disease;

WHEREAS, based on the official reports submitted by Dr. Karin Schwabenbauer, Ministerial Dirigentin and Chief Veterinary Officer, Directorate of Animal Health, Animal Welfare, Bundesministerium für Ernährung und Landwirtschaft (BMEL), Bonn, Germany to the World Organisation for Animal Health (OIE) on November 11 and 14, 2016, that there were outbreaks of H5N8 Highly Pathogenic Avian Influenza (HPAI) virus in Mecklenburg-Vorpommern and Schleswig-Holstein, Germany affecting chicken, duck and turkey farms as confirmed by the Friedrich-Loeffler Institute (National laboratory);

WHEREAS, there is a need to prevent the entry of HPAI virus to protect the health of the public and the local poultry population;

NOW, THEREFORE, I, EMMANUEL F. PIÑOL, Secretary, Department of Agriculture, by the powers vested in me by law, do hereby institute the following emergency measures for the importation of domestic and wild birds and their products from Germany:

1. Banning the importation of domestic and wild birds and their products, including poultry meat, day old chicks, eggs, and semen;

2. Immediate suspension of the processing, evaluation of the application and issuance of Sanitary and Phytosanitary (SPS) import clearance to the above-stated commodities;

3. Stoppage and confiscation of all shipments of the above stated commodities (with the exception on heat treated products) into the country by all DA Veterinary Quarantine Officers/Inspectors at all major ports.

4. Frozen poultry meat with slaughter/process date of 21 days prior to the HPAI outbreaks are allowed to enter the country subject to veterinary quarantine rules and regulations.1

5. Importation of meat products of poultry is subject to the conditions provided in article 10.4.19, 10.4.20 and 10.4.26 of the OIE Terrestrial Animal Health Code, 2015.2

This ORDER shall take effect immediately.

² Heat treated products are acceptable following chapter 10.4 of the OIE Terrestrial Animal Health Code (2014) recommending, provided that in addition to the Veterinary Health Certificate, the Competent Authority will include in the certification the following:
