



Among the above-mentioned contracting authorities, based on the information available, the majority of contracts in excess of thresholds are those involving state bodies.

In 2016, public organisations concluded 15 contracts in excess of thresholds, the price whereof comprised AMD 24,536.8 million; 10 of which involve procurement of goods and 5 involve the services. The prices of contacts comprise AMD 6,611.0 million and AMD 17,925.8 million, respectively.
