Addendum

The following communication, received on 14 August 2017, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Quizalofop-ethyl

The proposed maximum residue limit (PMRL) document for quizalofop-ethyl notified in G/SPS/N/CAN/1113 (dated 16 May 2017) was adopted 9 August 2017. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.05 Saskatoon berries (juneberries)

ppm = parts per million
