Description of content:</b> This Order of the Minister of Agriculture, Food and Consumer Protection presents some protective measures against the outbreak of Avian Influenza (H5N1) disease in Germany, Bayern province, stopping the import and transit of live fowls (domestic and wild), fledglings (24 hour-old birds), decorative fowls (regardless of origin until a second order is issued), hatching eggs and eggs for human consumption, fowl semen, fowl meat, products originating from fowls destined for fowl feed and animal feed; for industrial and agricultural uses, and pathological material and biological products from Germany, Bayern province into the Albanian Territory.
