5. Title, language and number of pages of the notified document: Order of Minister of Agriculture, Food and Consumer Protection "On some protective measures against the Avian Influenza appeared in Czech Republic (Usti nad Orlici District of Tisova Region)" (available in Albanian, 2 pages)

Description of content: This Order of Minister of Agriculture, Food and Consumer Protection presents some protective measures against the avian influenza outbreak in the Czech Republic, stopping the import of all kind of live fowl (wild and domestic fowl), day-old poultry, decorative poultry regardless of origin unless in the second order of the Ministry, eggs for hatching and for human consumption, sperm of live fowl (wild and domestic fowl), meat of wild and domestic fowl and poultry products destined for poultry feed or for industrial and agricultural use. It stops the import of pathological materials and biological products of poultry that are not treated in thermal processes.
