6.	<b>Description of content:</b> This Order of Minister of Agriculture, Food and Consumer Protection presents some protective measures against the blue tongue disease outbreak in France, in regions of Ardenes, Bermeries, Solesmes, Regniowez, Flamengries, Montgon, Wallers, Coulommies-et-Marqueny, Doux, Etroeungt, Eparcy, Jenlain, Gognies, FrasnoyPont-sur-Sambre, Charnois, Gommegnies, Wargnies, LesDeux-Villes, stopping the import of all live animals of the ruminant family and any kind of herbivores susceptible to the blue tongue virus to the territory of Republic of Albania; semen of ruminants and any kind of herbivores; embryos/eggs of ruminants and any kind of herbivores; pathologic material and the biological products originating from ruminants and of any other kind of herbivores susceptible to the blue tongue virus.
