Description of content:</b> This Order of the Minister of Agriculture, Rural Development and Water Management provides some protective measures against the outbreak of Highly Pathogenic Avian Influenza H5N8 disease in the region indicated in point 4. A ban has been placed on the imports of all live poultry, semen, embryos, ova and by-products of poultry affected by Highly Pathogenic Avian Influenza H5N8, from the territory described in point 4, to the Albanian territory. In addition, the veterinary certificate should guarantee their origin. The measures also consist in stopping the import of unsterile biological materials originating from all live poultry, semen, embryos, ova and by-products of poultry affected by Highly Pathogenic Avian Influenza H5N8 in the territory described in point 4, to the Albanian territory.
