Description of content: This Order of the Minister of Agriculture, Food and Consumer Protection presents some protective measures against the outbreak of the blue tongue virus in Portugal, in the region of Volta dos Nogais-Barrancos, stopping the import of all kind of live animals of the ruminant family and any kind of herbivores susceptible to the blue tongue virus into the territory of Republic of Albania; stopping the import of semen of ruminants and any kind of herbivores, embryos/eggs of ruminants and any kind of herbivores, pathologic material and the biological products originating from ruminants and of any other kind of herbivores susceptible to the blue tongue virus.
