- **6. Description of content:** Automobile tyres and gas lighters must comply with the safety inspection of the Safety Inspection Agency and must be marked with its approval number before being sold or put into service for trade applications.

Lawn mowers do not carry out safety inspection but ensures the safety prescribed in safety inspection criteria and specific points must be described.

7. Objective and rationale, including the nature of urgent problems where applicable:

To ensure safety and protect consumers.

8. Relevant documents:

- Publication where notice appears, including date and reference number;
- proposal and basic documents (with specific reference number or other publication) to which proposal refers: automobile tyres and gas lighters are classified as pre-inspection of safety and must carry out safety inspection before being sold and lawn mowers are classified as post-inspection of safety.
- Publication in which proposal will appear when adopted: Applicable from 1 January 2000.
- Whenever practicable, give reference to relevant international standard:

- In the case of automobile tyres, EU, US, and Brazil are importing only safety-certified products and safety criteria varies from country to country.
- In the case of gas lighters, though safety criteria are different from country to country, the said product must carry out safety control by fixing safety devices.
- In the case of lawn-mowers, in the Republic of Korea, safety-related accidents occur frequently and the said product requires safety-related control.
