OVERVIEW OF SPS RELATED TECHNICAL ASSISTANCE ACTIVITIES

Communication from the European Union

The following communication, received on 16 March 2011, is being circulated at the request of the Delegation of the European Union.

- 1. In line with Article 9 of the SPS Agreement, the European Union would like to update on the European Commission's assistance activities in the recent years and those foreseen for 2011 and 2012 to support Developing Countries in complying with their rights and obligations under this Agreement.
- 2. The European Union provides approximately three billion euros a year for Aid for Trade (a line dedicated to multilateral initiatives). The European Union addresses compliance with SPS standards under its numerous trade-related assistance programmes. Furthermore, under the specific Aid for Trade budget line the European Commission has increased its contributions to the three Sisters for the period 2011-2013 in order to facilitate the participation of developing countries in their meetings, for the establishment of the IPPC helpdesk and to help Codex Alimentarius to perform a study on aflatoxins (for a total of 3.5 million euros). In addition, the contributions to the Standards and Trade Development Facility have also been secured.
- 3. Between 2007 and 2009, 99 projects touching upon SPS standards were funded: 19 in Asia, 29 in European candidate or potential candidate countries, 22 in ACP countries, 6 in European Neighbourhood Countries and 10 in Latin America. The remaining 13 actions were not allocated to a specific region (more details are reflected in Annex 1).
- 4. The bulk of EU assistance in the SPS area is implemented in the framework of multi-year country assistance programmes, which are aligned with national development plans and priorities. SPS support is usually embedded in a broader trade-related assistance programme (including areas such as SME development, export promotion, customs reform and improvement of the business enabling environment) or as part of a sector-specific support programme (e.g. targeted at specific agricultural value chains). In addition, the European Union also promotes increased regional cooperation in the area of SPS, aimed at (i) facilitating south-south trade through the harmonization of SPS measures within regional trade blocks, (ii) strengthening regional consumer protection e.g. through enhanced cross-border cooperation in the area of disease control and (iii) improving international market access by upgrading regional quality infrastructure and alignment with international standards.
- 5. In addition to country or regional programmes, the European Union also supports programmes at global, all ACP or continental Africa level, among which:

- "The Strengthening Fisheries Project" (SFP) ended in November 2010 but its activities and recommendations will be continued partly by the new EDES programme.
- "Strengthening Food Safety Systems" through SPS Measures or the "EDES project" has taken off in March 2010 and is coming up to cruising speed. The overall objective of this project is to alleviate poverty in beneficiary ACP countries through improving their food and feed trade. The project purpose is to develop in ACP countries risk-based food and feed safety systems for export products which are in line with regional, international and EU SPS standards. The project is very much demand-driven and the European Union invited the developing countries to spread this information widely within their countries. - As requested by the ACP Group and on the basis of the experience gained through previous programmes (PARC, PACE, SPINAP ...) an amount of 30M€is dedicated to minimizing the socio-economic impact of infectious diseases by strengthening the capacity of national and/or regional African institutions. This new programme is called "African Veterinary Governance Programme" and is implemented jointly by the OIE, the FAO and the AU-IBAR.
- The "PAN-SPSO programme" ended in December 2010 but because of its success the Aid for Trade budget now caters for an extension of the programme for another three years. Again, the continuation of this project will be implemented by the Nairobi based African Union Inter African Bureau for Animal Resources (AU-IBAR) and provides for the efficient participation of African countries in the three SPS standard setting organisations through technical support. The project includes a close collaboration with the STDF to implement some capacity building activities.
- 6. In addition to that, several specific SPS training initiatives are scheduled under the European Commission's "Better Training for Safer Food" initiative:
 - A total of five specific training programmes have been set up which cover the whole world and a vast number of subjects: the rapid alert system for food and feed (RASFF), TRACES an electronic certification system GMO analysis, the EU Food Standards and highly pathogenic and other animal diseases. Also, under the food testing programme two-week laboratory trainings are being provided to developing countries on mycotoxins, microbiology, residues of veterinary drugs and pesticides. An overview of the activities can be found in Annex 2.
 - The "Better Training for Safer Food Africa" project has been very successful. It partly consisted of SPS harmonisation activities at the African regional level as well as private sector support activities of Small and Medium Enterprises (SMEs). A pan-African reference document on food hygiene was drawn up, which is now being disseminated and implemented at regional levels. The OIE component of the programme continues until the end of 2011 and will be sustained under the "African Veterinary Governance Programme". Progress is being made to sustain the outcome of this programme.
 - Specifically tailored trainings on residue monitoring are also made possible. In 2010, such specific trainings were carried out for the following countries: Indonesia, Malaysia, Myanmar and India. In 2011, similar trainings (or follow-up trainings) are planned for the following countries: Ukraine, Georgia, Malaysia, Egypt and India.
- 7. The European Union actively supports efforts to increase donor coordination, including in the area of SPS. On a day-to day level, this process is carried out by the EU delegations which are front of house for the identification and formulation of most assistance programmes. At global level, the

European Union also contributes to the Standards and Trade Development Facility (STDF), which promotes coordination among donors in the provision of SPS-related assistance.

- 8. It goes without saying that individual EU member States also contribute substantially to development aid, be it bilaterally, regionally or at multilateral level (STDF and ISSB's).
- 9. Moreover, the European Union invites developing countries calling for SPS related Technical Assistance to approach either directly the EU Delegations based in their country or the Directorates of the European Commission involved in technical assistance located in Brussels

Overview of trainings for non-EU countries in 2010-2011

- Under the "EU Food Standards" contract: in 2010, 13 workshops were held on a large variety of subjects reaching almost a thousand participants across Peru, China, Ukraine, Malaysia, Brazil, Canada, Uruguay, Cyprus, Indonesia, Philippines and Thailand. In addition, ten rapid response missions were carried out to provide countries with urgent assistance. Under the BTSF Africa project five regional workshops were organised in Cameroon, Uganda, Morocco, Mali and Malawi and two intensive trainings for the Regional Economic Communities were provided.

- Under the "Highly Pathogenic Avian Influenza" contract: Four six-week training missions were carried out to Russia, Belarus, Moldova, Philippines ("http://www.aitraining.eu/index.php") including laboratory trainings in Denmark. Trainings in the Near East, China, Bhutan and Bangladesh are to follow in 2011.
- Under the "Food Testing" contract: Training was provided to analytical staff from developing countries in state-of-the-art laboratory techniques on mycotoxins, microbiology and residues of veterinary medicines and pesticides (http://www.trainsaferfood.eu/) (2010-2011)
- Under the "GMO Analysis" contract, three events were organized in Turkey, Singapore and South Africa. The programme will continue in 2011 in Mexico, European Neighborhood Countries, and Asia.
- Under the "RASFF/TRACES" contract: Fourteen workshops have been organised reaching 580 participants in Morocco, Argentina, Philippines, Thailand, Guatemala, Mauritania, Algeria, Madagascar, Jordan, Tunisia, Chile, Indonesia, and India. Others will follow in 2011 in Peru, Kenya and Thailand for RASFF and in Peru, Tanzania and South Africa for TRACES (http://www.foodinfo-europe.com/)
- 1. The invitations are directly submitted to the countries invited. Only applicants presented by the relevant authorities replying to the invitation will be taken into account. It is essential to contact the Executive Agency for Health and Consumers (http://www.btsf.eu) and no longer the European Commission.
