COMMUNICATION FROM CANADA

The following document, received on 23 March 2020, is being circulated at the request of the Delegation of Canada.

PROGRAMME

In the context of the Fifth Review of the Operation and Implementation of the Agreement on the Application of Sanitary and Phytosanitary Measures (SPS Agreement), Canada submitted a recommendation for the Committee on Sanitary and Phytosanitary Measures (SPS Committee) to consider holding a workshop on risk assessment, risk management, and risk communication in 2020.

The workshop will explore concepts within Article 5 of the Agreement and related issues concerning the implementation of the Agreement. The workshop will focus on risk assessment, risk management, and risk communication. This workshop builds on the following: the Thematic SPS Workshop on Risk Analysis, which was held on 13-14 October 2014; and the SPS Thematic Session on Risk Communication, which was held on 15 July 2015.

The workshop will be held in Geneva, Switzerland, on 22-23 June 2020, beginning at 10 am.
