

**TECHNICAL ASSISTANCE TO DEVELOPING  
COUNTRIES PROVIDED BY THE UNITED STATES**

Submission by the United States

Addendum

The following communication, dated 17 June 2004, is being circulated at the request of the Delegation of the United States.

1. In response to the Secretariat's request in G/SPS/W/101, the United States submits the following compilation of technical assistance provided to developing countries and newly independent states between July 2003 and June 2004 in accordance with Article 9 of the Agreement on the Application of Sanitary and Phytosanitary Measures. During this time, the United States sponsored 126 technical assistance projects in 81 developing countries and newly independent states in the field of food safety, animal health and plant health. The United States continues its efforts to tailor technical assistance in relation to the requests made by developing countries through the WTO SPS Committee questionnaire.

2. The United States also calls attention to G/SPS/GEN/181, Add.1, Add.2, and Add.3 papers of US government agencies involved in providing SPS-related technical assistance. Listed below are descriptions of several individual projects, followed by the table of the other technical assistance activities.

**I. UNITED STATES COMMITMENT TO SPS TECHNICAL ASSISTANCE.**

**Meat Safety and Regulatory Enforcement Training**

3. In 2004, technical assistance is being provided to Costa Rica, El Salvador, Guatemala, Honduras, Nicaragua and the Dominican Republic to help support implementation of Hazard Analysis Critical Control Point (HACCP) programs in meat and poultry slaughter and processing plants. The United States is providing meat and poultry safety training programs in response to trade capacity building needs identified in the negotiations of the free trade agreement between the United States and these countries.

**Global Cold Chain Development Assistance**

4. Since 1998, an estimated 3,000-4,000 food distribution representatives have attended training seminars through the Foreign Agriculture Services' (FAS) Cold Chain Improvement Initiative. This project is designed to assist developing countries adopt better practices and technologies to improve food safety and preserve high quality perishable food products. While consumption of high-valued, consumer-oriented foods has grown rapidly in recent years, the current state of refrigeration, humidity

control, handling, and storage (i.e., key links of the "cold chain") for both domestic and imported goods is often weak or non-existent. To address these weaknesses, FAS established cooperative efforts with over a dozen USDA Posts and provided technical assistance to more than twenty countries, including: Dominican Republic (February 2004, Phases II and III), Guatemala, El Salvador, Honduras, Mexico (September 2003, Phases II and III), Costa Rica, Nicaragua (June 2004, Phase III), and Panama.

## **II. UNITED STATES BIOTERRORISM OUTREACH: 2003/04**

5. The United States carried out extensive outreach in preparation for new rules on bioterrorism affecting imports of food into the United States.

6. On 29 January 2003, FDA held a public meeting (via satellite downlink) to discuss the registration and prior notice proposed regulations. Nearly 1,000 participants in the North and South America, and the Caribbean viewed the live broadcast. The meeting was later re-broadcast to Europe, Asia, Africa and the Pacific. Transcripts of the broadcast are available on FDA's website in English, French, and Spanish.

7. On 22 and 28 April, and on 8 May 2003, FDA conducted three demonstrations on the web-based food facility registration system for stakeholders in Washington, D.C. Representatives of foreign governments, domestic industry, and federal agencies attended.

8. On 28 October 2003, a public meeting was held to explain the rules through a satellite downlink. The meeting was later re-broadcast to Europe, Asia, Africa and the Pacific. Transcripts of the broadcast are available on FDA's website in English, French, and Spanish.

9. On 6-7 November 2003, a seminar was held in Washington, D.C. for foreign embassies, which included a full day of information and presentations on the new rules.

10. On 21, 23, 27 and 29 April 2004, FDA sponsored a series of half-day seminars in Beijing, China, Seoul, Korea, Tokyo, Japan, and Bangkok, Thailand entitled "Complying with the New U.S. Bioterrorism Regulations – What You Need to Know". The targeted audience included manufacturers, processors, packers, holders, transporters, foreign filers, brokers, exporters and importers of food to the United States. Participants had the opportunity to discuss the new regulations with key representatives from FDA and met with key industry representatives.
