Communication from the Republic of Korea

Addendum

The following communication, entitled "Notification of the Corresponding Harmonized System Headings of the Products, for which Shelf-Life Requirements Will Be Removed from the Korean Food Code on 1 July 1996", dated 1 July 1996, from the Permanent Mission of the Republic of Korea, is circulated at the request of that delegation.

In accordance with the agreement regarding the shelf-life issue between the Government of the Republic of Korea and the Government of the United States of America which was notified to the WTO Secretariat on 26 January 1996, the Government of the Republic of Korea hereby notifies the WTO Secretariat of the corresponding Harmonized System headings of the products for which shelf-life requirements will be removed from the Korean Food Code on 1 July 1996. The list of those products is attached hereto.
