## **II. ECONOMY, ECONOMIC POLICIES AND FOREIGN TRADE**

### **2. Economic Policies**

#### **(a) Main directions**

##### **Question 1**

**Macedonia is requested to accept the following commitment concerning the provision of future information on its privatization process:**

**The representative of Macedonia confirmed the readiness of Macedonia to ensure the transparency of its ongoing privatization program and to keep WTO Members informed of its progress in the reform of its transforming economic and trade regime. He stated that his Government would provide annual reports to WTO Members on developments in its program of privatization as long as the privatization programmed would be in existence along the lines of that provided to the Working Party. He also stated that his Government would provide annual reports on other issues related to its economic reforms as relevant to its obligations under the WTO.**

Answer:

Macedonia agrees to accept the above commitment.

##### **Question 2**

**Macedonia should prepare a table to be included in the factual summary that lists products and services subject to price control with their HS and services category numbers.**

Answer:

The requested table will be prepared and included in the Factual Summary.

##### **Question 3**

**Explain the relationship, if any, that may exist between price control measures and export licensing in relation to products listed in WT/ACC/807/21.**

Answer:

There is no relation between the price control measures and the export licensing. These are two separate measures.

##### **Question 4**

**May restrictions on exportation implemented by means of export licensing be used to achieve price control objectives? Are they used?**

Answer:

No. See the answer to Question 3 above.

**Question 5**

**How will Macedonia ensure compliance with the requirements of GATT Article III:9 after accession?**

Answer:

See the answer to Question 6 below.

**Question 6**

**Macedonia is requested to accept the following commitment concerning the application of its price controls after accession:**

**The representative of Macedonia stated that in the application of price controls now or in the future, Macedonia would apply such measures in a WTO consistent fashion, and take account of the interests of exporting WTO Members as provided for in Article III:9 of the GATT 1994. Macedonia would publish the list of goods and services subject to state controls and any that are introduced or re-introduced in the future in its Official Gazette. The Working Party took note of this commitment.**

Answer:

Macedonia agrees to accept the above commitment.

**(b) Monetary and fiscal policies**

**(iii) Sales Tax on Goods**

**Question 7**

**How does Macedonia intend to bring its excise taxation regime into line with WTO requirements, in particular with Article III of the GATT 1994?**

Answer:

The Ministry of Finance has prepared an action plan on the equalization of excise taxes for domestic and imported tobacco products. It encompasses equalization of excise taxes on tobacco products by 2005 and 2007.

The action plan is included as Attachment 1.

**Question 8**

**When will Macedonia equalize excise tax for imported and domestically produced tobacco products and thereby eliminate remaining inconsistencies in this area with the national treatment requirements of GATT Article III:2?**

Answer:

See the answer to Question 7 above.

### Question 9

**Will Macedonia submit an English translation of the Government decision for equalization of excise taxes on domestic and imported tobacco and tobacco products referred to in Question 6 of WT/ACC/807/18?**

Answer:

See the answer to question 7 above.

### Question 10

**Macedonia is requested to make a commitment that from the date of accession it will apply the value added tax in compliance with Article III of the GATT 1994, in a non-discriminatory manner to imports regardless of the country of origin and to domestically-produced goods.**

Answer:

Macedonia agrees to accept the above commitment.

### Question 11

**Do the exemptions from VAT listed in WT/ACC/807/18 also apply to all imported goods in the respective categories?**

Answer:

Yes, the exemptions from VAT apply to both domestic and imported products and services.

### Question 12

**Explain the meaning of the words "import taxes entitled to credit deduction" mentioned in paragraph 73 of the Factual Summary. Do the words "import taxes" mean VAT paid on the seller's purchases during the assessment period?**

Answer:

The reference in this question to "import taxes..." mentioned in paragraph 73 of the Factual Summary is the result of an error. Paragraph 73 only contains reference to "input taxes entitled to credit deduction".

Nevertheless, input taxes are amounts for which the outstanding VAT amount for the supply made in the assessment period are deducted.

Tax credit represents:

- VAT for supply provided to the taxpayer by other taxpayers;
- VAT for payments made in advance by the taxpayer for supply, when such payments are still outstanding; and
- VAT paid for imports.

The right to deduction may be exercised only if following conditions are met:

- When the taxpayer who, within the scope of his business activity uses supplied or imported goods or services for the purpose of his business activity; and
- On the basis of an invoice or customs declaration in which the tax is stated separately.

### Question 13

**Can Macedonia clarify whether VAT is imposed at the point of sale and collected by the sellers, where the sellers' VAT liability for the assessment period concerned is determined partly on the basis of total sales?**

Answer:

The VAT liability occurs at the moment of the supply of goods or at the moment of a complete delivery of the service.

When the payment is made prior to the supply of goods or the delivery of service, the VAT liability for the amount received takes place at the moment of the receipt of the payment.

With regard to imports, the VAT liability occurs simultaneously with the customs liability or, in the case of goods exempt from customs duty, at the moment of the entrance of goods into the country.

The VAT is calculated for a specific assessment period on the basis of the total turnover.

### Question 14

**Can Macedonia confirm that rates of excise and VAT imposed on goods originating from any country that is party to its preferential trade agreements are no lower than those imposed on the same goods originating from any other country and that, accordingly, the MFN treatment requirements of GATT Article I:1 are met?**

Answer:

Excise tax and VAT rates are identical for all imported goods regardless of the country of origin. The application of excise taxes and VAT in Macedonia is in full conformity with the MFN principle contained in Article I:1 of GATT 1994.

### Question 15

**We seek a commitment from Macedonia to equalize excise taxes on imported and domestic tobacco and tobacco products prior to the date of accession.**

Answer:

See the answer to Question 16 below.

### Question 16

**Macedonia is requested to make a standard commitment that from the date of accession, it will apply its domestic taxes, including those on products listed in the tables attached to its accession documents, in compliance with Article III of the GATT 1994, in a non-discriminatory manner to imports regardless of the country of origin and to domestically-produced goods.**



Answer:

Macedonia agrees to make the above commitment, with one exception. During the last Working Party meeting held on 7 December 2001, Macedonia requested a transition period for the equalization of excise taxes on tobacco products. This issue is still subject to negotiations.

See also the answer to Question 7 above.

**IV. POLICIES AFFECTING TRADE IN GOODS**

**1. Import Regulation**

**(a) Registration requirements for engaging in importing**

**Question 17**

**The penultimate paragraph on page 38 of WT/ACC/807/12 refers to Article 684 of the Macedonian Law on Trade Companies which states that: "In their operations on the territory of the Republic of Macedonia, foreign trade companies and foreign sole proprietors shall comply with the law and shall have a status equal with domestic persons and legal entities, unless otherwise determined by a government agreement or by law."**

**Will you explain the meaning of "government agreement"? Does this mean that the Government can, by its decision, diminish or increase the rights of foreign persons? If so, what are the cases in which such a possibility is envisaged? (This question also relates to the services regime.)**

Answer:

The reference is to an international agreement made by the Government (e.g., a treaty or another type of an international agreement).

**Question 18**

**Will Macedonia provide information about the other current laws referred to in Article 684 of the Law on Trade Companies? (This question also relates to the services regime.)**

Answer:

Article 684 of the Law on Trade Companies is a general provision which has the purpose of equating a foreign company registered in Macedonia to a domestic company. It also reiterates the usual general principle of a foreign company being required to comply with Macedonian law in the same manner as a domestic company.

**Question 19**

**Macedonia is requested to confirm in its accession documents that there is no state monopoly in foreign trade and that no restrictions exist on the rights of individuals and enterprises to import and export goods into Macedonia, except as provided in WTO Agreements, that individuals and firms can easily amend their registered scope of business to add the rights to import and export, that the criteria for registration are generally applicable and published in the Official Gazette, and that these requirements are not applied in a non-discriminatory manner towards imports.**

Answer:

Macedonia agrees to the inclusion of the above statement in its accession documents.

**Question 20**

**Macedonia is requested to make a commitment in its accession documents that from the date of accession it will ensure that its laws and regulations relating to the right to trade in goods and all fees, charges or taxes levied on such rights will fully conform with its WTO obligations, including Articles VIII:1(a), XI:1 and III:2 and 4 of the GATT 1994, and that it will implement such laws and regulations in full conformity with these obligations.**

Answer:

Macedonia agrees to accept the above commitment.

**(b) Characteristics of national tariff**

**Question 21**

**Will Macedonia submit an update on Article 24a of the Customs Law which provides for tariff quotas on "goods that are not produced in the Republic of Macedonia, or the production of which does not cover the needs [of Macedonia]"?**

**Has this provision been eliminated in current legislation?**

Answer:

Macedonia expects to repeal Article 24a of the Customs Law by June 2002. Amendments to the Customs Law will be submitted to the Working Party as soon as available.

**Question 22**

**Has the new Law on Customs Tariff been enacted and is it available for review?**

Answer:

Macedonia amended its Law on Customs Tariff twice during the last year. In both cases, changes were introduced in the customs nomenclature, as well as in the level of tariff rates.

An English translation of the Customs Tariff with the first set of changes (Official Gazette 15/01) was submitted to the WTO Secretariat and then distributed to the members as WT/ACC/807/16 on 12 March 2001. These changes were also reflected in the last revision of the goods offer distributed to the Working Party members as WT/ACC/SPEC/807/2/Rev.1.

The second set of changes was introduced in December 2001 (Official Gazette 104/02) and it represents a full harmonization on six-digit level with the World Customs Organization nomenclature. Those changes are incorporated in the latest revision of the goods offer.

(d) **Other duties and charges**

**Question 23**

**Can Macedonia confirm that its 1 per cent fee on imports for customs evidential services will be abolished at the end of 2001, as indicated in the response to Question 22 of WT/ACC/807/18?**

Answer:

The one per cent fee on imports for customs evidential services ceased to apply on 1 January 2002.

**Question 24**

**Have any fees for customs services been established to replace the one per cent fee?**

Answer:

According to the Regulation Governing the Amount of the Fee for Customs Services Rendered (Official Gazette 102/2001) the new fixed fee is EURO 19 for each ten-digit tariff entry on an import customs declaration. The fee is equivalent to the cost of the customs services rendered.

The regulation came into force on 1 January 2002. An English translation has been submitted to the WTO Secretariat.

**Question 25**

**Will Macedonia provide a status report on its plans for the 0.1 per cent export promotion fee applied to imports?**

Answer:

See the answer to question 27.

**Question 26**

**Macedonia is requested to make a commitment that from the date of accession it will impose fees and charges for services rendered related to importation or exportation only in conformity with Article VIII of GATT 1994.**

Answer:

See the answer to Question 27.

**Question 27**

**Macedonia is requested to make a statement that "other duties and charges" as provided for in Article II:1(b) of the GATT 1994 will be bound at zero in its Schedule of Commitments on Goods.**

Answer:

Macedonia states that "other duties and charges" will be bound at zero in its Schedule of Commitments in Goods with the exception of the 0.1 per cent charge for export promotion. At the

Working Party meeting on 7 December 2001 Macedonia requested a three year transition period from the date of accession for the elimination of this charge.

**(e) Quantitative import restrictions, including prohibitions, quotas and licensing systems**

**Question 28**

**What are Macedonia's plans for the elimination of licensing requirements currently imposed as "protection of domestic production" for products listed in Table 4(a) of the factual summary?**

Answer:

See the answer to Question 30 below.

**Question 29**

**Can Macedonia explain the security justification for the non-automatic licensing of precious metals and products of precious metals listed in Table 5 of the Factual Summary?**

Answer:

As indicated in paragraph 78 of the Factual Summary and Title (iii) of the Explanatory Note on Import Licensing appearing in the Annex to WT/ACC/807/18, non-automatic import licenses for precious metals and products of precious metals are administered in accordance with Article XX(c) of the GATT 1994. The security justification mentioned in Table 5 of the Factual Summary was an unintentional error. The requested corrections will be made in the appropriate places.

**(f) Import licensing procedures**

**Question 30**

**The last paragraph on page 67 of WT/ACC/807/18 states:**

**"Macedonia is seriously re-examining its import licensing regime in the light of all current and future international commitments. Pursuant to the obligations set out in the Stabilization and Association Agreement with the European Union, Macedonia has abolished all quantitative restrictions for imports from the European Union market as of 1 June 2001. The Government of Macedonia plans to extend the same treatment to all WTO Members on MFN basis prior to its accession to the WTO. "**

**Confirm that the "quantitative restrictions" referred to in this paragraph include the licensing regime operated under the Trade Law described in the attachments to WT/ACC/807/18.**

Answer:

The "quantitative restrictions" mentioned in the last paragraph on page 67 of WT/ACC/807/18 apply to products listed in Attachment 1 to the above document. Macedonia has already commenced to abolish such restrictions by a Government Decision issued on 18 December 2001. According to this Decision, licensing requirements were removed on 31 December 2001 for some of the products listed in Attachment 1 while for the remaining products they will be removed on 30 June 2002 and 31 December 2003 respectively.

An English translation of the Decision has been submitted to the WTO Secretariat. A detailed timetable for the abolition of licenses appears in Attachment 2.

**Question 31**

**Clarify Macedonia's intentions concerning all licensing requirements listed in the attachments to WT/ACC/807/18 in the context of the WTO accession requirements.**

Answer:

See the answer to Question 30 above.

**Question 32**

**Will Macedonia submit an update on the status of revising the current licensing system vis-à-vis imports from countries other than the European Union?**

Answer:

See the answer to Question 30 above.

**Question 33**

**Will Macedonia submit an English translation of the government decision on the abolition of the non-automatic licenses?**

Answer:

See the answer to Question 30 above.

**Question 34**

**What are the criteria applied by the Minister of Economy when issuing non-automatic licenses for oil derivatives? Are they published?**

Answer:

The licensing requirements, as well as the procedures for the administration of licenses for oil derivatives, are described in the Explanatory Note on Import Licensing on page 67 of WT/ACC/807/18.

There are no published criteria.

**Question 35**

**Will Macedonia submit a list of all non-automatic import licenses for products falling into Heading 27.10 of the Customs Tariff issued from January 1998 to date?**

Answer:

The specificity of the question, as well as the optional nature and extent of a possible answer, suggest that a more detailed elaboration of the question may be best achieved in bilateral discussions. Macedonia will welcome such discussions with interested members of the Working Party.

### **Question 36**

**On what basis does Macedonia justify the licence requirement for the import of products listed in Attachment 5 to WT/ACC/807/18?**

Answer:

As already described in the Explanatory Note on TBT in the Annex to WT/ACC/807/18, the basis for the licensing requirement relating to the products listed in Attachment 5 to WT/ACC/807/18 is consumer protection. The products in Attachment 5 are electrical appliances or machines. Consumers, when they acquire such products, should also be able to receive the necessary installation and user instructions, manufacturers guarantees, and repair information. Hence, in the strict sense of their content and character, the licenses are product licenses and not shipment importation licenses.

The licenses are issued for the respective models of the products to be placed on the market in Macedonia. Once issued, they are valid for an unlimited number of shipments of an unlimited quantity of the particular product for an unlimited period of time.

To obtain a licence it is necessary to submit to the Bureau for Standardization and Metrology samples of the manufacturer's certificate, guarantee, and instruction manual. The licence is issued immediately upon the receipt of such sample documents. Fees for the licenses are payable within a range of US\$50 – US\$195 depending on the complexity of the respective products and documents.

### **Question 37**

**Are the licenses for the importation of products listed in Attachment 5 to WT/ACC/807/18 automatic?**

Answer:

The licenses for the products listed in Attachment 5 to WT/ACC/809/18 are issued automatically upon the receipt of the respective documents. Nevertheless within the strict meaning of the definitions in the Agreement on Import Licensing Procedures they may be regarded as non-automatic.

Yet the licensing requirement is widely publicized. It is transparent and reasonable. The application procedures are simple. The procedures for the issue of the licenses are fair and equitable. The licenses are issued promptly.

Furthermore, it needs to be noted that these are product licenses and not shipment importation licenses. In other words they constitute a generic requirement concerning the products themselves and not their importation.

### **Question 38**

**Are the products listed in Attachment 5 to WT/ACC/807/18 subject to mandatory technical regulations?**

Answer:

Yes, as already stated in the Explanatory Note on TBT in the Annex to WT/CC/807/18, the licensing requirement for products listed in Attachment 5 to the above document is established by regulation.

**Question 39**

**Are import licenses for products listed in Attachment 5 to WT/ACC/807/18 issued on the basis of the manufacturers' certificates of conformity or are they subject to other certification and testing requirements?**

Answer:

As explained in the answer to Question 36 above, the licenses are issued on the basis of manufacturers' certificates and manuals. There are no other requirements.

**Question 40**

**On what basis does Macedonia justify the licensing requirement for the importation of products listed in Attachments 6, 8, 9, 10 and 11 to WT/ACC/807/18?**

Answer:

Macedonia offers the following justifications for the licensing requirements for products listed in Attachments 6, 8, 9, 10 and 11 to WT/ACC/807/18:

- Attachment 6 – The Administration on Plant Protection administers licenses for registration of new pesticides prior to their initial release on the Macedonian market. It also administers the renewal of such licenses.
- Attachment 8 – The Administration on Seeds and Seedling Materials administers licenses for:
  - Preservation of the quality of seeds, seedling materials and other reproduction materials of plant origin in conformity with the International Seeds Testing Association (ISTA).
  - Preservation of the identity of seeds, seedling materials and other reproduction materials of plant origin as prescribed by the International Organization on Post-Control Tests for the Examination of the Identity and the Purity of Varieties within the OECD.
  - Health of seeds, seedling materials and other reproduction materials of plant origin as prescribed by the International Plant Protection Convention (IPPC).
- Attachment 9 - The Forestry Department applies licensing requirements for the control of health safety of seeds and seedlings for forestry plants imported into Macedonia.
- Attachment 10 – The Veterinary Administration administers licenses to prevent importation of animals and products of animal origin containing contagious animal diseases.
- Attachment 11 – The Ministry of Environment applies licensing requirements for:
  - Halogen derivatives of carbon hydrate, as well as used refrigerators and freezers – reduction and elimination of substances that damage the ozone layer to comply with the international requirements of the Vienna Convention and the Montreal Protocol, as amended.

- Used and repaired tires, used wheels – prevention of pollution and other environmental hazards caused by old tires due to the absence of adequate recycling facilities and limited waste disposal capacities.
- Asbestos and products containing asbestos – reduction in the use of asbestos materials.

Used TV, radio and video sets, and monitors – prevention of unsafe and dangerous products from being used by the public, as well as reducing the risk of such products being abandoned in public places due to the lack of recycling and waste disposal capacities.

Products protected under the following international treaties:

- Convention on Biological Diversity (Rio)
- Convention on the Conservation of Migratory Species of Wild Animals (Bonn)
- Convention on the Conservation of the European Wildlife and Natural Habitats (Bern)
- Basel Convention on the Control of Cross Border Circulation of Hazard Waste and its Disposal
- 1998 Protocol for Persistent Organic Polluters

The information contained in Attachments 6, 8, 9, 10 and 11 to WT/ACC/807/18 has been revised. Updated information appears in Attachments 4, 5, 6, 7 and 9 to this document.

#### **Question 41**

**Are the licenses required for products listed in Attachments 6, 8, 9, 10 and 11 of WT/ACC/807/18 automatic?**

Answer:

The purpose of the procedures related to the products listed in Attachments 6, 8, 9 and 10 to WT/ACC/807/18 is the protection of human, animal and plant life and health. The requirements are based entirely on scientific principles, and they utilise international standards, guidelines and recommendations. The licenses represent a step in the control, inspection and approval procedures. They are issued forthwith upon the satisfactory completion of such procedures which are prompt and reasonable. In the strict sense of the term, as it is defined in the Agreement on Import Licensing Procedures, such procedures may be deemed non-automatic. But are they ever automatic?

Products listed in Attachment 11 to WT/ACC/807/18 require control, inspection and approval procedures for environmental protection reasons. Strictly speaking they fall within the TBT categories of conformity assessment requirements. Within the technical sense of the term they also may be deemed non-automatic.

#### **Question 42**

**Are the products listed in Attachments 6, 8, 9 10 and 11 to WT/ACC/807/18 subject to mandatory technical regulations?**

Answer:

Yes, the licensing requirements for products listed in Attachments 6, 8, 9, 10 and 11 to WT/ACC/807/18 are established by regulation.



English translations of the following relevant laws have been submitted to the Working Party:

- Law on Plant Protection (Official Gazette 25/98, 6/00);
- Law on Veterinary Health (Official Gazette 28/98);
- Law on Environment and Nature Protection and Promotion (Official Gazette 69/96, 13/99, 41/00, 51/00, 96/00);
- Law on Medicaments, Remedial Medicines and Medicine Devices (Official Gazette 21/98); and
- Law on Health Safety of Food Products and Articles for General Use (Official Gazette of SFRY 53/91).

#### **Question 43**

**Are import licenses for products listed in Attachments 6, 8, 9, 10 and 11 to WT/ACC/807/18 available on the basis of manufacturers' certificates of conformity or are they subject to other certification and testing requirements?**

Answer:

The controls applicable to the products listed in Attachments 6, 8, 9, 10 and 11 have as their purposes the protection of human, animal and plant life and health, or the protection of the environment. The documentary and other procedural requirements relating to such controls are determined by multilateral, regional and bilateral international agreements. It is these agreements that determine whether manufacturing certificates suffice for control, inspection and approval purposes. In this respect, Macedonia follows international standards, guidelines and recommendations. For full description of the licensing procedures, see the Explanatory Notes on SPS and TBT in the Annex to WT/ACC/807/18.

#### **Question 44**

**Will Macedonia explain the SPS justification for the import licenses for products listed in Attachment 11 to WT/ACC/807/18.**

Answer:

The reference to the SPS Agreement for products listed in Attachment 11 was made in error. The particular requirements refer to environmental protection and have a direct bearing on the safety of health and life, but it is true that they do not address issues arising from the entry, establishment or spread of pests, diseases, contaminants or toxins. In view of the above question, they are being reclassified as TBT requirements.

The changes are reflected in an amended table which is included as Attachment 9 herein.

#### **Question 45**

**What are the justifications for the import licensing requirements for pharmaceuticals listed in Attachment 12 of WT/ACC/807/18?**

Answer:

Medicaments, remedial medicines and medicine devices - To ensure that safe, harmless, effective and properly approved medicines are placed on the Macedonian market.

Narcotic substances and products thereof – To ensure control in the use of such products, and to maintain proper records of their use.

Poisons - To ensure that products of public hygiene containing poisonous substances do not constitute a danger to the public, and that they are properly described, labelled and classified.

#### **Question 46**

**How are the import licenses for pharmaceuticals listed in Attachment 12 of WT/ACC/807/18 administered?**

Answer:

Licence applications are filed prior to the importation, exportation and transit of pharmaceuticals. Application must be submitted in writing, in Macedonian language and Cyrillic letters on a special form that may be obtained at the Ministry of Health. It need not be notarized.

Each application must be accompanied by the following supporting documentation: evidence that the respective trader is authorized to trade with pharmaceuticals, copy of the invoice and evidence of the payment of the administrative fee. Administrative fee of 200 MDen is payable.

The decision is made by the Minister of Health within thirty days of the day of submission of the application. The applicant is informed about the decision in writing. Appeal may be filed with the Second Instance Committee in the Ministry of Health.

A licence is valid for a specific shipment only.

For further information, see the Explanatory Note on SPS in the Annex to WT/ACC/807/18.

#### **Question 47**

**Could Macedonia elaborate on the basis for issuing import licenses for products assessed as meeting Macedonia's technical regulations or standards, including its sanitary and phytosanitary requirements?**

Answer:

See the answers to Questions 36, 40, 44 and 45.

#### **Question 48**

**Macedonia is requested to make an assurance that there will be no import licence restrictions on goods which meet Macedonian technical regulations and/or standards, including SPS requirements.**

Answer:

Yes, Macedonia is willing to give such an assurance.

#### **Question 49**

**Do the new laws on SPS and TBT in preparation by Macedonia take full account of the requirements of the WTO agreements, with a view to the simplification and improvement of the current system in conformity with the WTO requirements?**

Answer:

The relevant draft laws have been submitted to the WTO Secretariat.

**Question 50**

**Are the import licence fees based on product unit prices (paragraph 80 of the factual summary) consistent with Article VIII of GATT 1994, which requires such charges to be related to the approximate cost of the services rendered and not to the value of goods?**

Answer:

The amount of a licence fee is based on the product price as the best and the most convenient measure of the complexity of document and product examination. The lowest fee is US\$50 and the highest is US\$195. The licence is issued for a particular product. It applies to all shipments of that product and is valid for an indefinite period of time. The fee is consistent with Article VIII of GATT 1994.

The scale of fees is published in the Official Gazette 38/90.

**Question 51**

**Will Macedonia provide an action plan with a detailed timetable indicating how and when it intends to remove its non-automatic licensing restrictions for imports, and submit it together with appropriate WTO justifications for any remaining requirements?**

Answer:

See the answer to Question 30.

**Question 52**

**Will Macedonia report on its plans for the elimination of import licenses or on bringing its import licensing system fully into line with the WTO requirements, and not use it as a means for the protection of industrial and agricultural enterprises in their progress towards market economy operations?**

Answer:

See the answer to Question 30.

**(h) Customs valuation**

**Question 53**

**Macedonia has already submitted a document (Attachment 3 to WT/ACC/807/18) which indicates the compliance of its legislation with the Customs Valuation Agreement. Will Macedonia rearrange this document in the numerical sequence of its own legislation to be shown in the first column and the relevant provisions of the Customs Valuation Agreement in the second column?**

Answer:

As indicated in WT/ACC/807/17/Rev.1, Macedonia is currently amending its Customs Law to put it in compliance with the Agreement on Implementation of Article VII of GATT 1994, including the Interpretative Notes. The process is expected to be completed by June 2002. For this reason, Macedonia requests that the preparation of the compliance table be postponed until that time.

**Question 54**

**Macedonia is requested to make a commitment that it will fully apply the WTO provisions concerning customs valuation from the date of accession without recourse to a transition period, including the Agreement on the Implementation of Article VII of the GATT 1994 and Annex I (Interpretative Note) as well as the provisions for the Valuation of Carrier Media Bearing Software for Data Processing Equipment (Decision 4.1).**

Answer:

Macedonia agrees to accept the above commitment.

**(l) Rules of origin**

**Question 55**

**Will Macedonia indicate when it will incorporate the provisions of Article 2(h) and Annex II, Paragraph 3(d) of the Agreement on Rules of Origin in its legislation?**

Answer:

As indicated in WT/ACC/807/17/Rev.1, Macedonia is currently amending its Customs Law to put it in compliance with the Agreement on Rules of Origin. The process is expected to complete by June 2002.

**Question 56**

**Will Macedonia submit the promised revised rules of origin which include the provisions of Article 2(h) and Annex II, Paragraph 3(d) of the Agreement on Rules of Origin both for preferential and non-preferential trade?**

Answer:

Legislation containing revised rules of origin will be submitted immediately upon enactment.

See the answer to Question 55 above.

**Question 57**

**Macedonia is requested to confirm the commitment made in the answer to Question 39 of WT/ACC/807/18 to incorporate the provisions of the Agreement on Rules of Origin in its legal regime, in particular the provisions of Article 2(h) and Annex II, Paragraph 3(d) in Macedonia's accession documents.**

Answer:

Macedonia confirms the above commitment.

(m) **Anti-dumping regime**

**Question 58**

**Inform the Working Party on the progress in preparing a new Law on Trade that will provide for WTO-consistent application of anti-dumping and countervailing duties and safeguards measures on imports, as indicated in WT/ACC/807/18.**

Answer:

New legislation is being drafted. Within a very near future, when the draft text is finalized, it will be submitted to the Working Party for comments.

The intention is to introduce in Macedonia legislation fully consistent with the Agreement on the Implementation of Article VI of GATT 1994, the Agreement on Safeguards and the Agreement on Subsidies and Countervailing Measures.

**Question 59**

**Macedonia is requested to make a commitment that it will not apply any anti-dumping, countervailing or safeguard measure to imports from WTO Members until it has implemented laws in conformity with the WTO Agreements on the Implementation of Article VI, on Subsidies and Countervailing Measures and on Safeguards and has notified these measures to the WTO.**

Answer:

Macedonia agrees to accept the above commitment.

**2. Export Regulation**

(d) **Export licensing procedures**

**Question 60**

**Will Macedonia provide a table listing, in one column, all of the products that are subject to export approval for strategic reasons and, in adjacent columns, details of: (1) the specific objective of export control in relation to the product concerned, (2) the WTO justification, and (3) references to the relevant legal instruments?**

Answer:

If by "strategic" the Working Party means security and defense, such table is included as Attachment 11.

(f) **Export financing, subsidy and promotion policies**

**Question 61**

**The Macedonian Law on Free Economic Zones includes a prohibited export subsidy (paragraph 125 of the Factual Summary). What action does Macedonia propose to take in order to bring the law in conformity with the WTO requirements?**

Answer:

At its session held on 23 January 2002, the Macedonian Parliament repealed paragraph 1 of Article 25 of the Law on Free Economic Zones which the Working Party members deemed to create a prohibited export subsidy. This repeal puts the free economic zones regime in compliance with the provisions of the Agreement on Subsidies and Countervailing Measures.

The amendments were published in Official Gazette 6/01. English translation was submitted to the WTO Secretariat.

**Question 62**

**Macedonia's response to Question 43 of WT/ACC/807/18 is inadequate. Articles 3, 15, 16, 25 and 26 of the Law on Free Economic Zones clearly link the right of establishment in the zone and access to the tax exemptions and incentives provided to exporting a minimum of 51 per cent of the value of the goods manufactured and the services provided in the free zone the first year, rising to 70 per cent by the third year and thereafter. Tax exemptions and incentives include exemption from tariffs and sales (VAT) taxes, from profit and property taxes for ten years, and from normal utility charges. Also Article 34 appears to state that normal standards and price controls administered in the rest of Macedonia do not apply to goods imported to or exported from the zones.**

**As these exemptions and incentives are conditioned on export performance, Macedonia's current free economic zone regime constitutes a prohibited subsidy within the terms of Article 3 of the WTO Agreement on Subsidies and Countervailing Measures.**

**Macedonia is requested to eliminate the subsidy element as soon as possible, and prior to its accession to the WTO.**

Answer:

See the answer to Question 55 above.

**Question 63**

**Macedonia is requested to confirm in its accession documents that from the date of accession it will not maintain subsidies, including export subsidies, which meet the definition of a prohibited subsidy within the meaning of Article 3 of the Agreement on Subsidies and Countervailing Measures and that it would not introduce such prohibited subsidies in the future.**

Answer:

Macedonia agrees to include the above statement in its accession documents.

**Question 64**

**Macedonia is requested to confirm in its accession documents that any subsidy program in existence in Macedonia after accession will be administered in accordance with the Agreement on Subsidies and Countervailing Measures and that all necessary information on programs to be notified, if such exist, would be provided to the Committee on Subsidies and Countervailing Measures in accordance with Article 25 of the Agreement upon the entry into force of Macedonia's Protocol of Accession.**

Answer:

Macedonia agrees to include the above statement in its accession documents.

**3. Internal policies affecting foreign trade in goods**Error! Bookmark not defined.

**(b) Technical regulations and standards**

**Question 65**

**Will Macedonia fully implement the WTO TBT Agreement from the date of accession, as indicated in the factual summary?**

Answer:

Yes.

**Question 66**

**Will Macedonia advise on its intentions to establish arrangements for the development and application of technical regulations and standards consistent with the relevant internationally agreed standards, and also its intention to establish arrangements for conformity assessments?**

Answer:

Yes, Macedonia intends to establish arrangements for the development and application of technical regulations and standards consistent with the relevant internationally agreed standards. It also intends to make all necessary arrangements for the appropriate conformity assessments. In fact, Macedonia already substantially complies with such requirements.

**Question 67**

**Will Macedonia explain the basis for the assessment of the present arrangements concerning electrical appliances (mentioned in paragraph 80 of the factual summary)?**

Answer:

See the answer to Question 36 above.

**Question 68**

**Does Macedonia accept foreign certification/conformity assessment documents for any of the technical regulations being applied to products listed in Attachment 5 to WT/ACC/807/18?**

Answer:

Yes. For details, see the answer to Question 36 above.

**Question 69**

**If Macedonia accepts foreign certification/conformity assessment documents for any of the technical regulations being applied to products listed in Attachment 5 to WT/ACC/807/18, are the licensing requirements still applicable for the acceptance of foreign certification/conformity assessment documents?**

Answer:

The licensing requirements are fully described in the answer to Question 36 above (and in Explanatory Note on TBT of the Annex to WT/ACC/807/18).

**Question 70**

**Are any of the licensing requirements applied to products listed in Attachment 5 to WT/ACC/807/18 to ensure that the products meet certain quality standards (other than health, safety, metrological or environmental reasons)?**

Answer:

See the answer to Question 36 above.

**Question 71**

**Macedonia is requested to confirm that the conformity assessment procedures will ensure the protection of legitimate commercial interests (in accordance with TBT Articles 5.2.3 and 5.2.4).**

Answer:

The current conformity assessment procedures in Macedonia are reasonable and limited in all respects (for an in-depth description of the procedures, see the Explanatory Note on TBT in the Annex to WT/ACC/807/18).

In particular, Macedonia confirms that its conformity assessment procedures comply with the requirements of Article 5.2.3 and 5.2.4 of the Agreement on Technical Barriers to Trade:

- The information requirements are limited to what is necessary to assess conformity and to determine fees; and
- The confidentiality of information is respected in the manner required in Article 5.2.4 of the above agreement.

**Question 72**

**Explain more clearly the comment in the last sentence of paragraph 108 of the factual summary regarding current testing procedures as objectives for the improvement of quality in domestic production.**

Answer:

There is no direct textual connection between "testing procedures" and the improvement of quality in domestic production in the last sentence of paragraph 108 of the Factual Summary.

The sentence is compound.

What was intended to be said is that testing procedures are virtually non-existent in Macedonia, and that their introduction is seriously hampered by the lack of resources and personnel due to the present economic conditions of the country. There is a serious concern that goods produced locally are qualitatively inadequate. Since there are no testing systems in place, the best that can be done is to convince the industry that it should introduce better or more reliable production methods.



There is some hope that such an inducement may come from potential foreign customers interested to import Macedonian goods into their countries. There is a great need for international help.

### Question 73

**Will Macedonia advise on the timing of the enactment of the proposed new legislation mentioned in paragraph 112 of the factual summary?**

Answer:

The drafts of the Law on Standardization, the Law on Metrology, the Law on Accreditation and the Law on Technical Requirements of Products and Conformity Assessment are intended to be enacted by April 2002.

### Question 74

**Macedonia is reminded that it is not sufficient to presume that standards/directives of other countries are based on international standards or are necessarily TBT consistent, and that all acceding countries must have a system in place (as required by the Agreement) that can respond to Members' concerns when Macedonia applies what some Members see as WTO inconsistent standards/technical regulations.**

**In this regard, what is Macedonia doing to ensure that it can notify when required to do so by the Agreement (i.e., when will an enquiry point be set up and how will it operate to ensure proper notification)?**

Answer:

Macedonia has established an enquiry point and has notified the WTO accordingly.

Notifications will be prepared and submitted in accordance with the procedures prescribed in the Agreement on Technical Barriers to Trade. The respective Macedonian officials are receiving continuing training by invitation in other countries.

### Question 75

**Is there a policy that provides further guidance on how Macedonia will respond to and take into account comments on draft regulations (as provided for in its Law on Standardization)?**

Answer:

In practice the Bureau for Standardization and Metrology consults the industry and business sectors on all proposals, drafts or projects concerning the development of either standards or technical regulations relating to goods. In view of the size of the country this is easily accomplished. The Bureau for Standardization and Metrology cooperates with the industry and business sectors on a regular basis. Of course, no draft regulations are in existence currently due to the economic conditions in the country.

**(c) Sanitary and phytosanitary measures**

**Question 76**

**Will Macedonia submit the additional SPS legislation it is developing to ensure that it meets WTO requirements?**

Answer:

Macedonia continues to develop new legislation that is WTO consistent. As drafts of the legislation become available, they will be submitted to the Working Party for review. To date, Macedonia has submitted for comments the draft Law on Food Safety (WT/ACC/807/20).

It is, however, relevant to point out that the existing Macedonian legislation follows international requirements and applies international standards. It is consistent with the SPS Agreement.

**Question 77**

**Provide a list of new SPS laws and regulations, detailing their content and providing the timing for their enactment. (We will not be able to finalize our comments until we have had the opportunity for this review.)**

Answer:

No new legislation has been drafted so far.

Attachment 10 contains a list of legislation on plant protection projected to be drafted at some time in the future.

An English translation of the draft Law on Food Safety has already been submitted to the Working Party.

**Question 78**

**Will Macedonia report on the work underway to establish a WTO consistent SPS regime?**

Answer:

See the answers to Questions 40, 41 and 76 (and the Explanatory Note on SPS in the Annex to WT/ACC/807/18).

**Question 79**

**Will Macedonia submit a detailed explanation of the role played by the Ministry of Environment in the administration of its SPS measures (paragraph 114 of the factual summary)? What SPS measures is the Ministry of Environment responsible for administering and what is the nature of its role?**

Answer:

See the answer to Question 44.

**Question 80**

**What is the WTO justification for the Ministry of Environment applying SPS measures and what is the justification for applying them to particular products?**

Answer:

See the answers to Questions 40 and 44 above.

**Question 81**

**When will an operational SPS enquiry point be established (paragraph 118 of the factual summary) and when will the information about the enquiry point be submitted?**

Answer:

As required by Article 7 and Annex B to the SPS Agreement, two operational SPS enquiry points have been established: one within the Ministry of Health responsible for providing information on food safety and another within the Ministry of Agriculture, Forestry and Water Economy responsible for providing information on issues relevant for the health and life of animals and plants. Information about these two bodies were submitted to the WTO Secretariat for circulation among members.

(e) **State-trading practices**

**Question 82**

**What is the relationship of Macedonia's stock reserves to the purchase of agricultural goods covered by protective prices?**

Answer:

The Directorate for Stock Reserves purchases surpluses of agricultural products at protective prices pursuant to the provisions of the Law on Stock Reserves.

The Directorate for Stock Reserves purchases agricultural products at protective prices only in cases when they have not been bought out by commercial entities and it threatens to cause serious disturbances on the market.

The buyout is regulated by a Government decision which determines the product, the protective price and the quantities.

**Question 83**

**Did the Directorate for Stock Reserves participate in the buyout of wheat and tobacco, noted in the response to Question 109 of WT/ACC/807/12?**

Answer:

No, the Directorate did not participate in the buyout.

**Question 84**

**In Annex 6 to the document WT/ACC/807/5/Add.1 it is stated that the only entity in Macedonia which is covered by the provisions of Article XVII of the GATT 1994 is the Directorate for Stock Reserves.**

**We would like to know if there are other companies in Macedonia with exclusive trading rights or monopolistic position in imports, particularly in the light of the information provided during the last Working Party meeting on the international agreement with a particular foreign oil-trading company?**

Answer:

The terms of the international agreement with a foreign oil-trading company do not contain any elements falling within Article XVII of GATT 1994.

**4. Policies affecting foreign trade in agricultural products**

**- Agricultural Production**

**Question 85**

**As Macedonia has stated that it has no export subsidies, it is requested to make a commitment that it will not establish any export subsidies upon its accession to the WTO.**

Answer:

The application of export subsidies in agriculture is subject to ongoing negotiations on support in agriculture. Macedonia expects this issue to be resolved on the next plurilateral meeting planned for May 2002.

**V. TRADE-RELATED INTELLECTUAL PROPERTY REGIME**

**1. General**

**Question 86**

**Will Macedonia report on the status of the legislation in both the industrial property and the copyrights areas, as mentioned in WT/ACC/807/17?**

Answer:

The new Law on Industrial Property has been submitted to the Parliament.

For the amendments to the Law on Copyright and Related Rights see the answer to Question 87 below.

**2. Substantive standards of protection**

**(a) Copyright and related rights**

**Question 87**

**Further to the replies to Questions 111, 113 and 117 of document WT/ACC/807/18 in relation to copyright protection, Macedonia is requested to submit all new amendments to the Law of Copyright and Related Rights and/or the pertinent new regulations (if any).**

Answer:

Amendments to the Law on Copyright and Related Rights are being drafted in full conformity with TRIPS. The draft is expected to be translated into English and submitted for international consideration in the very near future.

**(c) Geographical indications, including appellations of origin**

**Question 88**

**Please confirm whether in the draft Law on Industrial Property a protection of a geographical name (geographical indication or appellation of origin) is only available once registered in accordance with Article 219 of that draft, and whether such protection will lapse if registration is not renewed pursuant to Article 227 of the draft.**

Answer:

The registration of a geographical name is unlimited and is different from the registration of a right to use that geographical name.

The registration of the use of a geographical name takes place according to Article 219 of the draft Law on Industrial Property. According to Article 227 of the same draft, it is valid for five years when it can be renewed again. The number of renewals is unlimited.

**Question 89**

**Describe how additional protection is granted by legislation to wines and spirits including other types of products, if any, covered by this additional protection.**

Answer:

There is no additional protection.

**Question 90**

**Please provide examples, if any, of the use by courts of the exceptions in Article 24 TRIPS by courts or lists of names considered generic in your jurisdiction.**

Answer:

There is no such use of exceptions or lists of names considered as generic.

(e) **Patents**Error! Bookmark not defined.

### Question 91

**Please explain whether the exclusion of inventions from patentability based on ordre public or morality has been applied in practice and, if so, please provide details.**

Answer:

There are no such cases in practice so far.

### Question 92

**Please describe how micro-organisms, non-essentially biological processes, microbiological processes and plant varieties are protected in your legislation using the relevant sections of your legislation.**

Answer:

Microbiological processes and products as well as the inventions related to such products, in particular substances or compositions for use in surgical and diagnostic methods or methods for treatment of living human and animal bodies can be protected by patent.

Article 13 Paragraph 1 of the draft Law on Industrial Property states that a "Patent shall be granted for invention in all fields of technology which is new, involves inventive step, and is suitable for industrial application."

Exceptions to patentability are listed in paragraph 3 items 1 to 3 of Article 13:

"The following shall be excluded from protection by patent:

- inventions related to new animal species and plant varieties and essentially biological processes for production of animals or plants, except inventions relating to microbiological processes and products from such processes;
- inventions whose publishing or exploitation would be contrary to the public order or morality. Exploitation of invention shall not be deemed contrary to public order or morality only because it is prohibited by law or appropriate regulation;
- inventions for surgical and diagnostic methods or method for treatment of living human or animal body, except inventions relating to products, in particular substances or compositions for use in any of these methods".

### Question 93

**Please state if your legislation provides for patent product protection of pharmaceutical and agricultural chemical products and if so, indicate the legal reference.**

Answer:

Article 56 paragraph 2 of the draft Law on Industrial Property states: "The validity of a patent may be extended to more than 20 years if the subject matter of the patent is a medical product or a product for protection of plants or process for their production, which has to undergo an administrative procedure for authorization required by law before it can be put on the market, for the duration of such administrative procedure, but not more than five years."

#### **Question 94**

**Please explain how your legislation explicitly ensures that a proposed user has made efforts to obtain authorization from the right holder on reasonable commercial terms and conditions and that such efforts have not been successful within a reasonable period of time. In this context, how do you define "reasonable period of time"?**

Answer:

There are no such provisions in Macedonian legislation.

#### **Question 95**

**Please answer whether a compulsory licence is assignable or not.**

Answer:

Compulsory licence is non-assignable.

**(g) Layout designs of integrated circuits**

#### **Question 96**

**Please describe how your legislation protects topographies.**

Answer:

Article 7 of the Law on Protection of Topographies of Integrated Circuits (Official Gazette 5/98) establishes a register for topographies. Article 10 of this law states that upon registration a topography becomes protected. Article 12 of the same law provides that the procedure for registration begins with the filing of an application.

#### **Question 97**

**Please explain what protection your national legislation grants to right holders against the unlawful importation, sale or distribution for commercial purposes of topographies including integrated circuits or other articles in which a topography is incorporated in accordance with Article 36 of TRIPS.**

Answer:

According to Article 9 of the Law on Protection of Topographies of Integrated Circuits, the holder of a protected topography is granted an exclusive right of commercial exploitation, including the right to authorize or prohibit any of the following acts:

- reproduction of the topography by any means or in any form; and

- importation, sale or other form of distribution of the topography or integrated circuit incorporating the respective topography or products that include integrated circuit incorporating the respective topography.

#### **Question 98**

**Please explain how your legislation provides for the derogation from Article 36 as specified in Article 37 of TRIPS where a person has no knowledge or reasonable grounds to know when acquiring an integrated circuit or an article incorporating such an integrated circuit that it contains an unlawful topography.**

Answer:

Pursuant to Article 16 of the Law on Protection of Topographies of Integrated Circuits, a person who commercially exploits an integrated circuit incorporating the protected topography, and who has no knowledge, or has no reasonable grounds to know that the topography of the product is protected, is not prevented from commercially exploiting the integrated circuit. But compensation is payable, and its amount depends on the scope of commercial exploitation of the protected topography.

Paragraph 3 of the same Article states that the amount of such compensation can be agreed upon by the right holder of the protected topography and the person who commercially exploits an integrated circuit incorporating the protected topography, and who has no knowledge, or has no reasonable grounds to know that the topography of the product is protected. If no agreement is reached, the competent court establishes the amount of compensation.

#### **Question 99**

**Please state the term of protection granted by your legislation to topographies.**

Answer:

Pursuant to Article 10 of the Law on Protection of Topographies of Integrated Circuits, the exclusive right ends ten years after the earlier of the following events:

- the end of the calendar year in which the topography is first commercially exploited anywhere in the world; and
- the end of the calendar year in which the application has been filed in Macedonia in due form.

Paragraph 5 of the same Article states that if topography has not been commercially exploited, the exclusive rights expires after 15 years from the date of its fixation or encoding.

#### **(h) Requirements on undisclosed information, including trade secrets and test data**

#### **Question 100**

**Please explain whether or not your legislation grants a defined period of time for the protection of undisclosed information and if so, please give the time span.**

**Please explain how your legislation defines undisclosed information.**

**Please explain how your legislation defines data submitted to governments or governmental agencies.**



Answer:

Pursuant to Article 20 of the Law on Government Officials (Official Gazette 59/2000), a government official is required to keep secret all state and official information in a manner and under conditions determined by law and other regulations. The obligation to keep the information secret continues for three years after the termination of the official's service.

Pursuant to Article 150 of the Law on General Administrative Proceedings (Official Gazette 47/86), administrative hearings are public. The official in charge of the hearing may exclude the public during the whole or any part of a hearing on the grounds of moral or public safety, or where the hearing involving official, business, professional, scientific or artistic secrets. The official in charge must warn all persons that they are obliged to keep secret any information learned at the hearing and reminded about the consequences if they do not keep the secret.

Pursuant to Article 292 of the Law on Trial Proceedings (Official Gazette 33/98), the judge may exclude the public from the whole or any part of any hearing in the interests of keeping an official, business or personal secret, or maintenance of the public order and moral. The court must remind the persons present of obligations to keep the confidential information secret.

Pursuant to Article 280 of the Law on Criminal Proceedings (Official Gazette 15/97), the court may ex officio or upon request of the parties, exclude the public for any period of time from the hearing for the purpose of keeping information secret. The president of the court shall remind all the persons present on their obligations to keep the secret and warn that the act of not keeping a secret is a criminal act.

The Law on Misdemeanours (Official Gazette 15/97) contains similar provisions.

#### **4. Enforcement**

##### **Question 101**

**Please explain whether or not your legislation provides for a mechanism to appeal to judicial bodies of final administrative decisions in the areas covered by TRIPS.**

Answer:

According to Macedonian law all final administrative decisions may be submitted to the Supreme Court for review in a procedure known as "administrative dispute". The main two laws in this area are: the Law on General Administrative Proceedings (Official Gazette 47/86) and the Law on Administrative Dispute (Official Gazette 4/77).

##### **Question 102**

**Please describe how your legislation authorizes judges to order production of evidence by the opposing party.**

**Please give precise information on what measures are taken to ensure the protection of confidential information.**

Answer:

According to Article 7 of the Law on Trial Proceedings, the court is required to investigate fully and truly the challenged facts. The parties to the dispute are required to present all facts and

submit evidence in support of their claims. The court is also empowered to consider evidence not presented by the parties. According to Article 205, the court decides what evidence is to be presented.

The same requirements exist in criminal proceedings pursuant to Article 11 of the Law on Criminal Proceedings (Official Gazette 15/97).

The draft Law on Industrial Property provides that a person whose right is infringed may ask the court to order the person that infringes his right to desist from further infringement, to confiscate and destroy products produced or put on the market with the aim of infringement, to submit documents and data of the infringing party, and to order the publication of the court decision which establishes the infringement.

### **Question 103**

**Please quote provisions of your legislation that authorize judges to order a defendant to desist from an infringement.**

Answer:

Pursuant to Article 159, Paragraph 1 of the Law on Copyright and Related Rights, the right holder may request the infringer desist from any conduct causing the infringement or conducive thereto.

Also, pursuant to Article 162, Paragraph 1 of the Law on Copyright and Related Rights, the court may, at the request of the right holder, determine provisional measures to prohibit any conduct causing an infringement.

### **Question 104**

**Please quote what provisions of your legislation authorize judges to order the payment of the right holder's expenses by the infringer.**

Answer:

Pursuant to Article 143 of the Law on Trial Proceedings, the unsuccessful party is required to pay the expenses of the winning party and of other parties participating in the proceeding on behalf of the winning party. Upon partial success of the trial, the court may decide that expenses be paid proportionally by the parties to the dispute or that one party proportionally compensates the expenses of the other. According to Article 91 of the Law on Criminal Proceedings, if the accused is found guilty, he is required to pay all costs of the criminal proceedings.

### **Question 105**

**Please explain if and how judges have the authority to order that infringing goods be placed outside channels of commerce or destroyed.**

Answer:

Pursuant to Article 162, Paragraph 1 of the Law on Copyright and Related Rights, when the exclusive right has been infringed, the court may, at the request of the right holder, determine provisional measures to seize, remove from circulation and to store copies, devices, equipment and the documents relating thereto.

In criminal proceedings, pursuant to Article 157 of the Criminal Code (Official Gazette 37/96), the court is empowered to order seizure of the infringing goods.

Draft Law on Industrial Property, Article 249, provides that the person whose right is infringed may request the court to order confiscation of the infringing goods, as well as excluding such goods from commerce.

#### **Question 106**

**Please quote what provisions of your legislation authorize judges to indemnify a defendant in the event of abuse by the plaintiff.**

Answer:

Article 145 of the Law on Trial Proceedings, empowers a judge to award costs to a party who may have incurred them unreasonably.

#### **Question 107**

**Please indicate whether or not procedures are available to suspend the exporting of counterfeit goods.**

Answer:

Pursuant to Article 165 of the Law on Copyright and Related Rights: "If the right holder reports that his exclusive right according to this Law has been infringed by the importation of certain goods into the State, the customs authorities may, on his request, determine the following customs measures:

- the right holder or his agent to inspect the goods; and
- the goods to be seized, removed from circulation, or stored in a secure place."

Pursuant to Article 252 of the draft Law on Industrial Property, the customs authorities may determine the same measures.

#### **Question 108**

**Please indicate whether or not your legislation provides for a *de minimis* imports exception.**

Answer:

Pursuant to Article 181 of the Customs Law (Official Gazette 21/98), items intended for personal use are exempted from duties.

#### **Question 109**

**Please explain how your legislation implements Article 61 of TRIPS.**

Answer:

Article 157 of the Criminal Code provides that where an infringement of a copyright and related rights takes place, a fine or imprisonment of one year may be imposed on a person who without authorization discloses, presents, reproduces, distributes, performs, broadcasts or in any other way tries to obtain illegally someone else's copyright or related rights. The same article provides that

in such cases the copies of the copyright work, subjects of related rights and means for their reproduction shall be seized.

## **VI. TRADE-RELATED SERVICES REGIME**

### **1. General**

#### **Question 110**

**Explain whether the MFN exemptions on real estate and legal services are based on provisions of any national legislation.**

Answer:

Yes, these MFN exemptions are based on the provisions of the following laws:

- Law on Ownership and Real Rights (Official Gazette 18/01), Articles 243-247;
- Law on Building Land (Official Gazette 53/01), Articles 6 and 19; and
- Law on the Bar (Official Gazette 80/92), Article 11.

#### **i. Banking**

#### **Question 111**

**Provide more information about foreigners being permitted to provide services through branches and/or subsidiaries.**

Answer:

Foreigners may provide banking services in Macedonia by establishing a bank or a subsidiary of a bank.

The criteria for establishment of a bank or a subsidiary are identical for foreign and domestic natural and legal persons.

Pursuant to Article 6 of the Law on Banks (Official Gazette 63/2000), a foreign bank may provide banking services by establishing a subsidiary in the Republic of Macedonia. The subsidiary has a status of a legal entity, and for its establishment the same requirements apply as for the establishment of a bank.

Pursuant to Article 9 of the Law on Banks, an individual natural or legal person other than a bank may not hold more than one third of the stock with management rights in a bank established in Macedonia. This requirement is in force until 1 January 2003. From that date onward, there will be no limitations on the establishment of banks, i.e. domestic and foreign natural persons and legal entities will be able to own 100 per cent of the capital of a bank established in the Republic of Macedonia.

#### **Question 112**

**Provide more information on the regime for issuing and trading in travellers checks and credit/debit/charge cards.**

Answer:

The issuance of a check, as well as other related rules and issues, are regulated by the Law on Check (Official Gazette 3/02). The provisions of this law are general and apply to all types of checks, including travellers checks. There are no limitations on the issuance of a check, except that a check which is payable in Macedonia can be drawn on a bank.

There are no specific provisions in the Macedonian legislation on the regime for issuing and trading in credit/debit/charge cards. However, pursuant to Article 45 of the Law on Banks, issuing a credit/debit cards is listed as one of the activities that may be provided by a bank.

**Question 113**

**On the basis of what criteria does the Central Bank determine the capital share of a foreign bank?**

Answer:

There are no specific criteria.

**Question 114**

**What are the criteria of the approval used by the Commission of Securities?**

Answer:

According to Article 38 of the Law on Securities (Official Gazette 63/2000), an approval by the Commission of Securities is based on an application containing:

- basic information about the applicant and applicant's business and development strategy,
- information about the members of the applicant's management team, and
- information on the issue of securities.

Article 39 of the Law on Securities require the applicant to submit additional information and documentation, such as: an establishment act; report by a certified auditor for the last three years; balance sheet and profit and loss account for the last three years; any decision about the issue of securities; and other relevant documents that the Commission may require.

Article 41 of the Law on Securities, requires the Commission of Securities to decide the application within 30 days from the date of its submission. The decision is based on the information submitted.

**ii. Insurance**

**Question 115**

**What is the status of enactment of the new Law on Insurance?**

Answer:

The new Law on Insurance Supervision has been submitted to the Parliament for consideration. An English translation of the draft law has also been submitted to the Working Party for comment.

#### **Question 116**

**What is the procedure for gaining temporary entry work visas for professionals in the insurance industry?**

Answer:

There are no special provisions related to professionals in the insurance industry.

#### **Question 117**

**What are the minimum requirements for the establishment of an insurance company? What is meant by minimum requirements?**

Answer:

Pursuant to Article 12 of the Law on Insurance (Official Gazette 35/01), an insurance company is established upon the payment of the base capital. The base capital is paid in Denar counter value of:

- EURO 750,000 if the company is established for carrying out life or non-life insurance activities; and
- EURO 1,000,000 if the company is established for carrying out reinsurance activities.

#### **Question 118**

**Are the criteria for the establishment of an insurance company publicly available?**

Answer:

Yes, the criteria for the establishment of an insurance company are stated in the Law on Insurance.

#### **Question 119**

**Are the capitalization requirements for the establishment of an insurance company higher for foreign participants?**

Answer:

No. Pursuant to Article 12, Paragraph 5 of the Law on Insurance, the capital requirements are identical for both foreign and domestic natural and legal persons.

#### **Question 120**

**New applicants are required to supply information as set out in the Insurance Law to a Commission established by the Minister of Finance. Is this requirement documented and publicly available?**

Answer:

Yes, the authorization process is documented and publicly available. Pursuant to Article 17 Paragraph 5 of the Law on Insurance, the decision of the Minister of Finance to authorize the establishment of an insurance company is published in the media.

**Question 121**

**May the decision of the Commission concerning the establishment of an insurance company be appealed? To whom and on what basis?**

Answer:

Yes, there is an appeal process against a decision concerning the establishment of an insurance company. The appeal is submitted to a committee established by the government which is required to decide the matter within 8 days.

**Question 122**

**Does Macedonia anticipate lifting the limitation for foreign insurance companies to engage in reinsurance in the defense industry (except with the permission of the Ministry of Defense)?**

Answer:

Such limitation does not exist.

**Question 123**

**What other limitations apply to foreign companies under the current Law on Insurance in reinsurance activities?**

Answer:

There are no other limitations. In fact, the only reinsurance company that operates in Macedonia in this moment is a foreign company.

**Question 124**

**Current law requires the approval of the Minister of Finance for the establishment and operation of an insurance company. Are the criteria publicly available? Are the criteria different for foreign and domestic companies?**

Answer:

Yes, all criteria appear in the Law on Insurance (Articles 13-19), and they are identical for domestic and foreign companies.

**Question 125**

**Is the legislative process with regard to laws on insurance transparent? Does it enable the industry to have an adequate notice and time to submit comments?**

Answer:

Yes. The drafts of the laws are always submitted to the industry for comments. Many of these comments were used in the drafting of the new Law on Insurance Supervision.

**Question 126**

**Do you anticipate the elimination/phasing-out of the compulsory reinsurance cessions?**

Answer:

This limitation does not exist any more.

## **2. Policies affecting Trade in Services**

### **Question 127**

**Why is a foreign auditing company permitted to establish only one auditing company in Macedonia?**

Answer:

Pursuant to Article 4 of the Law on Audit (Official Gazette 65/97, 27/2000, 31/01), an auditing company registered to provide auditing services in Macedonia can be established only by an authorized auditor. However, non-audit company may acquire and hold up to 25 per cent of stock in a new established auditing company in the Republic of Macedonia.

### **Question 128**

**Why is a foreign company not registered to provide auditing services in its own country prohibited to participate as a capital investor in a newly established auditing company in Macedonia?**

Answer:

If a foreign company is not registered in its own country for providing auditing services, its participation in the total capital of a new established auditing company in the Republic of Macedonia cannot exceed 25 per cent. In fact, the same requirement also applies to domestic companies that are not registered for providing auditing services.

The purpose of this requirement is to ensure that an auditing company is at least 75 per cent owned by an authorized auditor and/or auditing company. It is expected that such company will provide higher quality of services.

## **VII. INSTITUTIONAL BASE FOR TRADE AND ECONOMIC RELATIONS WITH THIRD COUNTRIES**

### **2. Economic integration, customs unions and free-trade area agreements**

#### **Question 129**

**Will Macedonia submit details of proposals for bringing the arrangements under preferential trade agreements into line with Article XXIV of GATT 1994 (paragraph 79 of the factual summary is outdated and the arrangements may have changed)?**

Answer:

In addition to the agreements described in the answers to Questions 151-158 of WT/ACC/807/18, Macedonia submits the following information about agreements recently made with the EFTA member countries (Switzerland, Norway, Liechtenstein and Iceland) and with Ukraine.



(a) Free Trade Agreement with the EFTA Countries

General

Signed in Zurich on 19 June 2000. The Agreement will enter into force on 1 May 2002.

Free trade agreement, establishes a free trade area within a period of ten years

Scope

Agricultural and fish products from Chapters 1 to 24 of the HS.

Industrial products from Chapters 25 to 97 of the HS.

Trade provisions

- Import Customs Duties

Macedonia shall abolish all customs duties on imports originating in the EFTA countries, including the specific customs duties (Article 4, paragraph 2), except those referred to in List A and List B of Annex III, for which the customs duties will be abolished gradually over a period of six and nine years, respectively.

EFTA countries shall abolish all customs duties on imports of goods originating in Macedonia, including specific customs duties (Article 4, paragraph 2) with the exception of Switzerland and Liechtenstein for products listed in Annex II, Table 4.

The Contracting Parties shall abolish all customs duties of fiscal nature (Article 6).

- Export Customs Duties

The Contracting Parties shall abolish all customs duties on exports (Article 7).

- Quantitative Restrictions

Quantitative restrictions on exports and imports between the Contracting Parties shall be abolished, except for products listed in Annex IV, as regards imports to and exports from Macedonia which may be maintained for a period of four years from the date of entry into force of the Agreement.

- Rules of Origin

Protocol B of the Agreement defines the rules of origin and methods of administrative cooperation related to them.

Standards

- Sanitary and Phytosanitary Measures

Article 12 stipulates non-discriminatory application of national regulations regarding sanitary and phytosanitary measures.

- Safeguards - General Protective Measures

In cases where a particular product is imported in large quantities, the Contracting Parties may introduce adequate measures in accordance with the Agreement and the WTO rules (Article 20).

When either of the Contracting Parties has serious balance-of-payments difficulties, it is allowed to take restrictive measures, including import-related measures in accordance with the GATT 1994 (Article 23).

Exceptions

- General Exceptions

The Agreement does not exclude bans or restrictions of import, export or transit of goods, established for the protection of: public moral, public order, public security, protection of national treasures, historical and archeological values etc., on the conditions that these measures are connected with the restrictions in domestic production or consumption and are in accordance with the international agreements (Article 9).

- Security Exceptions

Exceptions due to security reasons (Article 25).

The full text of the Agreement has been submitted to the WTO Secretariat.

(b) Free Trade Agreement with Ukraine

- General

Signed in Skopje on 18 January 2001. Entered into force on 10 September 2001

Free trade agreement, establishes free trade area within a period of ten years

- Scope

Agricultural and food products from Chapters 1 to 24 of the HS

Industrial products from Chapters 25 to 97 of the HS

Trade provisions

- Import Customs Duties

Macedonia shall abolish all customs duties on imports of goods originating in Ukraine, except for products listed in Protocol A and the customs evidence fee (Article 4, paragraph 2).

Ukraine shall abolish all customs duties on imports of goods originating in Macedonia, except for products listed in Protocol A and the customs evidence fee (Article 4, paragraph 2).

The Contracting Parties shall abolish all customs duties of fiscal nature (Article 6).

- Export Customs Duties

The Contracting Parties shall abolish all customs duties on exports (Article 7).

- Concessions in Agriculture

Tariff quotas on imports of agricultural products from Macedonia to Ukraine and vice versa, will be granted under the concessions given in Protocol B (Annexes I and II, respectively).

- Quantitative Restrictions

All quantitative restrictions between the Contracting Parties shall be abolished, both on exports and imports (Article 8, paragraph 2) except those referred to in Article 4 of Protocol A, as regards imports to and exports from Macedonia and Ukraine for a period of up to four years.

- Rules of Origin

Protocol C of the Agreement defines the rules of origin and methods of administrative cooperation related to them.

Standards

- Sanitary and Phytosanitary Measures

Article 14 stipulates non-discriminatory application of national regulations regarding veterinary, sanitary and phytosanitary measures in compliance with international conventions.

- Safeguards - General Protective Measures

In cases where a particular product is imported in increased quantities, the Contracting Parties may introduce appropriate measures. (Article 19).

When either of the Contracting Parties has serious balance-of-payments difficulties, it is allowed to take restrictive measures, including import-related measures in accordance with GATT 1994 (Article 27).

Exceptions

- General Exceptions

The Agreement does not prohibit bans or restrictions on import, export or transit of goods, established for the protection of: public moral, public order, public security, protection of national treasures, historical and archeological values etc., if these measures are connected with the restrictions in domestic production or consumption and are in accordance with the international agreements (Article 23).

- Security Exceptions

Exceptions due to security reasons (Article 32).

The full text of the Agreement has been submitted to the WTO Secretariat.

(c) Status of Negotiations with Other Countries in the Region

Albania – The Agreement was signed on 29 March 2002.

Bosnia and Herzegovina – The second round of negotiations took place on 3-5 April 2002.

Romania and Hungary – Consultative meetings were held with both countries in 2000. No further developments to date.

The information in the answers to Questions 151-158 of WT/ACC/807/18 and herein is current. It is believed to be in line with Article XXIV of GATT 1994.

## ATTACHMENT 10

### **List of Future Legislation Projected to be Drafted by the Administration for Plant Protection, Ministry of Agriculture**

- New law on mineral and organic fertilizers, including appropriate regulations, to harmonize with EU directives.
- New law on plant protection for harmonization with the regulations and standards of the EU and to comply with WTO requirements.
- Regulation on the manner and time of carrying out obligatory health check ups and measures for determining the health conditions of agricultural crops for production of seeds and facilities for production of planting materials for perennial agricultural plants during the vegetation period, the list and the allowed percentage of economically harmful plant pests and the form and contents of the certificate on the health condition of crops and facilities.
- Regulation on the requirements which are to be fulfilled by legal entities regarding the equipment and facilities for carrying out obligatory health check ups in the production of seeds and planting materials during the vegetation and before releasing for sale the seeds and planting materials.
- Listing the types of seeds which, before their release for sale or before their use for own production, need to be disinfected, i.e. disinfested.
- Regulation on the manner of destruction of plant protection products that are not safe for use, and used plant protection products packing material.
- Regulation on the requirements which are to be fulfilled by legal entities regarding the equipment, devices and premises for carrying out disinfections and disinfestations of plants and deratizations in the premises for storing, processing and keeping plants and in the means of transport for these plants.
- Regulation on the manner and quantity for taking samples from seeds and planting materials, plants, plant products and plant protection products.
- Order for the areas contaminated by quarantine plant pests.
- Regulation on the manner of carrying out obligatory health check ups of plants and plant products in the areas contaminated by quarantine plant pests to areas which are not contaminated, as well as the contents and shape of the certificate relating to the health condition of plants in the internal turnover.
- Regulation on the manner of carrying out obligatory health check ups of plants and plant products in their circulation across the state border, and the necessary conditions for carrying out the health check ups.
- Regulation on the manner of issuance, the shape and contents of the prescription of plant protection products that are released for retail sale.
- Regulation on the amount, manner and time limits for payment of costs for the procedure for issuance of licenses for releasing plant protection products in the circulation.

- Regulation on the amount of compensation for completing the obligatory health check ups of plants, seeds and planting materials before releasing them for the internal circulation from contaminated into non-contaminated areas and for maintaining the health conditions of plants in quarantine facilities and plants under quarantine surveillance.
