Analytic Note Listing Moldovan Legislation, Decrees, Decisions and Regulations  
Relevant to the WTO Legal Texts: Status of Draft Legislation and Draft Amendments

The Ministry of the Economy of the Republic of Moldova has submitted the following Analytic Note listing Moldovan legislation, decrees, decisions and regulations relevant to the WTO legal texts, with the request that it be circulated to Working Party members.

Analytic Note listing Moldovan Legislation, Decrees, Decisions and  
Regulations Relevant to the WTO Legal Texts: Status of Draft Legislation and Draft Amendments

The Government of Moldova is pleased to submit to the WTO a list of current laws, decrees and decisions pertaining to its Foreign Trade Regime. The list also identifies draft laws, draft amendments to laws, and draft decisions currently in the process of being approved by the Government and/or enacted by Parliament. If the law, decree or decision has been translated into English, the English text is attached to this Note, even when, as in many cases, the text has previously been submitted to WTO. If there is currently no English version, this is indicated in the column "Notes" by the annotation "being translated". It is anticipated that the translation of the bulk of these texts will be completed by the time of the next Working Party meeting on 19 July 1999: all texts will be available in English by 1 August 1999.

The Government of Moldova is aware that some Members have expressed an interest in having an electronic version of all texts, including those previously provided to the WTO Secretariat in hard copy only. The Government will be pleased to make available all texts referred to in this Note in electronic form in the near future. Those texts previously submitted to WTO in hard copy only, but which will be provided on disc in the near future, are marked (\*).

In considering the time likely to be required to enact draft legislation, the following disciplines imposed by the Government should be borne in mind. After a draft law is prepared by the Ministry primarily concerned, two weeks are allowed for comments by other relevant ministries, two weeks for consideration by the Ministry of Justice, and three weeks for consideration by the Government. Parliament normally enacts legislation within seven weeks of submission to it of a draft text.
