#### **INTRODUCTION**

During 2000, a total of 398 technical assistance activities were organized, involving most Divisions in the WTO. This compares with 382 activities in 1999, representing an increase of 4.2 per cent. These activities were held in 121 countries, of which 99 were WTO Members, 16 were in the process of accession, and 6 countries had expressed interest in joining the WTO. Out of the 99 Members where technical assistance activities were held, the large majority 81 were developing countries and 18 were least-developed<sup>2</sup> (LDCs). Another 9 LDCs not Members of the WTO were also beneficiaries.

With regard to funding, these activities have again largely been made possible through extrabudgetary contributions. In addition to funds provided by the more regular donors, new contributions were received in 2000.

It should be noted that as from 1 July 2000, technical assistance activities carried out on behalf of the least-developed countries were coordinated separately by the WTO Secretariat Working Group on Least-Developed Countries/IF (SWG), while those activities on behalf of other developing countries and transition economies remained under the jurisdiction of the Technical Cooperation Division. For this reason, reporting on the two groups of activities is carried in two separate sections in the present document.

Regarding the evaluation of WTO technical assistance, since the summer of 1999 the Secretariat has been systematically circulating questionnaires to participants in technical assistance activities. Participants' responses to these questionnaires will be an important element in the Secretariat's ongoing evaluation analysis efforts.

The present report contains a factual description and limited assessment of WTO's technical assistance activities undertaken during 2000. In general, it can be said that while respecting the demand-driven approach, a geographical balance was maintained in the delivery of technical assistance, and priority given to least-developed countries. WTO's technical assistance covered a very broad and diverse range of countries, including Members and non-Members, and a very broad range of trade-related topics, which were addressed in a general and/or specific way, depending on the requirements of the beneficiary countries.

Relative share of activities undertaken by WTO and other organizations

Given the WTO's Secretariat relatively small size it cannot take charge of all the technical assistance activities it undertakes. Thus, as illustrated in Table I, 132 activities were organized solely by the WTO, representing a share of 33.2 per cent of all activities reported. 125 activities were organized and held jointly with other institutions, representing a share of 31.4 per cent of all activities. And the WTO participated, on invitation, in 141 activities organized by other institutions, representing 35.4 per cent of all activities.

The WTO continues to develop and strengthen links with regional and other institutions, bodies and organizations to cooperate in the organisation of technical assistance activities. In addition, it is increasingly outsourcing activities when and where feasible, so as to reduce the burden on the Secretariat's human resources. In this regard, the WTO Secretariat signed a number of Memoranda of Understanding with the Secretariats of other bodies (e.g. the Inter-American Development Bank, the Caribbean Community, the Central African Economic and Monetary Community, the Economic and Social Commission for Asia and the Pacific, the Economic and Social Commission for Western Asia, the Islamic Development Bank, the Economic Commission for Africa, the Joint Vienna Institute and the Common Market for Eastern and Southern Africa, among others) to formalize such ties.

At the request of the Committee on Trade and Development, the Secretariat prepared a paper entitled "A Strategy for Technical Assistance in WTO", which consolidates many of the elements of technical assistance published over the past five years in different documents prepared for the Committee on Trade and Development, incorporates the issues raised in the two days of reflection on technical assistance held on 18 and 19 July 2000, and the points mentioned in two recent internal Task Forces on Technical Cooperation.

In the area of evaluation, the guidelines and modalities for implementing WTO technical assistance envisage that monitoring and evaluation will be carried out by the Committee on Trade and Development on the basis of an annual evaluation of the results of technical assistance activities with a view to ensuring optimum use of resources in line with appropriate evaluation criteria. In March 1999 the Secretariat prepared a note setting out the activities it had undertaken in the first phase of the monitoring and evaluation process mandated by the CTD (WT/COMTD/W/58/Rev.1). In furtherance of this exercise, the Secretariat outlined in June 2000 a proposal that could become the "framework and guidelines" for monitoring and evaluating WTO technical assistance (WT/COMTD/W/73) and issued a manual for WTO's Secretariat staff dealing with monitoring and evaluation (WT/COMTD/W/74).

As part of its response to the increasing need for, and requirements of, trade-related capacity-building, the Secretariat produced in 2000 a Guide to Sources of Trade-related Technical Assistance. The Guide is intended to provide a single reference source for potential beneficiaries of trade-related technical assistance, and may also be helpful in ensuring adequate coordination and cooperation among the various providers of such assistance.

During the course of 2000, WTO technical assistance made further progress in achieving its objectives as follows: (i) to contribute to the fuller participation of beneficiary countries in the multilateral trading system through human resource development, institutional capacity-building, and increased public awareness of the multilateral trading system; (ii) to deliver technical assistance through activities including training, advisory missions, seminars and workshops on a national or regional basis, and technical notes on issues of interest to beneficiary countries; (iii) to provide legal advice under Article 27.2 of the Dispute Settlement Understanding; and (iv) to coordinate activities with other international organizations, principally UNCTAD and ITC, but also with IADB, World Bank, IMF and others in the context of the Integrated Framework for Trade-related Technical Assistance for LDCs, with a view to achieving a significant, durable impact and obtaining synergies through the most efficient use of resources.

The report which follows is divided into three main sections, the first dealing with an overview of technical assistance by subjects covered and selected modes of delivery, the second covering developing countries (other than the least-developed) and transition economies, and the third covering the least-developed countries.

#### **SECTION ONE**

# OVERVIEW OF TECHNICAL ASSISTANCE BY SUBJECTS COVERED AND SELECTED MODES OF DELIVERY

#### I. TECHNICAL ASSISTANCE: SUBJECTS COVERED

#### A. ACCESSION

During 2000, due to an unusually extensive programme of accessions meetings in Geneva, Accessions Division was constrained to place priority on assistance to acceding governments during their visits to the WTO rather than missions to capitals. The conclusion of several accessions by mid-2000 (Jordan, Georgia, Albania, Croatia and Oman) allowed the Division to step up its technical and advisory technical assistance activities in the second half of the year. The Secretariat also continued to assist governments, at different stages of accession, to ensure that the flow of information between them and WTO Member governments remain pertinent and timely.

Countries visited in 2000 included Bhutan, Sudan, Yemen, China, Russian Federation, Vietnam, Lithuania and Oman. Requests for, and consequently the number of, technical assistance missions are on a rising trend as an increasing share of countries in the process of accession are least developed economies or small governments with limited resources and knowledge of WTO matters.

#### B. AGRICULTURE

The Agriculture and Commodities Division was extensively involved in technical assistance activities in 2000. The Division was frequently contacted by Geneva-based delegations or from capitals for assistance in the preparation of notifications and with regard to responses to specific implementation questions. Also in Geneva the Division participated in the trade policy courses organized by the Technical Cooperation Division and the Secretariat Working Group on LDCs/IF, and by video link, in courses run abroad. In addition assistance was provided through meetings in Geneva arranged with representatives of developing countries, such as South Africa on sugar and Barbados on safeguards. In addition, a number of meetings were held with representatives of private sector companies, such as South African sugar and the Chinese State Tobacco Monopoly and non-governmental organizations, such as the International Policy Council and Christian Aid. In Geneva, a number of acceding countries sought assistance with the accession process, including China, Chinese Taipei, Lithuania and Vietnam, some of whom also asked for assistance in their capitals, such as China and Chinese Taipei.

A wide variety of seminars, workshops and symposia took place in 2000 ranging from one day seminars in Europe to week long workshops in Africa, Asia and Latin America. These included workshops organised by FAO which were held in Nepal for South Asia, in Bolivia for Latin America, in Cameroon for West Africa and in Jamaica for the Caribbean, and with the Islamic Development Bank in Qatar and in Burkina Faso. The Division also participated in a number of national seminars such as in Barbados, Turkey, India and Chinese Taipei.

The type of assistance provided depended very much on the requirements of the particular mission. As the agriculture negotiations started in 2000 it was necessary to devote much of the presentations to cover them. However, in many cases specific issues were addressed in detail. The understanding of the Agreement varies considerably from one country to the next and from one group within a country to another, and it is necessary to tailor the presentations to suit the audience. In general, the presentations could be said to have fallen into four general categories. The first for people who already have some knowledge of the Agreement and the related issues which concentrated on the negotiations and on specific issues of concern; the second provided a general overview of the Agreement on Agriculture; the third dealt with certain provisions within the Agreement covering a single generic issue such as market access; and the fourth covered the whole agreement and how it affects a particular product or product group such as sugar or beef.

It is clear that there is still a great deal to be done in many countries about the details and the implications of the Agreement on Agriculture and the negotiations on continuing reform. At the same time rising trade volumes and improved trade opportunities are increasing the importance of the

Agreement. There is some evidence that the work of the WTO and other international organisations such as the FAO, ITC and the World Bank is beginning to have some impact especially in the number of proposals and the participation of developing countries in the agriculture negotiations. However, it is also clear that trade policy is one of many factors that must be addressed by some of the poorer countries before they can take advantage of the opportunities created by the WTO Agreements. Improving infrastructure, recovering from natural and man-made disasters and finding the most appropriate macro-economic policies are also very important. As trade becomes more important these physical constraints, as well as difficulties sometimes encountered when dealing with cumbersome systems of customs administration are being commented on by more participants in more meetings.

The main difficulties facing the agriculture technical assistance activities include the following:

- The need to retain flexibility in planning activities. The Division does not have the resources to organise seminars or workshops but needs to be able to respond to requests from countries and from other organisations. This requires flexibility in planning activities and for individuals in making their presentations.
- Internal co-ordination within countries requesting technical assistance is difficult to achieve as different ministries deal with agriculture, trade and foreign affairs. (Indeed, countries at all stages of development have difficulties co-ordinating their various ministries.).
- Many national constraints need to be overcome before trade opportunities can be fully exploited. These constraints vary from legal and social stability to poor physical infrastructure. While the importance of trade to development is acknowledged, governments sometimes focussed on the more obvious constraints.

The wealth of developed countries along with the Generalised System of Preferences and agreements like the Cotonou Agreement, have given developing countries preferential access to richer markets and have resulted in a concentration on the North American and European markets. However, high technical and safety standards, established brands and saturated markets make future potential expansion difficult. A re-focus, to concentrate on the potential growth markets closer to home, may offer scope for increasing trade and improving development.

#### C. BALANCE-OF-PAYMENTS

In November 2000, the Secretariat visited Dhaka to provide technical assistance to the Government of Bangladesh in connection with the Committee on Balance-of-Payments Restrictions request to Bangladesh to prepare a phase-out plan for the restrictions which it maintains for balance-of-payments purpose.

#### D. COMPETITION POLICY

Paragraph 22 of the Singapore Ministerial Declaration provides that the technical assistance programme of the Secretariat shall be made available to developing and, in particular, least-developed country Members to facilitate their participation in the work of the WTO Working Group on the Interaction between Trade and Competition Policy (WGTCP) which is established by Paragraph 20 of the Declaration. More specifically, the purpose of the Organization's technical assistance programme in this area has been to facilitate developing and other countries' participation in the WTO's work on trade and competition policy by: (i) disseminating information on technical and policy developments relating to trade and competition policy, both among Geneva-based delegates and in the various regions of the developing world; and (ii) exposing delegates directly to, and enabling them to enter into a two-way dialogue with, knowledgeable academics and experts from the private sector and civil society as well as senior capital-based competition policy officials from developed and developing

countries on the questions before the WTO in this area. During the past year, the Secretariat has also sought to respond to a demand articulated by developing countries during the preparatory process for the Seattle Ministerial Conference for additional and more intensive assistance in the area of trade and competition policy, particularly through regional workshops and similar activities. A number of activities were undertaken in support of these objectives. In several cases, these activities were organized by the WTO with participation from staff of other intergovernmental organizations or involved staff of the WTO Secretariat participating in activities organized by other intergovernmental organizations such as UNCTAD and APEC.

In July 2000, a WTO Regional Workshop on the subject of Competition Policy, Economic Development and the Multilateral Trading System: Overview of the Issues and Options for the Future was held in Phuket, Thailand, for the benefit of Asian WTO Members and observers. The Workshop was organized by the WTO Secretariat in assistance with the Government of Thailand and with financial support from the Government of Japan. It was attended by representatives of 22 WTO Member and observer countries from South, Southeast and East Asia, from both trade ministries and competition offices. It examined a range of questions relating to the role of competition policy in developing economies, the needs of such countries with respect to technical assistance and other forms of assistance, and the role that the multilateral trading system might play in supporting the implementation of effective national competition policies by developing country Members. Subsequently, a detailed report on the Workshop was made available to delegations in a meeting of the WTO Working Group on the Interaction between Trade and Competition Policy, in October 2000. During the year, preparations also commenced for a similar Workshop to be held in Cape Town, South Africa, for the benefit of African WTO Members and observers, in February 2001.

During the year, a representative of the Secretariat participated in a series of regional meetings organized by UNCTAD in preparation for the Fourth Review Conference on the United Nations Set of Multilaterally Agreed Equitable Principles and Rules for the Control of Restrictive Business Practices which was held in Geneva on 25-29 September 2000. In particular, the Secretariat participated in regional meetings held in Jaipur, India; Kiev, Ukraine; Casablanca, Morocco; and San Jose, Costa Rica, where updates were provided to delegates on the ongoing exploratory work and state of play on competition policy in the WTO.

In May 2000, a representative of the Secretariat participated as an instructor in an intensive week-long course on competition policy organized by the World Bank in assistance with the Government of Singapore. The course was attended by staff of competition agencies, representatives of non-governmental organizations and other interested persons from throughout East and Southeast Asia.

In July 2000, a representative of the Secretariat participated as a speaker in a Roundtable meeting on Competition Policy and Pro-Poor Development which was organized by the Department for International Development of the Government of the United Kingdom, in London. The Workshop, which was attended by senior representatives of competition agencies and other relevant government departments from throughout the developing world, examined the links between competition policy and pro-poor development and the ways in which developing countries might be helped to implement effective national policies in this area.

In November 2000, a representative of the Secretariat participated as a speaker and commentator in an APEC Regional Seminar on WTO Issues: Investment and Competition Policies, in Manila. The Seminar, which explored the inter-relationships between competition policy, transnational investment and trade liberalization, was organized by the Government of Japan and the Japanese External Trade Organization (JETRO) in assistance with the Government of the Philippines and was attended by representatives of a large number of countries from throughout East and Southeast Asia.

In December 2000, a representative of the Secretariat participated as an expert advisor in the launch meeting of a project organized by the Consumer Unity and Trust Society, a non-governmental organization based in India and Zambia, to review the implementation of competition policy in a number of countries in Asia and southern Africa. The project (known as the "7-Up Project") involves a comparative study of the implementation of competition policy in India, Pakistan, Sri Lanka, Tanzania, Zambia, Kenya and South Africa with some contributions from Zimbabwe. It is intended to provide insights that will be fed into ongoing deliberations on the formulation and implementation of competition policy at the national, regional and other levels. A Secretariat representative is participating as a member of the project advisory board, on an ongoing basis.

During the year, work also continued on the preparation of a volume of policy analysis based on four Symposia on issues concerning competition policy, development and the multilateral trading system that were held in Geneva and were organized by the WTO Secretariat with financial assistance from and participation by staff of UNCTAD and the World Bank, in 1997-1999. The volume is expected to be available in the fall of 2001.

As a further element of the WTO Secretariat's technical assistance activities relating to the interaction between trade and competition policy, lectures were presented as part of several sessions of the Organization's Trade Policy Course and Short Trade Policy Course that were offered during the year. Special lectures and presentations were also given for various organizations that visited the WTO during the year. A representative of the Secretariat also participated as an instructor in a University of Geneva Summer Course on issues relating to competition policy and the multilateral trading system, which was attended by a number of delegates from developing countries. Finally, it is worth noting that an important activity of WTO staff members in this area throughout the year was the provision of information and advice, on an ongoing and informal basis, to delegations to facilitate their participation in the work of the WGTCP.

#### E. DISPUTE SETTLEMENT

In accordance with Article 27.3 of the Understanding on Rules and Procedures Governing the Settlement of Disputes (DSU), the Technical Assistance Division, jointly with the Legal Affairs Division, organized the Sixteenth, Seventeenth and Eighteenth Special Training Courses on Dispute Settlement Procedures and Practices. These courses were held on 21-24 March 2000, 4-7 July 2000 and 21-24 November 2000, respectively. The objective of these courses was to enhance the understanding of officials, from developed and developing country Members as well as acceding countries, of the WTO Dispute Settlement Understanding so as to enable them to advise their governments effectively on all matters relating to the implementation and application of the WTO Agreement. The programme included a general presentation on the GATT/WTO system, followed by detailed presentations on the dispute settlement procedures and practices. The courses also contained an important practical component requiring active involvement and interaction from the participants, through case studies and simulated panel exercises. A total of 120 participants took part in these courses.

With the financial assistance of donor governments, the Secretariat held a number of national and regional workshops on dispute settlement procedures and practices for government officials from developing countries. National seminars or workshops were held last year in China, Chinese Taipei, Ghana, Kenya, Malaysia, Saudi Arabia (2), Slovak Republic, Sweden and Thailand. Regional workshops or seminars were held for countries from several regions in the United States (June 2000), for the Asian region in Japan (July 2000), for Eastern European transition economies in Brussels (October 2000), and for Arab countries in Egypt (October 2000). It is intended to hold similar courses over the next two years in all regions, should funding be available under the regular budget of the WTO or from donors.

During the year 2000, developing countries were actively involved in the dispute settlement process, both as complainants and as respondents. Pursuant to the provisions of Article 27.2 of the DSU, a number of developing countries sought the assistance from the Technical Cooperation Division in a variety of legal matters and situations. Assistance which was provided included advising countries on their legal rights and obligations under the WTO Agreement; commenting on a Member's submission to initiate or defend an action under a covered agreement, and undertaking legal research and providing legal opinions.

#### F. GOVERNMENT PROCUREMENT

Paragraph 22 of the Singapore Ministerial Declaration states that the technical assistance programme of the Secretariat will be available to developing and in particular least-developed country members to facilitate their participation in the work of the Working Group on Transparency in Government Procurement (WGTGP) which is established by Paragraph 21 of the Declaration.

More specific technical assistance activities undertaken during the past year included the Secretariat's participation in a regional conference organized by the ADB/OECD and a workshop organized by the Commonwealth Secretariat. In addition, briefing sessions were organized with the purpose of informing Geneva-based delegations and officials from capitals of least-developed countries, developing countries, economies in transition and countries in the process of accession on the status of the work of the Working Group.

In the context of the plurilateral Agreement on Government Procurement, the Secretariat provided bilateral technical assistance to Members and acceding countries requesting information and guidance on that Agreement. A major component of this type of assistance involved briefings of the officials from countries in the process of acceding to the GPA. In addition, the Secretariat contributed to the workshops organized respectively by Jordan on its accession to the Agreement and by the Commission of the European Commission for Turkish officials.

#### G. INTELLECTUAL PROPERTY

The Secretariat has provided assistance specifically in relation to the TRIPS Agreement. Much of this has been provided through international, regional and national seminars devoted in whole or in large part to the TRIPS Agreement or to a specific aspect of the Agreement.

Assistance with WIPO has been a key feature in this area. This has been based on the Cooperation Agreement between the two Organizations, Article 4 of which deals with legal-technical assistance. For example, the WTO Secretariat provided speakers for six regional or international events organized by WIPO, and the International Bureau of WIPO provided speakers for two regional workshops organized under the Joint Integrated Technical Assistance Programme to Selected Least-Developed and Other African Countries (JITAP). In addition, the two Secretariats have contributed to each other's training activities in Geneva, including the WIPO Worldwide Academy and the WTO trade policy courses.

The WTO Secretariat has cooperated in the provision of technical assistance in the area of TRIPS also with a number of other intergovernmental organizations and non-governmental organizations.

In addition, it should be recalled that a large part of the work of Secretariat officials dealing with intellectual property matters has been the provision of information in response to questions put to them by representatives of Member governments in Geneva and by capitals. Such advice and information has also been given to officials from acceding countries and representatives of the private sector.<sup>3</sup>

#### H. MARKET ACCESS

In 2000 the Market Access Division, in conjunction with the Technical Cooperation Division, the Secretariat Working Group on LDCs/IFand external consultants, provided technical assistance on the following issues under its administration: tariff issues and non-tariff barriers, as well as assistance for the implementation of the Agreements on Customs Valuation, Preshipment Inspection, Import Licensing Procedures, and Rules of Origin. Assistance was further provided by the Market Access Division on the Information Technology Agreement (ITA), and the WTO work programme on trade facilitation.

Assistance on market access issues was furnished in the context of market access seminars and workshops. One technical mission was conducted to help a developing country with the preparation and transposition of its tariff schedule. Given the growth of technical assistance in the area of the market access programme on customs valuation, it was decided that such assistance would be administered by the Technical Cooperation Division in cooperation with the Market Access Division. A number of missions were carried out under this new arrangement in 2000. In addition, a particular assistance programme was devised in cooperation with the Statistics Division for the submission of data to the Integrated Data Base.

#### **Customs Valuation**

The Technical Assistance Programme on Customs Valuation launched by the Committee on Customs Valuation in 1998 continued during the year 2000. As a number of countries were preparing a request for extension of the 5-year transition period allowed by Article 20.1 of the Agreement, there were fewer technical assistance missions than in previous years. A total of eight missions were carried out (in Africa, the Middle East, the Caribbean and Central America). In addition, the Secretariat participated in regional seminars and international meetings to assess different aspects of the Agreement. For the national missions, the customs valuation experts worked with the implementation teams, covering a number of issues including collaboration on the drafting of legislation, rules and procedures, and giving courses and seminars for government officers that deal with customs valuation (mainly customs officers, but also staff required to make the post-entry verification, computer analysts dealing with databases and systems for customs automation, etc.). Conferences were organized for the private sector to make clear the rights and obligations of importers and of the customs administration.

#### Integrated Data Base (IDB)

In the General Council decision of 16 July 1997, the Secretariat has been mandated to provide, upon request, "technical assistance to Members in relation to the submission of the data required for the Integrated Data Base for Personal Computers." Technical assistance for the IDB has taken different modes of delivery. In the year 2000, the Statistics Division conducted one national mission and participated in one WTO regional seminar to provide IDB training. In addition, a number of Geneva-based workshops and seminars were organized with delegations, which sometimes also included national experts. As concerns the SIECA data entry software, the Secretariat had contacts with the IADB and SIECA to discuss progress in the revision of the software and is currently awaiting to receive the revised version of the software and the accompanying training manual.

National Missions and Regional Seminars

In the year 2000, Statistics Division staff took part in a three week Short Trade Policy Course organized by the Islamic Development Bank in Burkina Faso, from 14 February to 3 March 2000. Officials from French speaking African countries attended the course. One half day was attributed to the IDB presentation. In addition, a three-day technical assistance mission to Barbados was organized. During this mission, various departments in charge of the preparation of IDB data were visited. Technical expertise and guidance were provided to officers in charge of preparing the import statistics and the tariff data.

#### Geneva-based activities

In addition to the WTO Trade Policy Courses for developing countries, which take place three times a year in Geneva, Statistics Division staff was also involved in other occasional WTO Short Trade Policy Courses and in the Geneva Week for non-resident delegations. Upon request of the Committee on Market Access, the Statistics Division organized ten workshops and hands-on training sessions during the summer of 2000.

#### Consolidated Tariff Schedules

Work is still in progress in the Secretariat and amongst Members to bring together all Members' tariff concessions and agricultural commitments into a standardized database format. Once completed, training in the use of the Consolidated Tariff Schedules database will be included in the Secretariat technical assistance activities.

#### I. NOTIFICATIONS

Several Members, in particular least-developed and developing country Members, face difficulties in complying with the extended and expanded notification requirements of the multilateral trading system as noted in the Singapore and Geneva Ministerial Declarations.

In order to raise Members' awareness of their notification obligations, the Secretariat almost systematically includes a module on notification requirements in national as well as in regional seminars. Additionally, specialized two-day workshops are organized upon request in Geneva or at the national or regional level. In 2000, one workshop of this type was organized for the benefit of government officials of an acceding country.

#### J. RULES

The Rules Division is responsible for the administration of the WTO Agreements on Anti-Dumping, Subsidies and Countervailing Measures, and Safeguards, as well as the Understanding on State Trading Enterprises. These agreements impose very complex and highly technical obligations on Members and their implementation requires technical expertise and skill which is often not available in Member countries, particularly in developing countries. The Rules Division, therefore, faces constant requests from Members for training and legal assistance at a high-level of expertise. Responding to requests for technical assistance from Members is one of the most important tasks of the Rules Division in the implementation process. However, due to a significant workload increase in other areas of Rules Division's responsibility, mainly dispute settlement, the Division could not respond to many requests from Members; and given the limited availability of staff it has had to reduce its activities in the field of technical assistance.

#### (i) Specialised Assistance Regarding the Use of Contingent Trade Remedies

Specific hands on training to developing countries' investigating authorities is the most efficient form of assistance to contribute to capacity building in the trade remedies activities of developing countries. The Rules Division has traditionally used two modalities for the delivery of

specialized assistance: (i) regional workshops for national officials conducting trade remedies investigations; and (ii) country specific assistance. In previous years both modalities were more or less equally used with very positive results in both cases. Regional workshops made it possible to reach a larger number of countries, while country specific assistance allowed the Division to provide more detailed and focused instruction. However, in 2000 delivery of technical assistance through specialised regional workshops had to be suspended, and only the most urgent requests for specialised assistance were given attention in a country specific manner. This situation was due to the staff shortage and other workload related problems mentioned in the preamble of this report.

#### (ii) Regional Seminars on the WTO Rules Agreements

The purpose of this assistance is to clarify the WTO rights and obligations in the rules area for developing Members and acceding countries. This would allow officials from the attending countries to better assess their country's position with respect to the implementation of the WTO Rules Agreements and identify the necessary steps to be pursued in order to achieve their implementation objectives. This may also permit those countries to increase and enhance their participation in the activities of the different committees of the rules agreements (Anti-Dumping, Subsidies and Countervailing Measures, and Safeguards), and to improve their response to the various notification obligations.

In 2000, the Rules Division carried out three of these regional seminars, one of them directed at Central and Eastern European countries, the others for English-speaking Central African countries and English-speaking African countries.

#### (iii) Seminars on Subsidies

Workshops were held to reinforce Members' understanding of their obligations regarding the notification of subsidies and of the multilateral disciplines applicable to the granting of subsidies. The workshops aim to provide Members with the knowledge and analytical tools necessary to make an inventory of their subsidies programmes and to assess their WTO obligations with respect to those programmes. The workshops are targeted primarily to developing country Members and Members who must modify or eliminate prohibited subsidies within the transition periods set forth in the SCM Agreement. Participants in these subsidy workshops include government officials from agencies which administer subsidy programmes, as well as capital-based officials responsible for WTO affairs. In 2000, the Rules Division carried out one Member specific seminar on subsidy disciplines .

#### (iv) Country-Specific Assistance

A growing number of countries making use of contingent trade remedies request the Rules Division to provide individual training and help to assist them on the development of substantive legal provisions and procedures that conform to the relevant WTO Agreements. Assistance is mostly in the form of one-week missions with technical instruction focused on the most problematic issues in the administration of contingent trade remedies legislation. In 2000 the Rules Division carried out four country specific technical assistance missions, the beneficiaries of these missions were Peru, Ecuador, Paraguay, and Egypt.

#### (v) National Legislation Preparation and Review

One of the most important implementation assistance activities performed by the Rules Division is the assistance it provides in the preparation and review of Members' draft national legislation in the area of contingent trade remedies. Upon request, the Division's staff analyse and provide comments on the consistency of the draft legislation with the Agreements on Antidumping, Subsidies and Countervailing measures, and Safeguards. The staff also comments on the administration of the system that is being put into place, as well as offer their advice on calculation methods and investigating procedures. Members are reminded of their obligations towards exporters in the conduct of investigations, and of their obligations to ensure that their procedures are free of bias

and that their investigations are carried out in the fairest possible manner. This type of assistance requires a careful study of the draft legislation and tends to be a time-consuming process involving close interaction with the Members' responsible authorities and delegations in Geneva. In this area the Rules Division conducted one mission to assist in the drafting of national legislation and regulations of one Member and provided comments on the draft legislation and regulations of two other Members.

#### (vi) Legal Advice

The Division receives frequent requests for advice on issues covered by the various Agreements within its competence. Questions usually come from the Members' administering authorities or other government officials with responsibilities in the area. The questions are mostly directed at seeking clarification on the meaning of specific provisions in the Agreements and how they should be applied in practice.

## (vii) Participation in the Technical Cooperation Division, Training Division and Secretariat Working Group on LDCs/IF Programmes

The Rules Division participates in these programmes where expertise on antidumping, subsidies, countervailing measures, safeguards and state trading enterprises is needed. This includes trade policy courses, notification workshops, seminars on the functioning of the WTO and its Agreements, presentations for capital-based officials and individuals, and presentations for officials from secretariats or bodies of regional arrangements. Among other activities in this field, the Rules Division participated in five courses organized by the Technical Cooperation Division in cooperation with other international organizations or governments, these activities were carried out in Singapore, Korea, Austria, Qatar and Burkina Faso.

#### K. SANITARY AND PHYTOSANITARY MEASURES

The Agriculture and Commodities Division participated in a significant number of technical assistance activities related to the implementation of the Agreement on the Application of Sanitary and Phytosanitary Measures during the year 2000. These included national and regional workshops or seminars, conferences, and technical advice on specific topics. In June 2000, the Secretariat organized a workshop on the Application of Risk Analysis in the Context of the SPS Agreement, which brought together a number of international and national experts on this issue. In addition, the Secretariat organized a regional SPS seminar in Côte d'Ivoire and national seminars in Jamaica and Cuba, and, in conjunction with the World Bank, a regional seminar in Namibia. The Divisional staff also actively participated in a wide range of seminars and workshops organized by national authorities, regional or other international organizations. These included, inter alia, a sub-regional workshop on food safety in Senegal; regional training courses on the SPS Agreement for the Gulf States; a symposium on the impact of the SPS Agreement on the trade of animal products in the Middle East, held in Lebanon; a WHO workshop on trade and health issues in India; a regional workshop on the transparency provisions of the SPS Agreement held in Belarus; a US/Hungary joint training session; a regional workshop for experts in Uruguay; a national seminar in Panama; an ASEM/TFAP<sup>4</sup> Seminar on Risk Analysis and SPS Procedures held in the Hague; the ASEAN Food Conference in the Philippines; a workshop organized by the UN University on biotechnology in Japan; and a conference of the Turkish Food Industry. The Divisional staff also provided technical assistance to Croatia and the Former Yugoslav Republic of Macedonia on their processes of accession to the WTO.

Seminars and workshops organized by the Secretariat are designed to enhance the awareness and understanding of basic rights and obligations under the SPS Agreement, to assist Members and future Members take full advantage of the transparency provisions of the Agreement, and, with the

support of the Codex, OIE, IPPC and/or independent experts, address more technical issues related to implementation. These generally include, for example, risk analysis, equivalence, regulatory reform, development of Hazard Analysis Critical Control Point (HACCP) techniques, etc. The Secretariat has regularly encouraged the active participation of the private sector in these activities in an effort to educate and sensitise these countries' industries and consumers on food safety and animal and plant health protection requirements.

The Secretariat is pleased to see that its technical assistance efforts, combined with those of Members and of international and regional organizations, have had positive results. More Members, and in particular more developing country Members, seem to have a better understanding of their rights and obligations under the SPS Agreement, and how to make effective use of this tool. Their technical assistance needs have become more sophisticated, focussing on in-depth information in particular areas.

More developing country Members have begun to submit notifications and appear to better understand the recommended notification procedures. The Secretariat has produced a detailed handbook on the transparency provisions of the Agreement, developed with the assistance of the New Zealand authorities, which includes templates for requesting information or responding to requests. The handbook is meant as a practical guide for governments to facilitate the implementation of the transparency provisions of the SPS Agreement. Although the handbook was designed to be especially useful for developing and least-developed countries (LDCs), as well as for acceding countries, it is also a useful reference for other WTO Members.

SPS technical assistance activities continued to reveal different concerns and needs, which can be summarized as follows:

- Lack of coordination and exchange of information on a national level, not only within but among the different services responsible for the three sectors food safety, animal health and plant health and also among officials attending meetings of the SPS Committee and those attending meetings of the three standard-setting bodies, namely, Codex, OIE and IPPC.
- Need for continued technical assistance with regard to the establishment of national regulatory frameworks, including the development of legislation.
- Need for increased emphasis on technical assistance pertaining to technical and scientific issues, including risk analysis methodologies, veterinary and quarantine services, the creation of reference laboratories, development of appropriate testing procedures, etc.
- Need for continued efforts to help developing countries' participation in the development and implementation of international standards, through appropriate training.

Finally, Members continue to stress the need for improved coordination among the relevant international organizations in their approach to technical assistance in developing countries, to ensure adequate geographic coverage, to ensure consistency in the advice offered and to avoid unnecessary overlap. Similarly, improved coordination among Members providing bilateral or regional technical assistance is requested. The SPS Committee is addressing this question. The Secretariat is also further coordinating its technical assistance activities with other international organizations, and continues to organize many activities in the context of meetings or initiatives by other international or regional organizations.

#### L. SERVICES

In 2000, demands on the staff of the Trade in Services Division (TSD) to organize and/or attend services-related conferences, workshops and seminars have continued to grow. This seems to reflect at least three factors: (i) the intention of many current Members, in particular developing countries, to keep themselves informed of the new services round and ensure effective participation; (ii) the interests of acceding countries in gaining a deeper understanding of the GATS and its legal and economic implications; and (iii) concerns of various organizations and associations about the perceived impact of the Agreement on core social or infrastructural services. Staff members sought to respond to as many requests as possible within the constraints defined, on the one hand, the Division's manpower shortage and, on the other hand, the growing resource implications of the ongoing services negotiations. These constraints are likely to intensify further.

While previous reports distinguished between two principal types of events – specialized meetings hosted by governmental or government-affiliated bodies and broader-based training seminars - a third type has gained in importance: seminars and workshops organized by specialized international organizations and non-governmental associations with an interest in individual services sectors (e.g. communication, transport, education or health). The latter events have generally proved more demanding, in terms of advance preparation, than other meetings as they tend to focus on the policy implication of the GATS, or particular GATS provisions, under country-specific economic or social conditions.

"Traditional" workshops and seminars are intended mainly to familiarise experts from individual administrations and, possibly, industry associations with the implications of the Agreement for their areas of activity. Recent experience corroborates that, given the complexity of the GATS, such broad-based events should by organized over two, ideally three days. This may prove difficult, however, in individual cases as ministries have to weigh the short-term resource implications of freeing staff with the ensuing longer-term benefits.

What benefits can be expected from such seminars? As noted in last year's report, there is, first, the generation of trade intelligence in agencies and industries not previously confronted with the concept of international services trade and/or the existence of the GATS; second, the creation of country-internal coordination and cooperation links between specialised bodies (ministries, agencies, regulators) and departments in charge of GATS; and, third, in-depth information of personnel whose daily workload may prevent them from closely monitoring developments in Geneva. Contacts during seminars may also translate into longer-term working relations with TSD staff. This may prove particularly important for acceding countries and developing countries with small delegations in Geneva that are unable to attend all relevant services meetings on a regular basis.

Regional seminars may be viewed as more cost-effective than national seminars. However, the participation of individual countries is more limited, and much depends on the "multiplier effects" that may later be generated in capitals. As has been stressed in earlier reports, these effects depend on various factors which are largely beyond the Secretariat's control, including appropriate selection of participants and their continued involvement in the areas concerned. Last year's experience confirms that regional seminars are particularly well prepared by the host countries and/or agencies. The Secretariat's participation was facilitated in several cases by the organizers contributing to the costs involved and/or by the clustering of several meetings in the same region to economize on time and resources. In the latter part of the year, due to budget shortages, the schedule of meetings was determined largely by the ability of interested Members and organizations to cover the Secretariat's travel and accommodation costs.

#### M. TECHNICAL BARRIERS TO TRADE

In 2000, the Secretariat held and participated in seminars on the TBT Agreement and related matters (e.g. standards, conformity assessment and metrology) with the cooperation of the ARSO,

IDB, ISO, ITC, OIML, PTB, UNIDO, US Department of Commerce and the World Bank. They were held in Argentina, Bangladesh, Burkina Faso, France, Georgia, Jamaica, Kenya, Kuwait, Panama, Qatar and Thailand for countries from Africa, Asia, Latin America, the Middle East and Mediterranean region as well as economies in transition. Funds were provided by the WTO Hong Kong, China Funds to finance participants attending the seminar in Thailand.

#### N. TEXTILES AND CLOTHING

The technical assistance plan of the Textiles Division aims to provide Members, as well as countries in the process of accession, with detailed information on the provisions of the ATC. In this context, explanations are given on progress in the implementation of the Agreement in its first six years, requirements of Members in the remaining years of the transition period, recent developments in textiles and clothing trade by country and region, the long term outlook for trade in this sector, developments in other WTO Agreements affecting textiles trade, dispute settlement procedures with emphasis on this sector and notification obligations. In addition, particular care is put into establishing the relationship of these developments to the overall situation in the WTO.

The Textiles Division carries out this plan by responding to requests for assistance made by Members and by acceding countries and observers through regional and national seminars, for both Geneva-based delegations and capital-based officials, covering the three broad regions of developing countries. In many cases this involves participation in joint programmes with other international organizations in order to present the widest possible range of information and views on the ATC and on the situation in overall textiles trade.

In 2000, the Textiles Division participated in one regional and one national seminar in Africa, one national seminar in Asia, one regional seminar in Geneva and in one conference of an intergovernmental organization. The regional seminar was held in Ouagadougou, arranged in cooperation with the Islamic Development Bank, and involved 12 West African countries. The national seminars were held in Mauritius and India. In Geneva, the seminar on the ATC was arranged by the ICC, bringing together the least-developed West African countries. The conference of the International Cotton Advisory Committee, held in Australia, brought together representatives of 24 developing countries and LDCs. The Textiles Division also participated in workshops held in the framework of the African Ministerial Meeting in Libreville, Gabon.

#### O. TRADE AND ENVIRONMENT

In 2000, the Trade and Environment Division participated in a significant number of technical assistance activities related to trade and environment, including national and regional seminars, conferences, and provided technical advice on specific topics related to the work programme of the WTO Committee on Trade and Environment. In particular, the Secretariat organized several regional training seminars on trade and environment in Africa, South America, Asia and Central and Eastern Europe. The intention of these seminars was to have trade officials meet their environmental counterparts from the region and exchange views in order to enhance their understanding of trade and environment discussions in the WTO and the implications for their regions. The seminars sought to increase awareness of the WTO's role and activities in this area and to prepare participants for future discussions in the WTO.

The seminars contributed to:

- The understanding that greater coordination between trade and environmental policy makers is central to policy coherence on trade and environment at both the national and international levels. Trade officials were exposed to the views of their environmental counterparts (and vice versa). Through concrete case studies, e.g. on the relationship between multilateral environmental agreements (MEAs) and WTO rules, it was demonstrated how a lack of proper coordination in the past has sometimes resulted in the negotiation of what may be potentially conflicting international obligations.
- The analysis at the national and regional levels of the complex policy interlinkages involved in the trade, environment and sustainable development nexus and the potential "win-win-win" contribution of secure market access and increased trade liberalization to trade, environment and development.
- An enhanced dialogue and information sharing on country experiences and views between government officials from both the trade and the environmental sides within the region. Participants reflected on the implications of WTO trade and environment discussions on their country and in the region as a whole with the intention of enhancing their negotiating position in future negotiations.

#### P. TRADE AND INVESTMENT

The Secretariat participated in two regional seminars on Trade and Investment, one in Lima, Peru in August 2000, the other in Santiago, Chile in December 2000. The purpose of both seminars was to assist developing countries to better understand the possible role that multilateral rules might play in this area.

#### O. TRADE POLICY REVIEW

In 2000, five technical assistance missions were held in conjunction with missions for the preparation of trade policy reviews i.e. for Madagascar (2), Mozambique and the WTO Members of the Organization of East Caribbean States (OECS)<sup>5</sup> (2). The main objectives of these joint missions were to gather information on technical-related assistance requirements for these Members, which is reflected in the TPR reports and subsequently to organize technical assistance missions taking into account the needs that were identified. This approach will continue to be followed and elaborated, particularly for least-developed countries.

Technical assistance was also provided to several developing countries in the preparation of their trade policy reviews. While the reviews of most developing and least-developed countries are less frequent than for developed countries, the number of requests has increased. The Secretariat provides assistance in this area to all requesting developing countries, in particular African and least-developed countries.

#### R. JITAP

The Joint Integrated ITC/UNCTAD/WTO Technical Assistance Programme for selected Least Developed and other African countries (JITAP) is aimed at helping these countries to integrate/participate in the Multilateral Trading system. This programme is applicable on a provisional basis to eight African countries namely Benin, Burkina Faso, Côte d'Ivoire, Ghana, Kenya, Tanzania, Tunisia, and Uganda. This programme which was launched as a follow-up, in 1997, to the Singapore Ministerial Meeting and the UNCTAD Ninth Conference both held in 1996 has been effectively implemented since 1998 and is to be ended by the end of the present year. Some twenty-four countries have; however, to date presented their application to this programme<sup>6</sup>

- JITAP technical assistance is undertaken jointly by ITC/UNCTAD and the WTO and is focused on the following elements:
- Increasing capacity-building of LDCs through training and dissemination of information on the multilateral trading system;
- Assisting beneficiary countries implement their obligations under the WTO;
- Facilitating participation in WTO events, through the provision of documentation and computer material.

To help achieve these three general objectives, the activities of the programme are arranged into 15 clusters. Each cluster focuses on a specific subject area and includes a set of activities that are inter-linked and sequenced in time to ensure efficient management of the programme. Technical Assistance provided by the WTO is mostly related to cluster 2 (Inter Institutional WTO Committee dealing as the focal point to the programme), cluster 3 (assistance on customs matters including the Customs Valuation Code and rules of origin), cluster 4 (implementation issues faced by the participating countries), cluster 5 (WTO Reference Centres), and cluster 8 (the training of trainers on the multilateral trading system).

In year 2000, activities undertaken by the WTO Secretariat in the context of this programme were mainly regional and national seminars, technical missions, and participation in conference of relevance for the programme. In addition, several activities including on line information as well as technical advice on implementation issues have been provided on a continuous basis during this year in particular those related to cluster 4 and cluster 5.

Of the 24 activities recorded during year 2000 regional seminars accounted for 11 activities while technical missions for 9 of them; national seminars for 3 and participation in a conference on the multilateral trading system. Regional seminars were held in all participating countries except Tunisia. The subjects of these seminars were respectively TRIPs (2), services (2), regional integration and procurement (2) on trade remedies (2) and on legal implementation (1). In these seminars subregional institutions were invited to participate. Inputs were provided for these activities by UEMOA, EAC, ARIPO, and OAPI. With respect to technical missions four of were held in participating countries. These were focused on improving on a constant basis the delivery of the programme. Other technical missions were held in respect of Customs valuation, Trade remedies and notification requirements. Three national seminars were held respectively in Tanzania (2) of which a High-level national symposium on Trade and in Ghana.

In the of year 2000, a mid-term evaluation of the JITAP programme was undertaken. Several conclusions were reached; one of which was that the programme could be expanded to additional countries. It was also suggested institutions could act to redress some of the programmes' weaknesses, such as the private sector and local academic and training institutions, and a greater involvement of the donor countries themselves.

Also three countries located in other regions than Africa in particular Haiti, Yemen and Maldives have also requested to belong to this joint programme.

#### II. TECHNICAL ASSISTANCE: SELECTED MODES OF DELIVERY

#### A. REFERENCE CENTRES AND INFORMATION TECHNOLOGIES FOR DEVELOPMENT

Enhanced use of information technology tools continued to be an important way of delivering WTO technical assistance in 2000. Technical assistance activities, organized with the Joint Vienna Institute for countries in Central and Eastern Europe and in Guatemala, Mexico and Peru for Latin American countries, had substantial video-conferencing and distance-learning components. In addition, on-line fora were organized to permit government officials of WTO Members in distant locations to participate in topical discussions. Themes of on-line fora in 2000 included Trade and Sustainable Development, as well as WTO and Africa. The WTO-World Bank on-line forum on Trade and Sustainable Development attracted the participation of over 1,300 individuals from around the world. The forum was the first initiative of the WTO University Network, which links the organization with universities and research centres to build and disseminate knowledge on international trade issues. Topics broached included poverty, inequality and WTO; technical standards and poverty; LDCs and WTO and why Developing countries should participate in a new Round, as well as democracy and WTO.

The Trade and Development Web site jointly initiated by the WTO and the World Bank continued to provide useful information on-line to enable decision-makers in developing countries to better understand the economic implications and make use of the rules and mechanisms of the WTO. A CD-ROM on existing sources of WTO-related technical assistance was developed in 2000. In addition to serving the immediate purpose of providing a single reference source for potential beneficiaries of trade-related technical assistance, the guide should also be helpful in ensuring adequate co-ordination and co-operation among providers of assistance.

#### WTO Reference Centres

Twenty-seven WTO Reference Centres were established in 2000 to help improve the institutional setting and support trade information systems in least-developed and developing countries. This brought the total number of WTO Reference Centres by 31 December 2000 to ninety-six covering 78 countries and 14 regional/sub-regional organizations. Refer to Annex I for a geographical distribution and a list of individual locations. The majority of the Reference Centres established in the year 2000 were located in regional or sub-regional institutions.

During the year under review, WTO Reference Centres were established in Botswana, China, Gabon, Jordan, Kyrgyz Republic, Lebanon, Mongolia, United Arab Emirates and Comoros. The regional or sub-regional institutions covered were the Secretariats of the Southern African Development Community (SADC), United Nations Economic Commission for Africa (ECA), Common Market for Eastern and Southern Africa (COMESA), Economic Community of West African States (ECOWAS), Andean Community of Nations (CAN), Indian Ocean Commission (IOC), Inter-governmental Authority on Development (IGAD), Caribbean Community (CARICOM), West African Economic and Monetary Union (UEMOA), African Development Bank (AfDB), Arab Maghreb Union (UMA), United Nations Economic and Social Commission for Western Asia (ESCWA), Secretariat for Central American Economic Integration (SIECA) and the Organization of Eastern Caribbean States (OECS). WTO Reference Centres were also established at

the Dominica High Commission in London and at the Brussels-based Embassy of Burkina Faso. Training was provided to officials from all London-based Caribbean Missions in September in the former, and to LDC officials of all ACP Missions in the latter in February/March 2000.

WTO Reference Centre computer equipment was procured for the Brussels-based Embassies of Bénin, Chad, Grenada and Niger to facilitate their access to the Internet. A computer equipment was also procured for the Republic of Congo.

The activities carried out during the year 2000 focused mainly on training of officials on accessing the wealth of information on the WTO Internet site and digital carriers (e.g. CD-ROMs) developed by the WTO. The regional or sub-regional institutions procured their own computer equipment and ensured Internet access before the arrival of the WTO team at the Headquarters of the particular institution.

Follow-up activities in 2000 have included the replacement of computer equipment and/or procurement of computer accessories (uninterruptible power supply device--UPS and "surge arrests") for Bénin, Central African Republic, Chad, Malawi and Niger to stabilize electric power supply to the computer equipment. During the year under review, the WTO Secretariat explored ways of providing free Internet access for WTO Reference Centres located in least-developed countries. Close to 48,000 pages of Daily WTO News Headlines were sent to all WTO Reference Centres during 2000.

In May 2000, a survey was conducted to assess the effectiveness and usefulness of the WTO Reference Centres. The responses received demonstrate that the Reference Centres have indeed become indispensable sources of information on the WTO for the Government, academia and the business community. Some depict the Reference Centres as a "one-stop shop" for trade-related information on the WTO, while others describe the training provided as useful to the extent of reducing the amount of time spent searching on-line for documents, or information on the WTO. Countries benefiting from WTO Reference Centres have increasingly recognized them as WTO national offices located in cyberspace from where they obtain an instantaneous response to most of their WTO-related queries and obtain relevant information. Several countries are also using the WTO Reference Centres as their enquiry points to fulfil various notification requirements under the Agreements on SPS (Annex B:3); Technical Barriers to Trade (Articles 10:1 and 10.3) and GATS (Article III:4). Moreover, officials benefiting from the Reference Centre training indicated, in questionnaires given at the end of each training session, that they would use the expertise acquired to access electronic training tools, WTO information resources, maintain ongoing contact with the WTO and to access WTO meeting schedules. Indeed, the establishment of WTO Reference Centres in several developing countries has contributed to improved information flows between the WTO Secretariat and Ministries of Commerce of WTO Members, and regional or sub-regional organizations.

Information Technologies For Development (ITD)

The Web site of the Trade and Development Centre is an Internet site with information and training resources designed to meet the needs of LDCs and other developing country trade officials. The Internet site is used by about 15,000 visitors per month. The content includes:

- On-line fora on trade issues of interest to developing countries: Three fora were organized over the past year with participation from users world-wide, mostly from LDCs and other developing countries.
- Developing country case studies: Case studies have been developed and are available on the Internet site.
- Interactive training guides: These can be viewed online or downloaded from the Internet site.

- Training activities: These include the WTO trade policy courses and World Bank courses.
- World Bank integrated program for Agriculture: The World Bank's integrated program of research and capacity building aims at enhancing the participation of developing countries in the WTO 2000 Negotiations on agriculture.

Development of electronic training and information materials remains crucial for LDCs and other developing countries. Some of the current activities are:

- Continued development of Internet and CD-based information material for WTO Reference Centres, as well as for use in other WTO activities, including Short Trade Policy Courses.
- Expansion of the ITD Internet site to include more case studies, on-line for aand other content.
- Development of a library of interactive training tools on CD-ROMs. The first such module on the Agreement on Textiles and Clothing offers users three hours of interactive course material. More computer-based training modules on other WTO Agreements, to be made available on CD-ROMs and accessible on the Internet, are under development.
- The World Bank Global Distance Learning Network (GDLN). This is a project initiated by the World Bank aimed at using communications technologies to deliver training programs (distance learning) and access to computerized databases to developing countries. It is a global communications system with computer links, video-conferencing and interactive classrooms. The World Bank developed the first Centres in 1997 using facilities in its network of field offices located in capitals of developing countries. The current phase of the project is to establish Distance Learning Centres (DLCs) which are owned and operated by training and educational institutions in each participating country. The existing GDLN network covers several countries in Africa, Asia, Caribbean and South America. The WTO continued its collaboration with the World Bank on this project in 2000. There has been one pilot project to-date in which the WTO used the Bank's network for a 6-hour interactive seminar on notifications. This session was conducted from the WTO Secretariat in Geneva for about 60 trade ministry officials in four African countries.

Training in the use of information material on the Internet and on CD-ROM, including the use of specialized databases, remains the most important need identified by LDCs and other developing country trade officials.

#### B. DISTANCE LEARNING AND COMPUTER-BASED TRAINING

The innovative use of distance education and learning methods and techniques can augment the impact of technical assistance activities. The main beneficiaries are junior to mid-level government officials who need to better understand WTO rules and procedures, but the use of video-conferences has also proven to be highly efficient in the delivery of specialized assistance.

#### (i) University Network in Latin America

A successful pilot project was executed in 2000 in collaboration with Mexico's Monterrey Institute of Technology and Higher Studies (ITESM). Six videoconferences were broadcast live by satellite from Geneva to university centres located in nine Latin American countries. Each

videoconference featured a presentation of 45 to 60 minutes made by one or two WTO experts on a specific subject such as trade in goods, trade and environment or dispute settlement, followed by a 20 to 30 minutes question-and-answer session. On average, 300 persons attended each videoconference, mostly students and businesspeople. An evaluation was conducted by ITESM through an online questionnaire and the cycle was rated as useful to very useful by most participants.

#### (ii) Videoconferences

Videoconferences have been used on a regular basis during 2000, in particular for short interventions by specialized experts of the WTO Secretariat during Short Trade Policy courses. In addition, videoconferences were used to deliver presentations in seminars and workshops where it was not feasible or practical to be physically present.

#### (iii) The WTO: A Training Package

A computer-based package on the World Trade Organization was prepared by the Secretariat and is accessible on the WTO web-site (*www.wto.org*) since 1998. It mirrors the structure of a general seminar and covers all concepts developed in a normal 4 to 5 day seminar run by TCD. It consists of ten modules. Each of the first nine modules corresponds to a three-four hour seminar lecture, and includes a review section using the Frequently Asked Questions (FAQ) approach. The last module -module 10 - contains the Final Act as well as other key WTO documents. This package is in the process of being updated.

The package can be seen as two inter-related components: (i) a set of over 350 "slides"; and (ii) a "book" that contains a short explanation for each bullet point appearing on the slides. The slides and the book are both available in English, French and Spanish on-line.

Among the advantages in using this distance learning tool are: 24 hour access; self-directed and self-paced (convenient for users); interactive and collaborative; content can be modified in a relatively easy manner; and each slide allows the user to send an e-mail to the WTO Secretariat for further clarifications.

Apart from its main use – computer-based self-training - this material can be used in two other ways: (i) to explain in a structured manner the work of the WTO, and (ii) to help trainers organize their presentations using slides. In the former case, no slides are needed while in the latter the "book" is used to highlight the key concepts that are elaborated in each slide presented. In 2000, over 500 copies, mostly on CD-ROM, were distributed and over 8,000 individual modules were downloaded from the web-site.

#### (iv) Computer-Based Training (CBT) series

The objective of this tool is to capture on CD-ROM the subjects presented in WTO Trade Policy Courses. The target audience are trade officials of developing countries as well as other interested persons who are not in a position to attend the residential courses. Using the CD-ROMs, they have access to the course material developed by WTO experts. The material is presented using a multimedia approach that combines text, audio and video segments in an interactive, pedagogical manner. Each module includes a test through which the student, and instructor, can measure progress in absorbing the subject presented. A first trilingual product on the Agreement on Textiles and Clothing that incorporates three hours of course material is already available and over 200 copies were distributed. A second CD-ROM covering the Application of Sanitary and Phytosanitary Measures (SPS Agreement) is in the process of being finalized.

In addition, a CD-ROM entitled "Introduction to the world economy: a course with emphasis on transition economies" has been developed by the World Bank in partnership with the WTO Secretariat and the Centre d'Etudes et de Recherches sur le Développement International (CERDI), University of Auvergne. This CD-ROM contains 16 lectures on trade policy issues and more than 200 articles (in pdf format) that can be used as support for a "traditional" course. This CD was prepared to accompany the two-week trade policy segment entitled "Trade Policy and the International Trading System" which forms part of the Applied Economic Policy courses taught at the Joint Vienna Institute. Around 150 copies of the CD-ROM were distributed in 2000, mostly to participants in the above-mentioned courses.

#### (v) WTO Documentation in Electronic Form

CD-ROMs containing WTO documents and training materials are produced on a regular basis in-house and distributed during technical assistance activities. During 2000, over 20 such CD-ROMs have been prepared, in particular for participants in Short Trade Policy courses.

#### (vi) Other CD-ROMs (publications)

The WTO has developed a growing series of electronic publications, normally distributed as CD-ROM products. Copies of these electronic publications have been provided to WTO Reference Centres as well as to delegations of developing and least-developed country Members. Most of these CD-ROMs are also available for sale. The following products are used in technical assistance activities on a regular basis:

- Results of the Uruguay Round. This trilingual CD-ROM contains all WTO rules and commitments made by its Members and the Schedules of Concessions on goods and on services (nearly 30,000 pages of undertakings). For each Member there are product-by-product lists of bound tariff rates affecting market access for goods, including agricultural products. The Schedules of Specific Commitments on services identify the services sectors to which a country will apply the market access and national treatment obligations of the GATS and any limitations from those obligations it wishes to maintain.
- Guide to GATT Law and Practice: Analytical Index. This CD-ROM contains the complete text of the corresponding publication and is fully searchable with hyperlinks and on-screen help.
- *GATT Basic Instruments and Selected Documents (BISD)*. This trilingual CD-ROM contains the 42 volumes of the corresponding publication and uses the same software as that for the Analytical Index.
- *Trade Policy Review* collection. This series covers the Trade Policy Review reports. The second issue covers the period 1995-2000. It is updated annually.
- WTO Trade Statistics on CD. This trilingual CD-ROM consists of trade statistics from Volume II of the WTO Annual Report. The last edition covers 2000. It is updated annually.
- WTO Internet site on CD. This CD-ROM allows to browse and print the information available on the WTO web-site at a certain date off-line. Updates are pressed every six months.

#### I. OVERVIEW OF TECHNICAL ASSISTANCE ACTIVITIES<sup>7</sup>

#### A. REGIONAL DISTRIBUTION OF TECHNICAL ASSISTANCE ACTIVITIES

Regarding the geographical distribution of technical assistance activities held, Table II gives a regional breakdown in person days. African countries benefitted from over 20 per cent of all assistance (1,435) in 2000. Compared to 1999, technical assistance in both the Middle East and Central and Eastern Europe and Central Asia increased significantly (54.9 per cent and 29.4 per cent respectively). Assistance in other regions represented 25.5 per cent of all activities for Asia and the Pacific and 23.4 per cent for Latin America and the Caribbean.

## B. DISTRIBUTION OF TECHNICAL ASSISTANCE ACTIVITIES BY MODE OF DELIVERY

It is recalled that WTO's technical assistance activities are conducted by different modes of delivery at the national and regional levels: seminars, workshops, training courses, technical missions, conferences and symposia. Summary information on modes of delivery is contained in Table IV.

Compared to 1999, the Secretariat's participation in training courses at both the national and regional level increased considerably from 163 to 253 person days in 2000 for all regions, with the biggest growth in Central and Eastern Europe and Central Asia. This strong demand reflects a continuously strong interest in the WTO issues, and the need, particularly of countries in the accession process or those which have recently acceded, to address implementation issues of the Agreements. The topics of the workshops, conferences, round tables, training courses were wide-ranging and generally dealt in-depth with specific issues. Workshops follow a 'hands-on' approach, with officials being trained and/or familiarised with the intricacies of a specific agreement. The Secretariat's considerable involvement in technical missions in all regions reflects a continuing demand for specific assistance on implementation and regulatory issues.

Technical assistance activities in Africa were mainly delivered in the form of seminars, technical missions and training courses. The regions of the Middle East and of Central and Eastern Europe and Central Asia saw the greatest increase in technical assistance activities at the national level, while the latter region also saw the greatest increase overall and at the regional level in person days. The Middle East saw an increase in the number of person days associated with seminars, technical missions and training courses, while Latin America and the Caribbean saw an increase in training courses and conferences.

While the mode of delivery may vary among regions, each region continued to be covered by a variety of activities.

## C. RELATIVE SHARE OF TECHNICAL COOPERATION DIVISION IN ALL TECHNICAL ASSISTANCE ACTIVITIES

It has often been emphasized that technical assistance is provided by the WTO as a whole, and not solely by the Technical Cooperation Division (TCD). The information available (Table V) shows that of all activities (expressed in person days), the Technical Cooperation Division was responsible for 426, representing a share of 29.7 per cent. A total of 330 person days were provided jointly by TCD and other Divisions, representing 23 per cent, and the vast majority of person days (679) were provided by other Divisions, representing a share of 47.3 per cent. It should also be noted that this increasing number of activities carried out by all Divisions in the WTO is done with only a modest increase in staff.

#### II. REGIONAL/NATIONAL PROGRAMMES AND SPECIALLY FUNDED PROJECTS

#### A. AFRICA

This section refers to the following 20 African Developing Countries: Algeria, Botswana, Cameroon, Congo, Côte d'Ivoire, Egypt, Gabon, Ghana, Kenya, Mauritius, Morocco, Namibia, Nigeria, Senegal, Seychelles, South Africa, Swaziland, Tunisia, Zimbabwe.

The total number of activities amounted to 61. Regional seminars and workshops accounted for 19, national seminars and workshops for 8, technical missions for 16, and conferences, symposia and colloquia for 12. The establishment of new WTO Reference Centres accounted for six activities.

Of the nineteen regional seminars held in 2000, several were jointly organized with other international organizations, namely FAO, ITC, ITU, UNCTAD, UNDP and the World Bank, and with regional institutions such as CEMAC, COMESA, or SADC. Participants from selected African countries also participated in Short Trade Policy Courses organized at inter-regional level by UNCTAD, Islamic Development Bank or individual countries, in particular Singapore, the United States, and Australia.

A total of eight national seminars were organized at the request of individual countries during 2000. Most were seminars of a specialised nature aimed at providing an in-depth knowledge in a particular area or WTO Agreement. Several of these seminars were organized in the context of the JITAP programme.

Technical missions continued to be one of the most important activities undertaken for African countries. A total of 16 activities were undertaken in the year 2000. Most of these missions aimed at helping individual countries to adapt their existing legislation and regulations to the WTO Agreements in areas such as customs valuation, trade remedies and TRIPS, and transposition of tariff schedules. Four technical missions were undertaken in the framework of the JITAP programme, and two technical missions were held in connection with the Trade Policy Review exercise.

In 2000, the WTO participated in 12 conferences, symposia or colloquia organized either by the WTO and/or by other international institutions, regional or sub-regional institutions, or individual countries. Some of the subjects dealt with in these events were Agenda for Africa, Emerging African Market, Globalization, Sustainable Economic Development, Trade Promotion, and Electronic Commerce.

In continuation of the WTO Information Technology for Development project launched in 1997, two new Reference Centres were established in individual African countries and four in subregional organizations.

Refer to Annex 2a for the list of activities undertaken in 2000.

#### B. ASIA AND THE PACIFIC

Among the regional activities that took place in Asia and the Pacific were:

The first WTO/ESCAP Trade Policy Course on the WTO and the Multilateral Trading System for 23 Asian Developing Economies, held in Bangkok (8-26 May 2000). This course provided an opportunity for Asian national WTO desk officers to get a deeper understanding of the fundamental principles of the WTO, the theoretical basis for international trade, and the rules and practices under the various WTO Agreements. Time was also devoted to new issues (trade and competition policy, trade and investment, transparency in government procurement, trade facilitation).

- A joint Singapore/WTO Trade Policy Course for Developing Countries was held in Singapore (14-22 September 2000) under the Singapore/WTO Memorandum of Understanding. This course is held annually for trade officials from developing and least-developed countries.
- The purpose of the WTO/Forum Secretariat /FAO/Commonwealth Secretariat Regional Seminar held in New Zealand (3-7 April 2000) was to explain to the Pacific Island countries the implications of WTO Agreements, with a special focus on agriculture, SPS and special and differential treatment provisions, and the harmonization of domestic policy, legislation and regulations with WTO requirements.
- A WTO/Asian Development Bank Regional Seminar was held in Tokyo (17-25 July 2000) on capacity-building in international and regional trade policy issues. This also involved detailed presentations of the implementation of WTO Agreements.

Specialized regional seminars were carried out on a number of Agreements. Regional seminars on the TRIPs Agreement and its implications for developing countries were held in India, Thailand and Hong Kong China; on TBT/SPS and conformity assessment procedures in Australia, Japan, Thailand, and the Philippines; on trade in services in Singapore and Malaysia; on trade and competition policy in Thailand and India; on textiles for ASEAN textile manufacturers in Malaysia; and on WTO Agreements for international trade lawyers in Australia. In addition, a regional seminar on electronic commerce strategies was held in India; and on trade and environment in Thailand.

In an increasing number of technical assistance activities, an increasing use was made of case studies and simulation exercises resulting from feed-back of participants. These covered dispute settlement procedures and practices, trade in services negotiations, and trade negotiations simulations. Another improvement was the use of customized lectures incorporating examples directly related to the trading framework and negotiating positions of the participants. A first step in the outsourcing of WTO technical assistance activities in the region came with the implementation of a Memorandum of Understanding signed with the Secretariat of the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP). In this case, the training programme was jointly set up and UNESCAP was responsible for all logistical and administrative matters.

Annex 2b shows a large number of additional activities that were carried out at the regional and national levels, directly by the WTO Secretariat or jointly with national administrations, international or regional organizations. These activities cover virtually all subjects of responsibility within the WTO legal system, including the establishment of WTO Reference Centres.

Refer to Annex 2b for the list of activities undertaken in 2000.

#### C. CENTRAL AND EASTERN EUROPE AND CENTRAL ASIA

During the year 2000, a broad range of technical assistance activities were undertaken for Central and Eastern European and Central Asian countries, including national and regional seminars, technical missions, workshops and training courses. The nature of the activities depended mostly on the specific requirements of each beneficiary country. Several countries in this region are currently in the process of accession, while others have recently joined the WTO as full Members, including Albania, Croatia and Georgia. In addition, some countries have been GATT Contracting Parties, and later WTO Members, for some time. The requirements thus differ considerably among those countries that need specific advice in their accession process, those that seek to improve their institutional and human capacity to enhance their understanding of the multilateral trade rules, and those that face implementation issues.

One main objective in designing technical assistance for countries in this region is to ensure that the offer meets the specific needs that have been identified by beneficiary countries in writing, during country visits, in seminars or in bilateral discussions. A questionnaire was sent in the summer of 2000 to which the vast majority of countries replied.

Countries that have recently joined the WTO continue to express a need to be trained on the operation of the system, particularly in those areas that contain new obligations. Problems encountered in the implementation process are frequently related to a weak knowledge base in specific areas and/or a weak institutional framework to implement the WTO Agreements. Efforts by the Secretariat have consisted mostly of providing assistance in the legislative process and are geared to achieving a better understanding of the Agreements, mostly by providing information through technical missions and training on the implementation of the Agreements. Training material is put at the disposal of the officials.

Efforts continue to be pursued to assist countries in the region in their accession process, or, for those that are Members of the WTO, in meeting the requirements of the WTO Agreements. Countries that are in the accession process require mostly a broad range of assistance, often starting in the early stages of the drafting process of the memorandum on the foreign trade regime, on tariff schedules, bindings and services commitments, and including general and/or specific explanations on the Agreements. At later stages in the accession process, the Secretariat is often called upon to provide explanations to a broader audience, to increase awareness of the WTO system, including the public and private sectors and Members of Parliament. This type of activity is often considered important by government officials who have negotiated the accession, in order to broaden the domestic support for accession and to disseminate information on the WTO to those that have not been directly involved in that process.

Activities of a specific nature to which countries were invited to nominate officials included, *inter alia*, agriculture, rules, market access issues, negotiating techniques, dispute settlement courses, and services. The duration of these activities varied between several days and a week. Also, short (two- or three-week) training courses were held both in Geneva, at the WTO headquarters, as well as at the Joint Vienna Institute (Austria). These training courses aim at assisting countries in developing a better understanding of the WTO rules and agreements and sharing information and experiences among participants. The courses, conducted by experts from the WTO, include video conferencing with WTO experts from WTO headquarters, interactive training with simulation exercises, CD-Roms, and training material available on the WTO web site. These courses provide officials with an opportunity to deepen their knowledge in areas of interest to them and establish contacts with WTO officials, thus providing a basis for further exchange of information by e-mail, fax or telephone.

The Secretariat continues to cooperate with regional and/or international specialized agencies, organizations and institutes to enhance efficiency in the delivery of information and organization of the activities. This includes the Black Sea Economic Cooperation (BSEC) based in Istanbul (Turkey) and the Economic Cooperation Organization (ECO) based in Tehran (Iran). Cooperation with these bodies has intensified. In addition, various (bilateral) donor agencies are active in the field, who often call upon the WTO to provide its expertise on specific agreements. In some cases, they directly sponsor WTO participation in their activities and assume all logistical and administrative aspects of the seminars, thus generating cost savings for the WTO. This cooperation will be built upon for future activities.

#### D. LATIN AMERICA AND THE CARIBBEAN

Notwithstanding the operational difficulties posed by the lack of decisions on technical assistance at the 1999 Ministerial Conference in Seattle, technical assistance activities with countries in the Latin American and Caribbean region continued in 2000, although in a slightly scaled-back manner.

Three innovative projects carried out in 2000 were:

- The first delivery of the planned Short (two-weeks) Trade Policy Courses at the subregional level, one in Lima at the Headquarters of, and in collaboration with, the andean Community Secretariat, and one in Guatemala at the Headquarters of, and in collaboration with, the Secretariat for Central American Integration (SIECA).
- The development of a Group Trade Policy Review for the Organization of Eastern Caribbean States (OECS) Members of the WTO, as a joint TPR-Technical Cooperation project.
- The first extensive application of distance-learning techniques through video-conferencing, both in the execution of the Short Trade Policy Courses and in a standalone Cycle of six Video-Conferences on WTO issues organized jointly with the Institute of Technology and Higher Studies of Monterrey (ITESM), Mexico, and broadcast, in real time, to academic centres of excellence associated with ITESM in nine countries in Latin America. Access to this Cycle of Conferences was assured for government officials of the countries concerned.

As pointed out in previous reports, over the last five years the WTO has developed a three-pronged approach to technical assistance activities with Latin American and Caribbean countries: first, carrying forward WTO's collaboration with regional institutions in the region, particularly the Institute for Integration in Latin America and the Caribbean (INTAL) of the Inter-American Development Bank (IADB); second, responding to requests from individual WTO Members on specific issues, through technical missions and national seminars and workshops; and third, responding to requests for the establishment of coherent national programmes of activities. Finally, in 2000 the programme on WTO Reference Centres, which had been extended to small economies and island countries in the region in 1999, was further expanded into regional Secretariats.

The WTO and INTAL, a research, training and general policy discussion organ of the Integration and Regional Programs Department of the Inter-American Development Bank, have been working together since 1997 in the organization and delivery of a number of technical assistance activities. In view of the success of these activities and the increasing demand from countries concerned, the idea was broached in late 1998 of putting IADB-INTAL/WTO collaboration on a more formal and structured basis. Consequently, and taking into account the expressed interest of the IADB for a joint programme with the WTO, a Memorandum of Understanding was prepared on the basis of the practice developed through the work already done. The MOU was signed by the IADB and the WTO in July 2000.

During 2000, eight different activities in the region were organized under the programme, covering MERCOSUR, the Andean Countries, the Central American Common Market and other countries in Central America and Spanish-speaking Caribbean, CARICOM countries, and Mexico. Different WTO subjects have been dealt with, including market access, agriculture, trade in services, subsidies and countervailing measures, anti-dumping, negotiating techniques, etc. Short Trade Policy Courses started in 2000, with courses delivered to the Andean Community Member countries and to countries in Central America and the Spanish-speaking Caribbean. The objective is to deliver at least one course every 12 to 18 months in each of the sub-regions. The introduction in these Courses of

real-time video-conferencing from Geneva with WTO experts, to supplement in-place lecturers' explanations, has met with great success, although there is always room for improvement due to the different technology levels in different countries and the organization of the presentations themselves.

The following points provide an initial overall assessment of the programme:

- The evaluations submitted by participants have consistently rated each activity as "very good" (20/30%) to "excellent" (40/60%); the concerns expressed by participants rating "good" or "fair" have mostly related to short duration, more case-study oriented, the need for more practical examples to better understand the functioning of the rules, not enough information on negotiating and political positions of their various trading partners, etc. We have tried to respond through introducing more up-dated information on the state of play in the various WTO bodies, as well as mini-tests in the form of written questionnaires, "quizzes" on scheduling of services commitments, market access negotiations and dispute settlement simulations, etc. These have been highly successful.
- The sub-regional approach adopted for the execution of activities has allowed the seminars, workshops and courses to be oriented towards the specific problems in each sub-region, which differ considerably from one to the other; in areas such as subsidies and anti-dumping. This approach has also recognized the different levels of usage of these instruments among countries, and thus permitted the workshops to be tailored specifically to their needs.
- INTAL's coordination with the WTO Secretariat, either through the Technical Cooperation Division or directly with the Divisions concerned with specific activities (Agriculture, Rules, Services, etc.), and its substantive participation in all events, has proceeded smoothly and efficiently; INTAL's access to the IADB network in all the countries in the region has proved to be extremely useful, particularly as to the preparation of logistical and other local arrangements.
- Where regional institutions other than INTAL (such as CABEI, ECLAC, SELA, IICA, ALADI, etc.) have been the main proponents of various activities, coordination with INTAL has succeeded in mobilizing additional resources and avoiding duplication, as well as provided the opportunity for officials from regional secretariats to also take part in lecturing and training participants, thus increasing inter-agency collaborative efforts throughout the region.
- On the whole, the IADB-INTAL/WTO association has allowed the WTO Secretariat to considerably deepen its own knowledge of the region and its problems, has provided valuable lessons to be applied in the general improvement of WTO technical assistance activities, and has contributed to the building of a sound basis of information and awareness in the region on the multilateral trading system, which is clearly reflected in the increasing demand for more specific activities to deal in-depth with various subjects.

In light of the above, IADB-INTAL and the WTO have jointly decided to extend the programme to the end of 2002, incorporating adjustments and improvements in their activities, as necessary, based on lessons learned.

Among other regional activities, the OAS/Georgetown University/WTO Advanced Training Course on Multilateral and Regional issues in the trade agenda for the Americas, for the benefit of small economies in the region (delivered separately in English and Spanish in the summer) deserves special mention. This programme, delivered annually since 1998, has become one of the highlights of technical assistance activities in the region.

Activities in 2000 show a clear trend towards more intensive work at the national level, and fewer events at the sub-regional and regional levels. Regarding topics covered, the trend is clearly towards an increasing interest in in-depth, subject-specific assistance, geared more to problems and implementation, and forward-oriented to participation in future negotiations, and demonstrates a more advanced level of awareness and understanding on the part of the governments concerned. Nevertheless, turnover due to democratically elected governments will still require repeats in the training of officials new to the WTO.

#### E. MIDDLE EAST

The year 2000 saw the accession of two Middle East countries to the WTO. Jordan acceded to the WTO on 11 April 2000 and Oman on 9 November 2000. Other Middle East Members of the WTO are Bahrain, Cyprus, Kuwait, Qatar and the United Arab Emirates (UAE). Lebanon, Saudi Arabia and Yemen (an LDC) are still negotiating their accession to the WTO. Relative to 1998 and 1999, technical assistance activities in the Middle East expanded in response to increasing needs of acceding countries and demands for assistance on implementation issues by Members in the region.

National seminars and workshops were held in Cyprus, Jordan, Kuwait, Lebanon, Oman, Saudi Arabia and the United Arab Emirates. The topics broached in these seminars included Agriculture, TRIPS, SPS and TBT matters, dispute settlement procedures and practices, trade in services and investment including electronic commerce and telecommunications, notification requirements and skills for multilateral trade negotiations.

Technical missions covered the implementation of GATS in the United Arab Emirates, government procurement in Jordan, customs valuation in Kuwait, and establishment of WTO Reference Centres in Abu Dhabi, Dubai, Jordan and Lebanon (ESCWA and the Ministry of Economy and Trade). WTO officials also participated in conferences held in Lebanon (on telecommunications), Cyprus (on GATS), Jordan (on UNDP-WTO technical cooperation in the Arab region) and Kuwait (on investment policies and opportunities in the global market).

Two regional seminars were held in the United Arab Emirates and one in Lebanon. The UAE regional seminars covered food safety policies and the implementation of the Agreements on Agriculture, SPS and TBT; as well as the services negotiations. The regional seminar in Lebanon covered the Agreement on Sanitary and Phytosanitary measures. Saudi Arabia hosted the two symposia on WTO Agreements, as well as customs valuation and free-trade areas. The Fourth Short Trade Policy Course, organized jointly with the Islamic Development Bank, was held in Qatar in October 2000. The Islamic Development Bank provided the funding and the WTO provided the resource persons.

Middle East countries and institutions generously supported and contributed financially to WTO technical co-operation activities in the region during 2000. These included Saudi Arabia, United Arab Emirates, Kuwait and such intergovernmental institutions as the Islamic Development Bank, the Gulf Co-operation Council and the Arab Research Fund, whose contributions in 2000 can be estimated at about five hundred thousand Swiss francs.

During the year under review, the WTO Secretariat signed a number of Memoranda of Understanding (MOU's) with Middle East institutions to facilitate delivery of prompt and effective technical assistance to Middle East countries. MOU's were signed with the Islamic Development Bank, and the ESCWA Secretariat.

An assessment of the technical co-operation missions points to a deepening of knowledge of the WTO Agreements in the Middle East region. In particular, the missions have triggered proposals from several countries to set up national committees to co-ordinate WTO-related matters, and to demand more emphasis on implementation issues rather than explanation of the Agreements, in future WTO missions. On other fronts, the hosting was announced of the Fourth WTO Ministerial Conference in Doha (Qatar) in 2001.

During the year under review, six briefings were arranged at the WTO Secretariat for visiting senior officials from the Middle East. In April 2000, a three-week briefing on the functioning of the WTO and the multilateral trading system was arranged for a visiting official from Bahrain. In June 2000, a four-day briefing was arranged for two senior officials from the Qatar-based Gulf Organization for Industrial Consulting on the functioning of the WTO. From the last week of October until mid-November 2000, four separate briefing/training sessions were organized for five trainees from Jordan. Two trainees followed training on trade remedy measures in the Rules Division, and one each on TBT and trade and environment, SPS and Agriculture issues in the Trade and Environment Division, as well as in the Agriculture and Commodities Division.

#### **SECTION THREE**

# WTO TECHNICAL ASSISTANCE ACTIVITIES IN LEAST DEVELOPED COUNTRIES

### I. STATUS REPORT ON THE INTEGRATED FRAMEWORK FOR TRADE-RELATED TECHNICAL ASSISTANCE FOR LDCs,

The review of the Integrated Framework for Trade-Related Technical Assistance had been initiated in November 1999. The review had been initiated pursuant to paragraph 6 of the Framework document that emerged from the High Level Meeting. To initiate the review, an independent review team was appointed to assess the operation of the IF, since 1997. The objective was the results of the independent review team would create a basis for the agencies to re-examine the IF, take decisions and make recommendations for its improvement.

The Independent review team was task-managed by the World Bank. The review team was headed by Mr. Sarath Rajapatirana. Other members of the team were Charles Lusthaus and Marie-Hélène Adriene. The World Bank requested an Advisory Committee, composed of John Eriksson and Hans Wyss, to provide independent advice and counsel to the evaluation team. The report of the review was submitted to the core agencies on 8 June 2000. It was circulated to WTO Members on 29 June 2000. In considering the report, the core agencies considered that it was essentially an input into the final stage of the review process in which WTO members, donors and LDCs were involved.

The essential recommendations of the report of the review, for the improvement of the IF, were as follows:

- a) <u>Clarify Policy Objectives:</u> Clarify the objectives of the IF by restricting it to technical assistance for trade-related development, to support, inter alia, policy reforms, manpower and human resources development, customs reforms, institutional change and legal environment reforms. Infrastructure investment and other hardware development, as well as technical assistance solely related to equipment and bricks and mortar, would be handled in the context of Consultative Groups (CGs) supported by the World Bank and the UNDP-supported Country Round Tables (as distinguished from the round tables presently held for the IF).
- Prioritize and Link to Overall Development Assistance Architecture: In the future most development assistance strategy issues are likely to be developed through participatory processes, in the context of such exercises as the Poverty Reduction Strategy Papers (PRSPs), the Comprehensive Development Framework (CDF) and the United Nations Development Strategy Frameworks (UNDAF). These efforts will be prepared by LDCs in consultation with the World Bank, the IMF, UNDP and other UN agencies, donors and stakeholders. In all such endeavours, country strategy will define the role of trade development and related technical assistance. The IF will then be linked to the priorities established through the formulation of country development strategies.
- c) Give Ownership to the LDCs: Make the IF process more demand driven and countryowned by requiring LDCs to prioritise their specific needs from the list of traderelated technical assistance activities listed in the Needs Assessments. Once a particular trade-related technical assistance project or program is identified as a priority by an LDC, that particular project or program would be submitted to the agency responsible for managing and coordinating such technical assistance.
- d) <u>Strengthen Governance and Administration:</u> The review considered two options: (i) strengthening the Administrative Unit to the point that it can manage the IF while continuing to be located at the ITC in Geneva, and (ii) moving the responsibility for managing the IF to WTO (where the Administrative Unit would be integrated). On

balance, the review concluded that the superior option is to make the WTO responsible for IF management. This is because the IF requires leadership in the trade field. This leadership in trade resides in WTO, following the Uruguay Round. Given the specific capacities required for managing the IF (within the sharper focused objectives as per (a) above), WTO will need to strengthen its ability to handle traderelated technical assistance. The Inter-Agency Working Group (IAWG) would continue as an advisory group, meeting not more than twice a year, and help WTO in its coordination with the other IAWG agencies.

- e) <u>Coordination Issues:</u> Once governance is strengthened along the lines of the foregoing recommendation, coordination can be better assured, as WTO will be the designated clearinghouse for inter-agency coordination issues. After completion of all Needs Assessments, the IF process can be simplified. There is also no need to hold round table meetings for the IF, if no trade-related technical assistance funding is expected. As to coordination within LDCs, the lead ministry in the country (whether it be Finance or Planning) that now discusses and presents infrastructure projects to the donors in the context of World Bank-supported CGs and UNDP-supported Round Tables, should bring the Trade or Commerce Ministers to support their requests for trade-related investment assistance at these forums. A special session for trade development may be considered in these forums.
- f) Funding the IF: First, the IAWG agencies and donors will need to ensure that they budget their administrative costs related to the IF while providing whatever other incentives are needed for a better recognition of the responsibilities which they undertook when the IF was created. Second, when it comes to the financing of traderelated technical assistance projects, one approach would be for WTO, as the managing agency for the IF to set up and manage a Trust Fund to finance such technical assistance projects. All donors, including multilateral agencies, would contribute (on a voluntary basis) to the Trust Fund as an expression of their commitment to the IF. The Trust Fund could be replenished every three years, depending on the demand for such funds. The LDCs would access the funds according to well-established criteria and use them within the priorities established under the IF process. The LDCs should be able to draw from the Trust Fund to procure technical assistance from any source, including the private sector. This would not only make technical assistance truly demand-driven but will also create incentives for the agencies to tailor-make their assistance to specific country needs. The use of funds would be subject to standard rules utilised by donors for their projects as to commitments and disbursements. The technical assistance provided by the six agencies and the private sector would be subject to international competitive bidding norms. The alternative to the Trust Fund option would be that the WTO would play the role of a clearing-house for trade-related technical assistance - an option that is less likely to achieve the objectives of a revised IF.
- Monitor Trade-Related Technical Assistance Performance: As trade development activities are brought into the mainstream by including them in the overall assistance process, they will be monitored and evaluated along with the progress of other programs in the countries. This can could be done through the World Bank's Economic and Sector Work and through the WTO's Trade Policy Reviews. WTO trade policy reviews should specifically monitor and evaluate the progress achieved towards integration of LDCs into the multilateral trading system. However, these reviews should go beyond the review of consistency with trade rules to assess how well trade regimes and trade-related technical assistance are contributing to the integration of LDCs into the global trading environment.

h) <u>Enlarging the IF to Other Countries and Agencies</u>: This review recommends that the question of enlarging the IF be revisited in the future, after the new recommended arrangements are in place for about three years. At that time a review could be undertaken to see what progress had been made since 1997 to advance the objectives established for the IF.

Senior officials of the core agencies, discussed the above recommendations, together with other inputs to the review, at the IAWG meeting on 21-22 June 2000.

The heads and representatives of the Agencies met on 6 July 2001 in New York<sup>10</sup> and issued a Joint Statement<sup>11</sup> containing decisions to improve the IF, make it more effective, and enhance its implementation.

The Joint Statements contained four key decisions, as follows:

- a) First, the Agencies agreed to assist the efforts of LDCs to mainstream trade and traderelated technical assistance into national development plans and poverty reduction strategies. It was also agreed that the World Bank would be responsible for mainstreaming;
- b) Second, the decision was taken to expand the meeting of the Heads of core Agencies to include representatives of donor countries in a new governance body an IF Steering Committee which would provide policy oversight;
- c) Third, the Administrative Unit, formerly located at ITC, would be folded into the WTO, which would continue to chair the IAWG; and,
- d) Fourth, the Agencies proposed the establishment of an IF Trust Fund and contributions to it, with an initial funding objective of US\$20 million. The UNDP was assigned the responsibility for managing the proposed IF Trust Fund in cooperation with the core Agencies, on agreed terms.

Furthermore, the Agencies agreed that the Joint Statement would be presented to their respective Governing Bodies and/or Councils<sup>12</sup>.

For the rest of the year 2000, consultations continued amongst agencies, donors and LDCs, within the core agencies. The agencies were focused on building consensus on the optimal changes to be made to the Integrated Framework in order to improve its functioning. Most of the consultations took place within the framework of the formal and informal sessions of the Sub-Committee on Least-Developed Countries. However, on 1 December 2000, informal consultations took place amongst agencies, LDCs, and WTO donor members. At this meeting, there was equality of participation. These consultations were continued into the year 2001.
