FOURTH SCHEDULE

DUMPING DUTIES TARIFF

INTRODUCTORY NOTE

Any entry appearing in this Schedule under the heading "REMARKS", is included solely for the purpose of information and does not, as such, in any way extend, curtail or govern the tariff imposed or the goods subjected thereto.

PART I - INTERPRETATION

In this Schedule unless inconsistent with the context

"actual cost" means the cost of the goods to the importer expressed in the terms of the currency of Malawi, free on board at the port of shipment of place of despatch to Malawi, and, in the case of goods exported to Malawi on consignment or for which nominal charges are made, the price free on board at which similar goods are ordinarily sold for export, or, if there is no such price then the domestic market value of such goods; "domestic market value" means the market price at which, at the date of purchase thereof by the importer, such or similar goods are freely offered for sale or for consumption in the country from which the goods are exported to all purchasers in the usual wholesale quantities in the ordinary course of trade in the principal market of such country, including the cost of packages ordinarily used in those markets plus the extra cost of packages and packing for export, carriage to the place in such country at which the goods are finally loaded, ready for export, on a ship, aircraft or vehicle for despatch to Malawi and all other expenses

incidental thereto, not being abnormal costs incurred as the result of a state of war strikes, lock-outs, or civil commotion, but shall not include any drawback of duty allowed or other taxation remitted by the Government of that country on the exportation of the goods therefrom:

Provided that -

- (i) in the application of this definition to goods exported to Malawi on consignment or for which nominal prices are charged or for which no charge is made there shall be submitted the words "time of exportation to Malawi" for the words "date of purchase thereof by the importer"; and
- (ii) When goods are sold in the country from which they are exported to Malawi under such conditions that no domestic market value can be calculated or when goods exported to Malawi are not sold for consumption in the country from which they are so exported, or are sold there in or under any manner or condition considered by the Controller to be unusual or peculiar in the marketing of such goods, the Controller may

determine a value, and the value so determined shall be deemed to be the domestic market value of such goods;

"export price"	means the price free on board at which goods are sold by the exporter to the importer in Malawi;
"free on board"	means free on board any conveyance;
"on consignment"	means consigned by a supplier outside Malawi to an importer within Malawi for sale on commission, such goods being the property of, or being held in the interest of, such supplier until sold or disposed

of by the person within Malawi.

1. If, after investigation by a board or person appointed by the Minister, the Minister is satisfied, in respect of goods which are of a kind or class grown, produced or manufactured in Malawi -

- (a) that the conditions set out in any of the items in column 1 of paragraph 4 of this Part obtain or are likely to obtain;
- (b) that detriment from one or more of such conditions may result to an industry in Malawi; and
- (c) that it would be in the public interest to impose in respect of such goods a dumping duty, he may, in accordance with Section 83 (1) and 84 of the Act, by order impose a dumping duty, or vary such duty, by amendment to Part III of this Schedule.

DUMPING DUTIES TAKEN

- 2. (a) The kinds of dumping duty which may be imposed, and the rates thereof, shall be those set out in columns 2 and 3 respectively of paragraph 4 of this Part against the appropriate item in column 1 of that paragraph.
 - (b) The rate of dumping duty may be a specified percentage of the value of the goods in question or a specified rate per unit of quantity of such goods.
 - (c) A dumping duty may be imposed to apply generally or may be limited in application to those goods:
 - (i) imported from or grown, produced or manufactured in a particular country; or
 - (ii) imported into Malawi or exported or conveyed to Malawi or grown, produced, manufactured, sold or disposed of by a particular person.

3. Whenever a freight dumping duty is imposed in respect of any goods the Minister may for that purpose determine and specify the minimum rate of freight charges which shall be applicable to that class or kind of goods when conveyed from any particular country or place to any place of discharge in Malawi or to any place in Africa at which goods are discharged from removal overland into Malawi.

Provided that the minimum rate of freight charges so determined shall in no case exceed the normal freight as certified in terms of column 3 of item 4 in paragraph 4 of this Part.

Dumping duties of the kind and at the rate specified in column 3 of the table set out hereunder, shall, subject to any limit specified in column 4, be charged, levied, collected and paid on the goods specified in column 2, and imported into Malawi.
