REQUEST BY EL SALVADOR FOR A WAIVER UNDER ARTICLE IX OF THE WTO AGREEMENT FOR MINIMUM VALUES UNDER THE AGREEMENT ON IMPLEMENTATION OF ARTICLE VII OF THE GATT 1994

The following communication, dated 29 April 2002, has been received from the Permanent Mission of El Salvador.

The Permanent Mission of El Salvador to the World Trade Organization presents its compliments to the Market Access Division and has the honour to provide information concerning its request under Article IX, paragraphs 3 and 4, of the Marrakesh Agreement to apply minimum prices to the list of products annexed hereto.

After enormous efforts to reform and modernise its customs procedures, El Salvador began to apply the Agreement on Customs Valuation on 8 March 2002, the date on which the further extension approved by the Council for Trade in Goods, but not yet adopted by the General Council, expired. Although El Salvador is currently applying the Agreement, the responsible authorities face a series of difficulties, including problems of under-invoicing and under-valuation.

Consequently, and taking into account the guiding principles to be followed in considering applications for waivers, adopted on 1 November 1956, and pursuant to Annex III, paragraph 2, of the Agreement on Implementation of Article VII of the GATT, El Salvador wishes to apply minimum prices to the detailed list of products annexed hereto as from the implementation date of the Agreement and for the periods indicated in this annex.
