

**AGREEMENT ON IMPORT LICENSING PROCEDURES**

Notification under Articles 1.4(a) And 8.2(b)

**HUNGARY**

In a communication dated 7 March 2000, the Permanent Mission of Hungary has submitted copies of the following regulations relevant to the Agreement on Import Licensing Procedures which have been published in the Hungarian Official Gazette (Magyar Közlöny) in the years 1998, 1999 and 2000:<sup>1</sup>

- (a) Decree No. 81/1999 (XII.29) of the Minister of Economics modifying Decree No. 6/1990 (XII.29) of the Minister of Economic Relations on the enforcement of Decree No. 112/1990 (XII.23) of the Government on Exports and Imports of Goods, Services and Rights Representing Material Value.
- (b) Decree No. 221/1997 (XII.8) of the Government on Exports and Imports of Goods, Services and Rights Representing Material Value, as amended.
- (c) Decree Nos. 64/1997 (XII.8) and 32/1998 (V.22) of the Minister of Industry, Trade and Tourism on Publishing the Global Import Quota of Consumer Goods for the First and Second Half Years of 1998. The Global Quota is announced in two equal parts at the beginning of the first and the second half year as per the above Decrees.
- (d) Decree No. 205/1998 (XII.23) of the Government on Exports and Imports of Goods, Services and Rights Representing Material Value.
- (e) Decree Nos. 29/1998 (XII.23) and 26/1999 (V.28) of the Minister of Economics on Publishing the Global Import Quota of Consumer Goods for the First and Second Half Years of 1999. The Global Quota is announced in two equal parts at the beginning of the first and the second half year as per the above Decrees.
- (f) Decree No. 223/1999 (XII.29) of the Government on Exports and Imports of Goods, Services and Rights Representing Material Value.
- (g) Decree No.68/1999 (XII.15) of the Minister of Economics on Publishing the Global Import Quota of Consumer Goods for the First Half Year of 2000. The Global Quota is announced in two equal parts at the beginning of the first and the second half year as per the above Decree.
