#### AGREEMENT ON IMPORT LICENSING PROCEDURES

Notification under Article 5

## JAMAICA

The following communication, dated 23 September 2003, has been received from the Permanent Mission of Jamaica.

Pursuant to Article 5 of the Agreement on Import Licensing Procedures, Jamaica wishes to notify the following amendments to its List of Items Requiring Import Licences.

#### Additions to the List:

The implementation of a licensing system for the importation of front and back clips for motor vehicles.

#### Removal from the List:

Removal of licensing requirement to import video games of a kind used with a television receiver.
