

**AGREEMENT ON IMPORT LICENSING PROCEDURES**

Notification under Article 5.1-5.4 of the Agreement<sup>1</sup>

MOROCCO

The following notification, dated 28 November 2011, is being circulated at the request of the delegation of Morocco.
