AGREEMENT ON IMPORT LICENSING PROCEDURES

NOTIFICATION UNDER ARTICLE 5

Romania

The following communication, dated 3 October 1995, has been received from the Permanent Mission of Romania.

By Order No. 47 of 18 September 1995 of the Minister of Commerce, automatic licences have been introduced, for statistical purposes, for the import and export of oil and oil products. The full text of the Order¹ is attached.

ORDER 47/18.09.1995

on establishing of automatic licenses for statistical purpose
on the import and export of oil and oil products

Based on Government Decision no. 454/1994 on the organization and functioning of the Ministry of Commerce and the provisions of Law 133/1994, the Minister of Commerce issues the following Order:

Art. 1. Beginning with 1 October 1995 the import of all oil and oil products, listed in Annex 1, are subject to automatic licensing, for statistical purpose.

Art. 2. Beginning with 20 September 1995 the export of oil and oil products, listed in Annex 1, are subject to automatic licensing, for statistical purpose.

Art. 3. The licenses are issued by the Ministry of Commerce; they are to be previously registered at the Ministry of Industries, as far as origin and destination for imports are concerned and as to the source of the goods for exports.

Art. 4. The number of import or export license will be mentioned on the import or export customs declarations covering tariff lines at eight digits level.

Art. 5. This Order is made public to the Ministry of Finance - General Directorate of Customs, Ministry of Industries and National Bank of Romania and to the economic operators, by means of mass-media and by other forms of dissemination.
