

AGREEMENT ON IMPORT LICENSING PROCEDURES

Notification under Article 5.1

UKRAINE

The following communication, dated 10 May 2011, has been received from the Permanent Mission of Ukraine.

(a) List of products subject to licensing procedures:

Meat and edible offal of poultry under heading 0105, fresh, chilled or frozen (UKTZED¹ 0207);

Fat free lean parts, pork fat and poultry fat, not flushed and not singled out in any other way, fresh or chilled, frozen, salted or in brine, dried or smoked (UKTZED 0209 00);

Insecticides (except veterinary medicines), fungicides, herbicides, means of prevention sprouting and growth regulators, rodenticides (except veterinary medicines) and other similar means (except disinfection) (UKTZED 3808 50 00 00*, 3808 91*, 3808 92*, 3808 93*, 3808 99*).

* with an exception of some consignments, which are imported free of charge with the permission of the Ministry of Ecology and Natural Resources solely for state testing and research.

(e) Indication of whether the licensing procedure is automatic or non-automatic according to definitions contained in Articles 2 and 3:

Licensing procedure is non-automatic.

(f) In the case of automatic import licensing procedures, their administrative purpose:

Not applicable.

(g) In the case of non-automatic import licensing procedures, indication of the measure being implemented through the licensing procedures

Licenses are issued by the Ministry of Economic Development and Trade on the approval of the Ministry of Agrarian Policy and Food of Ukraine. The approval should be received by the applicants before applying for license.

Some consignments, which are imported free of charge solely for state testing and research, require the permission of the Ministry of Ecology and Natural Resources (see item (a) for details).

The Procedure for issuing licenses to import of products mentioned in item (a) is specified in the Order of the Ministry of Economy of 14.09.2007 # 302 "On approval of the regulatory – legal acts concerning licensing of imports of goods and amendments to the Procedure for the processing of applications for issuance of licenses in the sphere of non-tariff regulation of

foreign economic activities in the Ministry of Economy of Ukraine" (mentioned in document G/LIC/N/3/UKR/3 of 10 December 2010).

- (h) Expected duration of the licensing procedure if this can be estimated with some probability, and if not, reason why this information cannot be provided:

Licensing of import of goods under the codes 0207 and 0209 00 come into force from 1 July 2011.

Licensing of import of goods under the codes 3808 50 00 00, 3808 91, 3808 92, 3808 93, 3808 99 is in force from the date of publication of the Resolution of the Cabinet of Ministers of Ukraine № 420, namely from 22 April 2011.

The duration of import licensing - till 31 December 2011.
