REPLIES TO QUESTIONNAIRE ON IMPORT LICENSING PROCEDURES

NOTIFICATION UNDER ARTICLE 7.3 OF THE AGREEMENT ON IMPORT LICENSING PROCEDURES

BARBADOS

The following notification, dated 15 September 1995, has been received from the Permanent Mission of Barbados.

Outline of System

1. The Miscellaneous Controls Act Chapter 329¹ of the laws of Barbados is employed by the Government of Barbados to regulate the importation of goods which are subject to the licensing regime.

Purposes and Coverage of Licensing

- 2. Miscellaneous Controls (General Open Import Licence) Regulations products as listed at Annex I.
- 3. The system applies to goods originating outside Caricom (First Schedule of Annex I) and goods originating within Caricom (Third Schedule of Annex I).
- 4. It is intended that the licensing system would restrict the quantity of imports of what are considered to be sensitive goods.
- 5. The Miscellaneous Controls Act Chapter 329 is the Law under which the licensing is maintained and licensing is therefore statutorily required. The legislation does not specify that products should be subjected to administrative discretion; however, from time to time discretion has been used. To abolish the system approval must be had from the legislature.

Procedures

6.	I.	There is no publication of information concerning the allocation of quotas, neither are
there	publication	ons with respect to the filing of applications for licences.

It is the importer who approaches the Government requesting permission to import the product(s). The domestic importer then approaches the country or their trade representatives from where the good is sourced.

There is no publication of the overall amount, neither is the amount allocated to goods from each country. Importers are notified individually of allocations.

- II. Depending on the item, quotas may be determined quarterly, six-monthly or annually. Importers can apply at any time until quotas are exhausted.
- III. The system is an open one and no preference is given to the domestic producers of like goods. It is not binding on the importer to bring in any good for which a licence has been issued.
- IV. When importers are granted quotas, applications may be submitted at any time within the period allowed for importation.
- V. Applications are processed within three working days provided that all necessary information is submitted.
- VI. A licence is issued with the understanding that importation will begin immediately.
- VII. Depending on the item to be imported, e.g. meat or meat products, the importer may have to approach more than one Government agency.
- VIII. The allocation of licences within the quota system varies. In the case of the importation of certain species of fish, for example flying fish and associated pelagics, only the "Miscellaneous Importers" are allocated licences on a first-come-first-served basis and past performance may be taken into account. Fish processors are allocated licences according to their participation in the local fishing industry. Apart from quotas for fish, quotas are usually allocated on past performance. With respect to new importers, consideration may be given depending on the overall size of the quota. All applications are examined on receipt.
- IX. There is no bilateral quota arrangement.
- X. Not applicable.
- XI. Yes.
- 7. (a) Importers are advised that import licences should be obtained before the goods are imported. Licences can be granted within a shorter time-limit and applications for goods which arrive owing to inadvertency may be facilitated depending on the particular circumstances.
- (b) A licence can be granted immediately on request.
- (c) Applicants are free to request import licences any time of the year. However, in the case of certain species of fish, licences are only issued to allow for the importation of fish during that time of the year known as the "window period", August to November.
- (d) See 6. VII.
- 8. Any applicant who has qualified for an import licence will automatically be granted the licence. Should an applicant be denied the licence the reason(s) is/are given to him. An applicant has the right

to appeal in the event he is denied a licence. Those who have been denied a licence may appeal to the same body. They may make their complaint direct to the Chief Price Control Officer, Permanent Secretary or the Minister.

Eligibility of Importers to Apply for Licence

9. All firms, persons and institutions are eligible to apply for licences under the restrictive and non-restrictive system.

Documentational and Other Requirements for Application for Licence

- 10. Applicants are required to state their personal or business name; address; the country from which the good is sourced and the country from which it is being consigned; the expected date and time of arrival; the relevant tariff heading; the description of goods and quantity and the quoted c.i.f. value in Barbados dollars. No other document is required.
- 11. For goods from Caricom countries, a certificate of origin is required as well as the commercial invoice. Goods from non-Caricom sources require only the commercial invoice.
- 12. There is no licensing fee or administrative charge.
- 13. There is no deposit or advance payment requirement.

Conditions of Licensing

- 14. A licence is valid for up to three months. The validity of a licence can be extended by renewal.
- 15. There is no penalty for the non-utilization of a licence or a portion thereof.
- 16. Licences are not transferable.
- 17. Specific conditions attached to the issuance of an import licence for products subject to quantitative restrictions, and those that are not subject to quantitative restrictions, may apply from time to time.

Other Procedural Requirements

- 18. There are no other administrative procedures apart from import licensing and similar administrative practices that are required prior to importation.
- 19. There are no hindrances to obtaining foreign exchange provided by the banking authorities for goods to be imported. Licences are not required to obtain foreign exchange and foreign currency is readily available to cover licences issued and for goods that are not subject to the import licensing system.

MISCELLANEOUS CONTROLS (GENERAL OPEN IMPORT LICENCE) REGULATIONS, 1994

The Minister in exercise of the powers conferred on him by section 3(1) of the Miscellaneous Controls Act, makes the following regulations:

- 1. These regulations may be cited as the Miscellaneous Controls (General Open Import Licence) Regulations, 1994.
- 2. (1) No person shall, except in accordance with the terms of a licence granted under section 10 of the Act, First import any goods set out in the First Schedule from any Schedule country other than a country listed in the Second Schedule Second being a country specified in section 6(1) of the Caribbean Schedule Community Act.

Cap. 15

Notwithstanding paragraph (1), no person shall, except in accordance with the terms of a licence granted under section 10 of the Act, import any goods set out in the Third Schedule from any country specified in the Second Third Schedule.

Schedule Second Schedule

Any person who contravenes or fails to comply with any of the provisions of these regulations is guilty of an offence and is liable on summary conviction to a fine of \$100 000 or to imprisonment for a term of 2 years or to both such fine and imprisonment.
