REPORT (1999) OF THE COMMITTEE ON IMPORT LICENSING

- 1. The Agreement on Import Licensing Procedures (the Agreement) establishes disciplines on users of import licensing systems with the principal objective of ensuring that the procedures applied for granting import licences do not in themselves restrict trade. It aims to simplify, clarify and minimize the administrative requirements necessary to obtain import licences.
- 2. The Committee on Import Licensing (the Committee) was established to afford Members the opportunity of consulting on any matters relating to the operation of the Agreement or the furtherance of its objectives.
- 3. All Members of the WTO are *ipso facto* members of the Committee. Observer governments in the General Council of the WTO have observer status in the Committee. In addition, representatives of the IMF, UNCTAD and the World Bank attend meetings of the Committee in an observer capacity.
- 4. The Committee held two meetings on 29 April and 21 October 1999 (G/LIC/M/9 and 10). The Committee at its meeting in April 1999 re-elected Mrs. Marie Gosset (Côte d'Ivoire) as Chairperson and elected Mr. Lars Andersen (Norway) as Vice-Chairperson for 1999. Pursuant to the Committee's Rules of Procedure, they took office at the end of that meeting.
- 5. Pursuant to Articles 1.4(a) and/or 8.2(b) of the Agreement, all Members are required to notify their laws, regulations and administrative procedures relevant to import licensing. During the period covered by this report, the Committee received notifications from the following seven Members: European Communities, Hungary, India, Latvia, Romania, Tunisia and Turkey. Since the entry into force of the WTO Agreement, 59 Members (the European Communities and its member States counted as one) have notified their legislation and/or publications under these provisions. These notifications may be found in document series G/LIC/N/1/-.
- 6. Article 7.3 of the Agreement requires all Members to provide replies to the Questionnaire on Import Licensing Procedures¹ by 30 September each year. Since the entry into force of the WTO Agreement, 59 Members (the European Communities and its member States counted as one) have made notifications under this provision. This includes replies to the Questionnaire from 11 Members in 1995, 22 Members in 1996, 25 Members in 1997, 25 Members in 1998 and 15 Members in 1999. During the period covered by this report, the Committee received notifications from Canada, Chile, European Communities, Ghana, India, Latvia, Malawi, Malta, Morocco, Namibia, Panama, Romania, Tunisia, Turkey and Uruguay. These notifications may be found in document series G/LIC/N/3/-.
- 7. The Committee also received pursuant to Article 5 of the Agreement notifications relating to the institution of new import licensing procedures or changes in these procedures from Argentina, India, Malaysia and Romania. These notifications may be found in document series G/LIC/N/2/-.

- 8. At its meeting on 29 April 1999, the Committee heard concerns expressed by several Members regarding the compatibility with the Agreement of certain modifications introduced by Brazil in August 1998 to its non-automatic import licensing system which had yet to be notified to the Committee (G/LIC/M/9).
- 9. The Committee also took note of the response of the Chairperson to the Chairman of the Council for Trade in Goods summarizing the discussion held in the Committee, at informal and formal level, on the subject of trade facilitation (G/LIC/M/9 and G/C/W/149, paragraph 7).
- 10. The Committee has provided a regular forum for the discussion of specific notifications submitted by Members and of concerns regarding notifications. It should be noted that the mandatory notification requirements under Articles 1.4(a), 8.2(b) and 7.3 are complied with by only about 55 per cent of the WTO Members. The Annex reflects the current status of notifications. In light of this situation, the Chairperson, recognizing the importance of notifications for the effective implementation and functioning of the Agreement, urged Members to fulfil their notification obligations.
