**REPORT (2011) OF THE COMMITTEE ON IMPORT LICENSING
TO THE COUNCIL FOR TRADE IN GOODS**

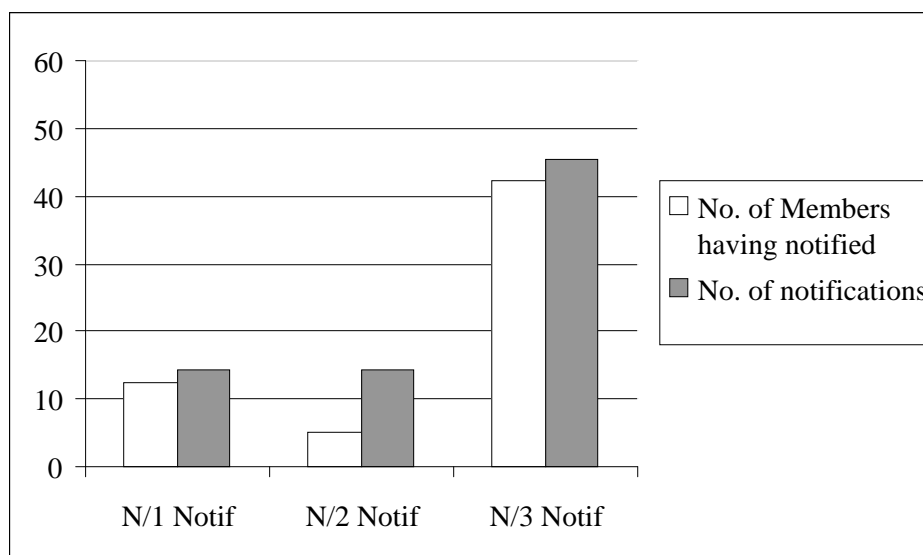
1. The Agreement on Import Licensing Procedures (hereinafter "the Agreement") which entered into force on 1 January 1995, establishes disciplines on users of import licensing systems with the principal objective of ensuring that the procedures applied for granting import licences do not in themselves restrict trade. It aims to simplify, clarify and minimize the administrative requirements necessary to obtain import licences.
2. The Committee on Import Licensing was established to afford Members the opportunity of consulting on any matters relating to the operation of the Agreement or the furtherance of its objectives. The Committee's Rules of Procedure, which were approved by the Council for Trade in Goods, are contained in document G/L/147.
3. All Members of the WTO are *ipso facto* members of the Committee. Observer governments in the General Council of the WTO have Observer status in the Committee. The International Monetary Fund, the World Bank and UNCTAD have regular Observer status in the Committee.
4. The focus of this report is on the period since the Committee's last annual report (G/L/941), i.e. 30 October 2010 - 14 October 2011 (hereinafter "the review period"). During the review period, the Committee held two meetings on 11 April and 14 October 2011 (G/LIC/M/33 and [G/LIC/M/34]). At its meeting on 11 April 2011, the Committee took note of the nomination of Mr. Flavio Soares Damico (Brazil) as Chairperson of the Committee for the current year and elected him by acclamation. At that meeting, the Committee elected as Vice-Chairperson for the current year, Mr. Gustavo Bosio (Israel). Pursuant to Committee's Rules of Procedure, they took office at the end of that meeting.
5. Pursuant to Articles 1.4(a) and/or 8.2(b) of the Agreement and procedures agreed by the Committee, all Members are required to notify their laws, regulations and administrative procedures relevant to import licensing and submit copies of any relevant publications or laws and regulations upon becoming a WTO Member. Any subsequent changes to these laws, regulations and administrative procedures are also required to be notified. Since the entry into force of the WTO Agreement, [100] (up to 30.09.11) Members¹ have notified the Committee of their legislation and/or publications under these provisions. During the review period, the Committee received [13] notifications from the following [12] Members: [Angola, Argentina, Former Yugoslav Republic of Macedonia, India, Kuwait, Lesotho, Malaysia, Morocco, Togo, Tonga, Turkey, and the United States: updated 30.09.2011]. Copies of publications and legislation submitted with these notifications are available for consultation in the Secretariat.

6. The Committee also received, pursuant to paragraphs 5.1-5.4 of Article 5, [14] notifications relating to the institution of new import licensing procedures or changes in these procedures from [6] Members: [Argentina, India, Jamaica, Paraguay, Thailand, and Ukraine: updated 30.09.2011] (see Figure 1). These notifications may be found in document series G/LIC/N/2/-. Since the entry into force of the WTO Agreement [36] Members have submitted notifications under these provisions. Article 5.5 of the Agreement allows Members to submit reverse notifications, where a Member considers that another Member has not notified the institution of a licensing procedure or changes in the procedures. However, no such reverse notifications have been received under this provision since the entry into force of the Agreement.

7. Article 7.3 of the Agreement requires all Members to provide replies to the Questionnaire on Import Licensing Procedures² by 30 September each year. Since the entry into force of the WTO Agreement, [102] Members have made notifications under this provision. This includes replies to the Questionnaire from 11 Members in 1995, 22 Members in 1996, 25 Members in 1997, 26 Members in 1998, 20 Members in 1999, 32 Members in 2000, 23 Members in 2001, 41 Members in 2002, 25 Members in 2003, 21 Members in 2004, 19 Members in 2005, 46 Members in 2006; 37 Members in 2007, 31 Members in 2008, 42 Members in 2009, 34 Members in 2010 and [35] Members up in 2011 (UPDATED 30.09.11). During the review period, the Committee received [44] notifications from the following [41] Members: [Albania, Argentina, Australia, Brazil, Burkina Faso, Cambodia, Cape Verde, Central African Republic, Chile, China, Croatia, Dominican Republic, European Union, Former Yugoslav Republic of Macedonia, Gambia, Honduras, Hong Kong China, India, Japan, Kingdom of Saudi Arabia, Korea, Kuwait, Lesotho, Macao China, Madagascar, Malaysia, Nicaragua, Norway, Peru, the Phillipines Qatar, Senegal, Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu, Switzerland, Thailand, Togo, Tonga, Tunisia, Turkey, Ukraine, United States and Viet Nam updated 30.09.2011] (see Figure 1). 8. Written replies to comments and questions from Members concerning the notifications submitted to the Committee and/or on import licensing procedures maintained by Members, and replies thereto, may be found in document series G/LIC/Q/-³. During the review period, the United States posed written questions to Indonesia on its Decree 56/2008 (document G/LIC/Q/IDN/17) and Turkey to India on import licensing procedures applied to marble and similar stones (G/LIC/Q/IND/17). The following Members provided responses to comments and questions: Argentina to questions from Turkey in document G/LIC/Q/ARG/10; India to questions from the United States in document G/LIC/Q/IND/11/Add.2 and, Indonesia to questions from the European Union in document G/LIC/Q/IDN/15.

9. The Committee has provided a regular forum for the discussion of specific notifications submitted by Members. Members' compliance with the transparency obligations of the Agreement has been the main preoccupation of the Committee for some time now. Informal meetings have taken place, preceded by informal consultations with various delegations from a large geographical range. During this process, delegations who have attended the informal consultations as well as those who have intervened at the informal Committee meetings have unanimously highlighted the importance of improving compliance with notification obligations. As a result of two years of informal discussions, two notification forms under Articles 1.4a) and/or 8.2b) and under Article 5 of the Agreement, were submitted by the Chair for the Committee's consideration. At the 11 April 2011 meeting, in light of the wide support for the use of the forms, on a voluntary basis, the Committee agreed that these forms be circulated in the G/LIC document series and posted on the Members website (document G/LIC/22). Since then, many Members have started to use these forms as well as a short statement form to indicate that the already notified import licensing regimes under Article 7.3 remain valid. As evident in the Annex to this report, there have been improvements in the level of compliance with the mandatory notification requirements, particularly under Articles 1.4(a), 8.2(b) and 7.3.

10. During the review period, ten Members had submitted, for the first time, notifications to the Committee under various Articles of the Agreement: under Articles 1.4a) Angola, Lesotho, Malaysia and Tonga; under Article 5 Cambodia, Central African Republic, Tonga and Viet Nam; and, under Article 7.3 Paraguay and Ukraine. The Chair thanked these Members for their notifications and urged Members who had not yet notified and had not updated their notifications or provided clarifications sought by other Members to do so as soon as possible.

11. At its meeting of 14 October 2011, the Committee conducted the Final Transitional Review under Paragraph 18 of the Protocol on Accession of the People's Republic of China. []
