# IMPLEMENTATION AND ADMINISTRATION OF THE AGREEMENT ON TECHNICAL BARRIERS TO TRADE

Communication from Mongolia

#### Revision

The following statement under Article 15.2 of the Agreement on Technical Barriers to Trade has been received from <u>Mongolia</u>.

#### I. RELEVANT LAWS AND REGULATION

- 1. The procedure of implementation and administration of the WTO/TBT Agreement is supported by the following legislative acts:
- A. LAW ON 'STANDARDIZATION AND CONFORMITY ASSESSMENT' (2003)
- 2. The law on "Standardization and Conformity Assessment" (Periodical "State Information" 2003) defines legal grounds for standardization and conformity assessment and to regulates relations between the government, citizens, business entities and organizations occurred in the implementation process thereof.
- B. THE GOVERNMENT DECREE NO.127 ON "MEASURES FOR ENHANCING STANDARDIZATION AND CONFORMITY ASSESSMENT ACTIVITIES" (2005)
- 3. This decree establishes a list of products and services that may be harmful to public interests, health and safety of humans, the environment and national security that shall be certified on a mandatory basis.
