- **6. Description of content:** This Resolution establishes that the labels/stickers of preparations containing ethyl alchol which are sold over the counter or on prescription in liquid pharmaceutical form and are intended for oral or parenteral administration, must indicate the ethyl alcohol content as a percentage by weight/volume.
- 7. Objective and rationale, including the nature of urgent problems where applicable: This new Resolution repeals ANMAT Resolution No. 3429/00 and extends to situations that were not previously provided for:
 - (1) Alcoholatures, tinctures, liquid extracts containing alcohol to enhance the dissolution of the active principle(s) and which are administered prior to dilution; 2) real possibility of ingesting a mouthwash/spray and related risks.
 - (2) Medicinal preparations containing a quantity of ethyl alcohol that would cause blood alcohol concentrations of greater than 20 mg/dl should not be authorized for paediatric use.
