 - P1: Safety aspects related to mechanical and physical properties (95 pages, English);
 - P2: Flammability (20 pages, English);
 - P3: Migration of certain element (19 pages, English).
- **Description of content:** The toys must meet the safety aspects related to mechanical and physical properties, flammability and migration of certain elements.

Part 1 specifies requirements and test methods for the mechanical and physical properties of toys;

Part 2 covers the flammable materials which are prohibited in all toys and the requirements concerning flammability of certain toys when exposed to fire;

Part 3 specifies requirements and test methods for the migration of the elements antimony, arsenic, barium, cadmium, chromium, lead, mercury and selenium from toy materials and from parts of toys.

These standards are mandatory and comply with EN. These standards are mandatory and comply with EN 71-1, 2, 3.
