Addendum

The following communication, dated 21 April 2005, is being circulated at the request of the delegation of the United Arab Emirates.

Elimination of low tariffs

As exposed in our previous communication of 20 May 2003 (ref.TN/MA/W/37) and of 28 May 2004 (ref. TN/MA/W/37/Add.1), the United Arab Emirates is highly interested in the concept of elimination of low tariffs and would like to underline again the importance it attaches to a definition for low tariffs at a rate not under 6%.

Zero for zero sectoral proposal on raw materials

Following our communication of 20 May 2003 (ref.TN/MA/W/37) and of 28 May 2004 (ref. TN/MA/W/37/Add.1), and the various plurilateral and bilateral meetings which took place in the course of the last months to discuss both the Sectoral Approach and the liberalization of raw materials; the United Arab Emirates presents below a preliminary list of raw materials as a basis for further discussion, and invites all interested parties to make their comments and suggestions in order to progress on these discussions which are important for a comprehensive and balanced achievement of the Doha Round.
