I. INTRODUCTION

1. This note summarizes the implementation of technical assistance in 2002, as requested by Members at the last meeting of the Committee on Trade and Development (November 2002).

2. At its thirty-ninth session on 6 March 2002 the Committee on Trade and Development agreed that the Secretariat proceed with the implementation of the Coordinated WTO Secretariat Technical Assistance Plan 2002 (WT/COMTD/W/95/Rev.3), while the Committee kept it under review (par. 55 of WT/COMTD/M/39). To this end, the Secretariat presented regular status reports on the implementation, circulated as WT/COMTD/W/101 and related addenda.

3. At its forty-third session (November 2002), the Secretariat informed Members that 122 activities provided for in the TA Plan had to be cancelled for a variety of reasons, e.g. (i) cancellation by recipient countries; (ii) problems in joint delivery with other Agencies (in particular, IF and mainstreaming); (iii) not enough progress to justify the execution of the planned activity (accessions, negotiating groups, trade negotiation skills); (iv) civil unrest/insecurity; (v) opportunity cost of implementing necessary and urgent ad hoc activities (displacement effect caused by ad hoc activities); (vi) Secretariat's causes, including delayed L-post recruitment. After deducting these activities and the 9 entries in the 2002 TA Plan related to the development of tools for technical assistance, the total number of activities inscribed in the 2002 TA Plan was 383, of which 209 were national and 174 regional.

4. *Implementation of the 2002 TA Plan.* In 2002, a total of 481 activities were undertaken, of which 347 planned activities. In addition, in early 2003 seven activities will be implemented as roll-overs of the 2002 TA Plan. Overall, 354 planned activities will have been implemented, i.e. 92 per cent of the revised 2002 TA Plan. Annex I lists all TA activities relating to 2002 undertaken in 2002 and early 2003. The listing follows the same structure as the Plan. For each subject matter, it lists planned as well as ad hoc activities. The dates column contains for each activity the corresponding start and end dates.

5. Table I below presents the breakdown of the activities executed in 2002 (both planned and ad hoc) and in early months of 2003 as roll-overs, by region, while table II contains the breakdown according to the subject matters of the Plan. This shows an execution rate of 90% of all planned national activities and in the case of regional activities, 95%.

6. *Ad hoc activities.* A total of 134 ad hoc activities were carried out in 2002, which in terms of number of activities undertaken represent 27% of the 488 activities undertaken in relation to 2002. It should be noted that in terms of cost, they would represent less than half that percentage since in most instances the only costs incurred for ad hoc activities are those related to the participation of staff.

7. *Monitoring and evaluation.* The Technical Cooperation Audit Unit of the Secretariat is in the process of preparing a full report on WTO technical cooperation activities carried out in 2002 that will be circulated to Members before the end of March 2003.

8. In this context, it is also worth mentioning that in relation to the commitments on technical cooperation and capacity building contained in the Doha Ministerial Declaration, the Director-General has circulated to Members an interim report (WT/GC/W/484), in accordance with the mandate in paragraph 41 of the Declaration, and will forward a final report to Ministers at the 5th Ministerial Conference.
