# TRADE-RELATED TECHNICAL ASSISTANCE (TRTA) AND CAPACITY BUILDING IN THE FIELD OF TRADE AND ENVIRONMENT

Submission by the European Communities under Paragraph 33

#### I. INTRODUCTION

- 1. Paragraph 33 of the Doha Development Agenda stresses the importance of technical assistance and capacity building in the field of trade and environment to developing countries, in particular the least-developed among them.
- 2. The World Summit on Sustainable Development (WSSD) Plan of Implementation, adopted in Johannesburg, also refers to the need to strengthen and improve technical assistance and capacity building for sustainable development, both at national and international levels. Discussions in the Committee on Trade and Environment but also in workshops organized by UNEP, UNCTAD and OECD have demonstrated the interest of many WTO Members for this issue.

#### II. ROLE OF TRTA IN TRADE AND ENVIRONMENT

- 3. The European Communities (EC) fully acknowledges the need for Trade and Environment technical assistance as being critical for developing countries to meet the challenge of sustainable development. Such an assistance should in particular help developing countries reap the benefits of further trade liberalisation and of new market opportunities while moving towards sustainable development, also at national level. This should accompany the DDA negotiating process so as to ensure that developing countries participate in such negotiations and prepare themselves to embrace the results achieved with regard to sustainability.
- 4. The EC has continuously highlighted the role of technical assistance in the CTE. Recently in its submission on labelling for environmental purposes (WT/CTE/W/225) and its corresponding proposal (JOB(03)/130), the EC has proposed that the CTE Regular Session shall before the end of 2004 hold, in addition to its usual schedule of meetings to be agreed, [three] "dedicated sessions" that shall pay particular attention, *inter alia*, to "the role of technical assistance to developing countries in designing eco-labelling schemes and in participating in the international standardisation process; technical assistance should also focus on the difficulties faced by developing countries when applying for eco-labels in export markets".
- 5. The EC has also called other WTO Members to support the Sustainable Trade and Innovation Centre (STIC), which is a Type 2 initiative designed to help developing country producers integrate environmental factors into their export strategy and to facilitate dialogue on voluntary codes between developing country producers and developed countries.

6. With a view to expanding the discussions beyond the field of labelling for environmental purposes, the EC hereby submits an illustrative list of its trade-related technical assistance and capacity building programmes in the annex.

#### III. HOW TO READ THE SUBMITTED LIST

- 7. The purpose of this list is not for the EC to present a total budget for its TRTA activities in the field of trade and environment that would encompass the entire budget of all the programmes listed.
- 8. Indeed, many programmes include a trade and environment component which is only a part of a wider technical assistance programme: the budgets indicated in the list are the total budgets of each programme and not their specific trade and environment component. Thus, in order to avoid counting twice the same amount, the projects listed which have only a component which relates to trade and environment will not be registered in the WTO Doha Database under the Trade and Environment heading.
- 9. For the same reason, the time period covered by the programmes is less strictly defined than the one used for the WTO Doha Database: all activities are on-going, just completed or decided and planned to start in the near future.
- 10. Nevertheless, a description that would be limited to programmes exclusively dedicated to trade and environment would not fully reflect the efforts of the EC to mainstream the trade and environment dimension throughout its TRTA activities, even in programmes that are not specifically designed for trade and environment purposes.
- 11. Moreover, the aim of this list is to stimulate discussion on the basis of concrete TRTA activities. For this purpose, even limited trade and environment components of wider TRTA programmes can be relevant for a specific country or a specific activity.
- 12. Finally, this list covers a broad range of trade related activities, but collecting data on TRTA is a complex exercise: the list is therefore not exhaustive. The EC wishes to reserve the possibility to update and complement it.

#### IV. HOW MAKE USE OF IT

- 13. Even if the list of activities in the annex is not exhaustive, it has been established keeping in mind some of the principles that the EC considers as particularly important in the design of TRTA in the field of trade and environment:
  - to make the process country driven: Sustainability Impact Assessments and UNEP's Integrated assessments are valuable tools that can help developing countries better identify linkages between trade, environment and development and, on the basis of their respective situation and needs, develop adequate tools to be put in place at the national level and better identify a possible need for external support;
  - to assist developing countries' trade negotiators;
  - to look for synergies between trade, environment and development: many projects tend at the same time to improve the environmental situation and to help developing countries reap the benefits of trade liberalization;

- to enhance coherence among donors: for example, the European Commission has provided support to the Capacity Building Task Force, a joint effort between UNEP and UNCTAD.
- 14. The aim of the submission of the attached list is to assist the Secretariat in complementing its report under paragraph 33 of the Doha Development Agenda, but also to enhance better co-ordination between trade, environment and development policies and officials in donor and beneficiary countries.
- 15. In the EC, the selection of these programmes is the result of a decision process involving trade, environment and development services. In countries benefiting from development assistance, the same kind of co-ordination is necessary when it comes to prioritising domestic needs and to designing efficient programmes. The EC would welcome this list being forwarded to capitals to further stimulate discussions between trade, environment and development experts of donors and beneficiary countries. This discussion will help further improve the design of EC development assistance programmes, and should be of interest for other technical assistance providers.
