II. FRAMEWORK FOR MAKING AND ENFORCING POLICIES

1. Structure and Powers of the Government/Authority of Sub-Central Governments/Uniform Administration (to be notified to the General Council)

- (a) Revision or enactment of domestic laws, regulations and other measures related to China's commitments under the WTO Agreement and Protocol, including those of local governments at the sub-national level, that have been promulgated since accession or the previous meeting of the relevant body under the Transitional Review Mechanism

Since last transitional review, China has enacted or revised the following laws and administrative regulations which may be related to its WTO commitments:

1. *Frontier Health and Quarantine Law of the People's Republic of China (revised)* (Revised and put into effect as of 29 December 2007)
2. *Regulations on the Implementation of the Income Tax Law of the People's Republic of China* (Promulgated on 6 December 2007 and put into effect as of 1 January 2008)
3. *Regulations on the Risk Disposal of Securities Companies* (Promulgated on 23 April 2008 and became effective on 23 April 2008)
4. *Regulations on Supervision and Administration of Securities Companies* (Promulgated on 23 April 2008 and became effective as of 1 June 2008)
5. *Regulations Governing Commercial Performances (revised)* (Promulgated on 7 July 2005, revised and put into effect on 22 July 2008)
6. *Regulations on Contracting Foreign Projects* (Promulgated on 21 July 2008 and put into effect as of 1 September 2008)
7. *Provisions of the State Council on the Standard for Declaration of Concentration of the Business Operators* (Promulgated on 3 August 2008 and put into effect as of 3 August 2008)
8. *Regulations on Management of Foreign Exchanges (revised)* (Promulgated on 29 January 1996, revised on and put into effect as of 5 August 2008)
9. *Provisions on Administration of Foreign-Funded Telecommunications Enterprises (revised)* (Promulgated on 11 December 2001, revised on and put into effect as of 10 September 2008)
10. *Provisional Regulations on Value-added Tax of the People's Republic of China (revised)* (Promulgated on 13 December 1993, revised on 10 November 2008 and to be put into effect as of 1 January 2009)
11. *Provisional Regulations on Business Tax of the People's Republic of China (revised)* (Promulgated on 13 December 1993, revised on 10 November 2008 and to be put into effect as of 1 January 2009)
12. *Provisional Regulations on Consumption Tax of the People's Republic of China (revised)* (Promulgated on 13 December 1993, revised on 10 November 2008 and to be put into effect as of January 2009)

- (b) Establishment and operation (upon accession) of the mechanism pursuant to Section 2(A), paragraph 4 of the Protocol under which individuals and enterprises can bring cases of non-uniform application of the trade regime to the attention of national authorities

Pursuant to *Legislation Law of the People's Republic of China, Regulations on Procedures for the Formulation of Rules, and the Regulations on Record-keeping of Regulations and Rules*, state administrations, social groups, enterprises and individuals who believe that provisions in regulations, departmental rules and administrative measures are inconsistent with the ones contained in those at an upper level, can put forward review suggestions in written form to the Legislative Affairs Office of the State Council. State administrations, social groups, enterprises and individuals who believe that any local regulations and rules issued by comparatively larger cities are inconsistent with laws, administrative regulations or provisions contained in regulations and rules at an upper level, can put forward review suggestions in written form to people's governments of provinces and autonomous regions.

From 1 November 2007 to 31 October 2008, the Legislative Affairs Office of the State Council received 67 pieces of review suggestions in written form, including 2 pieces from state administrations, 8 pieces from social groups and enterprises, and the remaining 57 pieces from individuals. The Legislative Affairs Office of the State Council has dealt with these suggestions according to relevant laws and regulations.
