WHEREAS in accordance with the provisions of the above-mentioned Decision, drafts containing modifications and rectifications to Schedule **CXL - European Communities** were communicated to all Members of the World Trade Organization in document G/L/65 dated 14 March 1996 and subsequently in documents G/L/65/Rev.1 dated 19 March 1996, G/L/65/Rev.1/Add.2 dated 21 October 1997, G/L/65/Rev.1/Add.2/Corr.1 dated 10 February 1998, G/L/65/Rev.1/Add.3 dated 23 November 1998, G/L/65/Rev.1/Add.4 dated 1 July 1999 and G/L/65/Rev.1/Add.5 dated 22 February 2000.

IT IS HEREBY CERTIFIED that the modifications and rectifications to Schedule **CXL - European Communities** are established in conformity with the above-mentioned Decision.

The annexed modifications and rectifications are effective as of 22 February 2010.

This Certification is deposited with the Director-General of the World Trade Organization, who shall promptly furnish a certified true copy to each Member of the World Trade Organization. It shall be registered in accordance with the provisions of Article 102 of the Charter of the United Nations.
