Corrigendum

The following communication, dated 30 September 1997, has been received from the Permanent Mission of Guatemala.

With reference to the transposition of the concessions negotiated by the Government of Guatemala in the course of its accession to the GATT, as set forth in Schedule LXXXVIII, into the Harmonized System nomenclature, I have the honour to inform you that consultations have been held with the European Communities and an agreement reached on the technical amendments provided in annex.

It should be pointed out that these technical amendments refer to the initial negotiating rights accorded by the Government of Guatemala to the Government of Sweden on 11 December 1990 in connection with its accession to the GATT.
