REPONSES AU QUESTIONNAIRE RELATIF AUX LICENCES D'IMPORTATION

NOTIFICATION AU TITRE DE L'ARTICLE 7:3 DE L'ACCORD SUR LES PROCEDURES DE LICENCES D'IMPORTATION

MALTE

La Mission permanente de Malte a fait parvenir au Secrétariat la notification ci-après.

Description succincte du régime

1. Le régime de licences d'importation est appliqué conformément au Règlement de 1969 relatif au contrôle des importations, qui a été publié en vertu d'un arrêté découlant de la Loi de 1947 sur les approvisionnements et services, laquelle dispose que le Ministre chargé du commerce peut prendre des règlements pour contrôler les importations. Le régime de licences est donc prescrit par la loi. La désignation des produits soumis au régime de licences est une question d'ordre législatif. Une copie du règlement modificatif doit être déposée à la Chambre des représentants lorsqu'un nouveau produit est ajouté à la liste ou qu'un produit en est rayé. La liste des marchandises d'importation contrôlée peut être modifiée selon que de besoin. Le régime ne peut être supprimé qu'avec l'aval du pouvoir législatif.

Objet et champ d'application du régime de licences

2. Une licence générale à vue est accordée pour l'importation de tous les produits autres que ceux qui figurent dans la liste annexée au règlement susmentionné. Une copie de la liste actuellement en vigueur, publiée en 1990 sous forme d'Arrêté portant le n° 213, figure à l'annexe A.¹

3. Aucune mesure discriminatoire n'est appliquée à l'encontre des pays exportateurs. Les importateurs peuvent s'approvisionner dans n'importe quel pays, à l'exception de ceux qui sont visés par des sanctions commerciales imposées par le Conseil de sécurité des Nations Unies.

4. Alors qu'auparavant le régime de licences visait essentiellement à restreindre la quantité ou la valeur des importations pour permettre à l'industrie et à l'agriculture locales de se développer, il est aujourd'hui avant tout perçu comme un moyen de suivre de près des questions de santé, d'hygiène vétérinaire et de sécurité ainsi que d'autres questions analogues. A la suite de mesures prises ces

dernières années, il a été jugé possible de libéraliser l'importation de tous les produits manufacturés, à l'exception de la dentelle faite à la main et des bijoux en argent ou or filigrané qui sont considérés comme des produits très sensibles. Certaines restrictions qui s'appliquaient encore à divers produits agricoles ont été supprimées à compter du 1er janvier 1995, date à laquelle des prélèvements à l'importation ont été mis en place pour ces produits, sauf en ce qui concerne le poisson entier à l'état frais ou congelé, qui reste soumis à des restrictions qualitatives à titre de mesure de sauvegarde consentie à la branche de production locale. Quelques produits, à savoir le blé, l'orge, le maïs et les produits pétroliers, restent soumis à un régime exclusif de commerce d'Etat.

Modalités d'application

6. Les produits importés ne sont plus soumis à des contingents. Le système de contingentement des importations a été démantelé au cours des sept dernières années.

7. Sauf complications, les licences peuvent être délivrées le jour même de la présentation de la demande. Toutefois, les demandes de licence doivent être présentées avant que les commandes soient placées à l'étranger.

Condition requise des importateurs pour être habilités à demander une licence

8. Sauf pour ce qui est de certaines marchandises dont l'importation est prohibée, les licences sont normalement accordées. Il faut évidemment que certaines conditions soient remplies, en ce qui concerne par exemple les engagements en matière de prix de détail dans certains cas ou les prescriptions de classement applicables aux fruits frais et aux pommes de terre de semence. Les refus sont généralement motivés et les requérants qui le souhaitent peuvent en appeler au Ministre chargé du Département du commerce.

9. Tous les ressortissants maltais et toutes les sociétés locales habilitées peuvent demander une licence d'importation.

Documents et autres formalités à remplir lors de la demande d'une licence

10. Les importateurs qui demandent une licence sont tenus de fournir les renseignements suivants:

- a) nom complet et adresse du requérant;
- b) numéro d'enregistrement de l'importateur;
- c) pays d'origine des marchandises;
- d) pays dans lequel les marchandises sont consignées;
- e) estimation de la valeur c.a.f. totale des commandes; et
- f) détails sur les marchandises devant être importées.

11. On trouvera à l'annexe B un formulaire de demande de licence d'importation DT 127 (en quatre exemplaires).² Habituellement, l'importateur n'est pas tenu de joindre des documents à sa demande, exception faite des renseignements nécessaires pour vérifier la nature des marchandises en cas de doute.

12. Un droit de licence de 1 lire maltaise est prélevé pour l'achat d'un timbre qui sera apposé sur la copie de la licence destinée aux douanes lorsque celle-ci sera présentée aux autorités douanières avant le dédouanement des marchandises importées.

13. Il n'est pas nécessaire de verser un dépôt ou un paiement préalable pour obtenir une licence.

Conditions attachées à la délivrance des licences

14. Normalement, les marchandises pour lesquelles une licence a été délivrée doivent être expédiées dans un délai de huit mois suivant la date de délivrance de la licence. Dans certains cas particuliers, la durée de validité des licences est plus courte mais elle est toujours raisonnable et n'empêche pas d'importer de quelque pays que ce soit. La durée de validité de la licence est normalement de huit mois, mais le Directeur du commerce a la faculté de la prolonger si une demande en ce sens lui est adressée.

15. Des sanctions ne sont imposées en cas de non-utilisation d'une licence que dans des circonstances exceptionnelles comme l'achat de fournitures essentielles ayant fait l'objet d'un marché entre l'Etat et l'importateur.

16. Les licences sont incessibles entre importateurs.

17. Les licences d'importation peuvent être subordonnées à des conditions qui visent essentiellement à protéger la santé, la sécurité, l'environnement et d'autres intérêts du même ordre.

Autres formalités

18. Il n'existe aucune autre formalité administrative.

19. Les autorités bancaires remettent automatiquement des devises pour les marchandises qui ont été importées sur présentation d'une preuve littérale de l'importation. Comme les devises ne peuvent être obtenues qu'après l'importation et non avant, cette possibilité est également offerte pour les marchandises qui ne sont pas soumises à des licences.

ANNEX A

L.N. 213 of 1990

SUPPLIES AND SERVICES ACT (CAP. 117)

Importation (Control) Amendment) Regulations, 1990

In exercise of the powers conferred by section 3 of the Supplies and Services Act, the Minister for Development of Tertiary Sector has made the following regulations.

1. (1) These regulations may be cited as the Importation (Control) (Amendment) Regulations, 1990 and shall be read and construed as one with the Importation (Control) Regulations, 1969, hereinafter referred to as "the principal regulations".

Citation and commencement.

LN 48 of 1969.

(2) These regulations shall come into force on 1 January 1991.

2. For the Schedule to the principal regulations there shall be substituted the following new Schedule:
