La Mission permanente de la République slovaque a fait parvenir au Secrétariat la communication ci-après, datée du 18 janvier 2000.

Le gouvernement de la République slovaque a décidé d'abaisser le taux de la surtaxe à l'importation, de 7 à 5 pour cent, à compter du 1<sup>er</sup> janvier 2000, par le biais du Décret du Ministère des finances de la République slovaque n° 208/1999 Coll. portant modification du Décret du Ministère des finances de la République slovaque n° 118/1999 Coll.

Le Ministère des finances de la République slovaque, conformément à l'article 56 de la Loi sur les relations économiques avec les pays étrangers n° 42/1980 Coll., modifiée par la Loi n° 102/1988 Coll. et la Loi n° 113/1990 Coll., promulgue le texte suivant:

Article premier

Le Décret du Ministère des finances de la République slovaque n° 118/1999 Coll. portant établissement d'une surtaxe à l'importation, modifié par le Décret n° 126/1999 Coll. et le Décret n° 208/1999 Coll. est modifié comme suit:

- 1) Au paragraphe 2, le chiffre "7" est remplacé par le chiffre "5".
- 2) Les annexes 1, 2 et 3 du Décret du Ministère des finances de la République slovaque n° 118/1999 Coll. portant établissement d'une surtaxe à l'importation, tel qu'il a été modifié, sont remplacées par les annexes 1, 2 et 3 du présent Décret.

Article 2

Le présent Décret prend effet au 1<sup>er</sup> janvier 2000.
