The following communication, dated 16 October 2000, has been received from the Permanent Mission of India.

Pursuant to the reservations conveyed by the European Communities and the United States within the time-periods set out in the *Decision of 26 March 1980 on Procedures for Modification and Rectification of Schedules of Tariff Concessions* (L/4962; BISD 27S) in respect of India's notification concerning modification and rectification to India's Schedule XII (document G/MA/TAR/RS/63 dated 16 December 1999) and by the United States in respect of G/MA/TAR/RS/67 dated 28 June 2000, India has held consultations and reached agreement with the European Communities and the United States.

The enclosure¹ reflects amendments to the two above-mentioned documents resulting from this action.

Debido a las reservas expresadas por las Comunidades Europeas y los Estados Unidos dentro de los plazos establecidos en la *Decisión de 26 de marzo de 1980 relativa a los procedimientos para la modificación o rectificación de las listas de concesiones arancelarias* (L/4962; IBDD S27), en relación con la notificación de la India referente a las rectificaciones y modificaciones de la Lista XII de la India (documento G/MA/TAR/RS/63, de fecha 16 de diciembre de 1999), y por los Estados Unidos, en relación con el documento G/MA/TAR/RS/67, de fecha 28 de junio de 2000, la India ha celebrado consultas y ha alcanzado un acuerdo con las Comunidades Europeas y los Estados Unidos.
