PATENTS (PRIORITY PROTECTION) ORDER, 2005

The Minister in exercise of the powers conferred on him by Section 21 (4) of the Patents Act, makes the following Order:

1. This Order may be cited as the *Patents (Priority Protection) Order, 2005*.
