Title, number of pages and language(s) of the notified document: Draft Commission Regulation (EU) amending Regulation (EC) No 1223/2009 of the European Parliament and of the Council as regards labelling of fragrance allergens in cosmetic products.; (4 page(s), in English), (28 page(s), in English) |
| 6. Description of content: The draft measure proposes that additional fragrance allergens are individually labelled on the package of a cosmetic product, if their concentration exceeds 0,001 % in leave-on products and 0,01 % in rinse-off products. It further introduces some updates and simplifications in the names of those substances. It is all done through amendments of Annex III to Regulation (EC) No 1223/2009. |

Proposed date of entry into force: 20 days from publication in the Official Journal of the EU

From [3 years after the date of entry into force of this Regulation] cosmetic products containing that substance/ those substances and not complying with the restrictions shall not be placed on the Union market. From [5 years after the date of entry into force of this Regulation] cosmetic products containing that substance/ those substances and not complying with the restrictions shall not be made available on the Union market
