¹ At the conclusion of the investigation, the Ministry had proposed to impose an anti-dumping duty of 26.09% on insulin imports from Denmark for a period of 5 years. Ultimately, the Ministry found that the 13.89% rate applied in the original investigation was sufficient to correct the unfair dumping practice. Subsequently, the Danish producer-exporter submitted a price undertaking offer, which was accepted by the Ministry.
