⁴ A sunset review of the anti-dumping duties initiated under Resolution No. 200-2021/CDB-INDECOPI, published in the official journal *El Peruano* on 07.07.2021, is currently ongoing, as a result of which the definitive anti-dumping duties imposed by Resolution No. 001-2000/CDS-INDECOPI and extended by Resolutions Nos. 161-2011/CFD-INDECOPI and 209-2017/CDB-INDECOPI on imports of all varieties of footwear (other than sandals and flip flops), with uppers of rubber, plastics or leather, originating in the People's Republic of China, will continue to be applied throughout the review procedure, in accordance with Article 11.3 of the Anti-Dumping Agreement.
