NOTIFICATION

The following submission, dated 14 May 2018, is being circulated at the request of the delegation of **Armenia**. The notification concerns domestic support commitments (**Table DS:1** and the relevant supporting tables) for the calendar year **2014**.

In accordance with the notification requirements, Armenia notifies that domestic support to agricultural producers in 2014 was provided through the operations of the Ministry of Agriculture and other government departments. All such support is covered by the domestic support categories which are exempt from reduction commitments or are within the de minimis limit under the Agreement on Agriculture. The attached Supporting Tables DS:1, DS:4 and DS:9 provide details of these measures.
