The Industry-Led Research Sub Programme will fund projects to optimise irrigation water use and improve on-farm risk management.

Delivery of four facilitated financial literacy programme workshops in four key dairy regions in South Australia provided by trainers experienced in the field of expertise (accounting, financial management, banking) and conversant with dairy industry practices.

The programme aims to equip farmers with abilities to enable them to better understand the financial health of their business so they seek support or put strategies into action well before their financial situation becomes critical.

The grants programme provides funding ranging between \$A 250,000 and \$A 1.5 million on a competitive basis for projects conducted by natural resource management bodies, non-government organisations, industry bodies and landowners to gain knowledge to adopt innovative production, resource management and supply chain management practices and processes, that will improve sustainability of resource based industries. This includes farmers, fishers, foresters and other businesses.

The programme provides \$A 21.2 million in funding for 31 projects to be completed by 30 June 2016.

The measure is a partnership between the Queensland Government and major rural industries, where the government provides financial support to support industry groups in providing environmental services to irrigators such as system design and management.

Services funded typically include:

- providing information through workshops, field days, fact sheets and web-based tools on ways to improve water and energy efficiency;
- conducting assessments on irrigation and pumping systems to determine their efficiency and to identify where water and energy savings can be made;
- offering advice to irrigators to encourage them to make system and practice changes, including advice on managing agricultural wastewater and the management of nutrients applied through irrigation.
