NOTIFICATION

The following submission, dated 04 April 2023, is being circulated at the request of the delegation of **Canada**. The notification concerns imports under tariff quotas (**Table MA:2**) during the **Calendar Year 2022, Marketing Year 2021/2022 and Quota Year 2021/2022**.

Pursuant to paragraph 6 of the "Understanding on Tariff Rate Quota Administration Provisions of Agricultural Products, as Defined in Article 2 of the Agreement on Agriculture" (documents WT/MIN(13)/39 and WT/L/914 of 11 December 2013), this notification includes the tariff quota "fill rates".

General Notes:

- * In cases where in-quota imports exceed the TRQ quantities, fill rates are capped at 100%
- 1. Tariff item numbers based on the 2012 edition of the Harmonized System (HS) nomenclature.
- 2. The count of in-quota imports for butter, cream and dry whey is based on permits issued by Global Affairs Canada against Canada's tariff quota commitments. The count of in-quote imports for wheat, barley and their products is based on data from the Canada Border Services Agency. These figures may not equal the quantities reported by Statistics Canada, International Trade Division. In-quota imports are tabulated according to the unit for the tariff quota (e.g., grain equivalent basis), and not on a product weight basis.
- 3. The count of in quota imports for other products is based on permits issued by Global Affairs Canada against Canada's tariff quota commitments. These figures may differ from total imported quantities reported by Statistics Canada, International Trade Division.

Note:

(1) CANQ005 - Imports of fluid milk by consumers are not counted. By virtue of General Import Permit #1, which regulates the importation of dairy products for personal use, any resident of Canada may import fluid milk. The General Import Permit may be invoked an unlimited number of times.
