NOTIFICATION

Corrigendum

The following submission, dated 15 April 2024, is being circulated at the request of the delegation of **Canada**. The corrigendum concerns total exports (**Table ES:2**) in the context of export subsidy commitments for the **Calendar Year 2022**.

The present corrigendum rectifies the quantity of total exports for **Coarse Grains** (CANX002) and **Live animals** listed under Table ES:2. The values should read as follows:

- Coarse grains (CANX002): 7,629,716 Tonnes
- Live animals: 23,052,652 Number
