NOTIFICATION

The following communication, dated 6 June 2019, is being circulated at the request of the delegation of **Colombia**. The notification concerns imports subject to tariff quotas (**Table MA:2**) for the calendar year **2016**.

Colombia's bound tariff quotas were not activated during the reporting period, as the bound intra-quota tariff is higher than the most-favoured-nation tariff applied. The import data reported in column 4 of the attached Table refers to total imports for these products.
