NOTIFICATION

The following submission, dated 28 February 2023, is being circulated at the request of the delegation of **Colombia**. The notification concerns imports under tariff quotas (**Table MA:2**) during the **calendar year 2020**.

Colombia's bound tariff quotas were not activated during the reporting period, as the bound intra-quota tariff is higher than the most-favoured-nation tariff applied. Total imports are notified in the annex.
