- The figures in column 4 "in-quota imports during period" represent effective imports, except for EECQ005 to EECQ013, EECQ017, EECQ018, EECQ021 to EECQ025, EECQ027, EECQ029, EECQ030, EECQ031, EECQ033 to EECQ037, EECQ039, EECQ042, EECQ043, EECQ046, EECQ088 to EECQ096, EECQ098, EECQ099, and EECQ124 where the quantity indicated is based on authorizations to import.
- The tariff lines in column 2 are in Combined Nomenclature CN2018.
- (1) EECQ015: The TRQ of 4 624 tonnes of pigmeat country allocated to Canada is not reported in this notification. Those volumes are integrated into the bilateral FTA CETA TRQ for which better conditions are applied.
- (2) EECQ099: The TRQ of 1 294 700 tonnes, country allocated to ACP countries, is no longer opened:
 - Sugar of LDCs origin is subject to duty free quota free pursuant Article 18 of Regulation (EU) No 2012/978 of the European Parliament and of the Council of 25 October 2012.
 - Sugar of ACP countries other than LDCs is subject to duty free guota free pursuant the Economic Partnership Agreements with these countries.
 - The overall obligation for an import licence for sugar expired on 30 September 2017 (Annex I to Commission Delegated Regulation (EU) 2016/1237).
